BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The annual United States Military Budget shall hereby be
2	capped at 500	billion dollars.
3	SECTION 2.	The annual United States Military Budget shall be defined a
4	the funds allo	cated to the United States Military by the U.S. Government
5	within a fiscal	year.
6	SECTION 3.	The United States Congress must enforce this cap by
7	ensuring the p	roposed budget meets the parameters.
8	A. In order to	suspend this limit, ¾ of congress must vote to remove this

1	A Resolution to Amend the Constitution to Adopt
2	Congressional-District Method of Electing the President of the
3	United States of America
4 5	WHEREAS, the electoral college only allows the states to have electoral votes; and
6 7	WHEREAS, if a district does not agree with the rest of the state that district does not get represented in the electoral college; and
8 9	WHEREAS, this results in districts of states not being represented to their fullest extent; and
	WHEREAS, the Congressional-District Method, also known as the Maine-Nebraska Method, would allow each district to have a say in the electoral college and take power away from states; now, therefore be it
13 14 15 16	RESOLVED, By two-thirds of the Congress here assembled, that the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution when ratified by the legislatures of three-fourths of the

20	SECTION 1 : Rights granted to states in the electoral college in the

A Bill to Establish an Opt-Out System for Organ Donation on Driver's License Applications

1	BE IT ENACT	ED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The current question posed to driver's license applicants regarding organ
3		donation, typically phrased as "Would you like to be an organ donor?",
4		shall be replaced with the following: "Do you wish to not be an organ
5		donor?" or an equivalent phrasing based on each state's current wording.
6	SECTION 2.	Driver's license applicants are individuals applying for, renewing, or
7		updating a driver's license or state identification card through a state's
8		Department of Motor Vehicles (DMV) or equivalent agency. The organ
9		donation question is the standard inquiry presented to driver's license
10		applicants regarding their willingness to register as an organ donor.
11	SECTION 3.	The Department of Transportation, in coordination with state DMVs, shall
12		oversee the implementation of the revised question on applications, online
13		portals, and verbal questioning. The Department of Health and Human
14		Services shall monitor the effectiveness of the policy.
15	SECTION 4.	This legislation will take effect on September 1, 2025. All laws in conflict
16		with this legislation are hereby declared null and void.

A Resolution to Formally Recognize the Sahrawi Arab Democratic Republic

1	BE IT ENACTED	BY THE CONGRESS HERE ASSEMBLED THAT:
2	WHEREAS:	the Sahrawi people living in the Western Sahara region have continuously
3		expressed a desire to obtain independence; and
4	WHEREAS:	the Kingdom of Morocco has repeatedly denied the right of self-determination of
5		the Sahrawi people; and
6	WHEREAS:	the Kingdom of Morocco has continuously committed multiple human rights
7	,	violations; and
8		violations, and
9	WHEREAS:	the Kingdom of Morocco continues to exploit the Western Sahara region of its
10		natural resources; and
11	WHEREAS:	the Sahrawi Arab Democratic Republic is already recognized as a sovereign state
12		by 44 members of the United Nations; now, therefore, be it
13	RESOLVED:	that the United States of America will formally recognize the Sahrawi Arab

15		Democratic Republic also known as the Western Sahara as a sovereign state.

A Bill to Expand Early Childhood Education Systems

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	All children from ages 3 until grade school will have access to high-quality
2		early education programs. This means that public school enrollment shall
3		begin two years earlier than the current mandatory starting age, making
4		high-quality early childhood education programs accessible for all children
5		nationwide.
6	SECTION 2.	"Public school" means a primary or secondary school that educates
7		without a fee.
8		"Early childhood education programs" refers to structured, interactive and
9		fun learning programs for children.
10	SECTION 3.	The implementation and funding of this bill will be seen by the Department
11		of Education and Department of Health and Human Services.
12		Grants will be provided to expand the childhood educational programs,
13		provide training/materials, and hire qualified educators
14	SECTION 4.	This legislation will take effect for the 2027-2028 school year and beyond.
15		All laws in conflict with this legislation are hereby declared null and void.

A Bill to Establish Four-Day School Weeks for Public School Students

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 1 SECTION 1. All Public Schools will have school in session for four days for all
- 2 participating students
- 3 A. This is not inherently applicable to teachers and staff
- 4 SECTION 2. Public Schools are any academic and non-college type school
- 5 established and maintained by the Department of Education. School Weeks are
- 6 the timeframe in which schools are in session for students, typically from
- 7 Monday to Friday.
- 8 SECTION 3. The United States Department of Education will oversee the
- 9 implementation of this bill
- 10 A. Any Public Schools not complicit with this bill will receive a fine of up to
- 11 \$20,000
- 12 SECTION 4. This legislation will take effect on January 1st, 2026.
- 13 SECTION 5. All laws in conflict with this legislation are hereby declared null 14 and void.

9 RESOLVED,	That the Congress here assembled will commit to upholding the
10	sovereignty of an independent Palestinian State

A Bill to Send Individuals Convicted of Drug Usage to go to Rehabilitation Centers Instead of Prisons

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The United States shall require all individuals convicted of drug usage to go
3		through rehabilitation centers instead of prison treatment. This bill will aim
4		to reduce recidivism among offenders.
5	SECTION 2.	Rehabilitation refers to treatment programs that include therapy,
6		counseling, and other interventions used to address substance abuse and
7		lead to an effective recovery. Drug usage refers to offenses that use drugs
8		classified as having a potential for abuse.
9	SECTION 3.	The following government agencies will oversee enforcement.
10		A. The Department of Health and Human Services will oversee the
11		implementation and administration of the rehabilitation programs and
12		ensure that they are high quality and effective. They will work with
13		state and local agencies to ensure that there are facilities and services
14		in place.
15		B. The Federal Bureau of Prisons will ensure that all prisoners convicted of
16		drug-related offenses are directed to rehabilitation centers instead of
17		prisons.
18	SECTION 4.	This legislation will take effect on August 1, 2026. All laws in conflict with
19		this legislation are hereby declared null and void.

A Bill to Readjust Income Tax Rates in Certain Brackets

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1. National tax rates for income from \$0 to \$11600 will be cut
2	from 10% to 5% and from \$11601 to \$47150 will be cut from 12% to 6%.
3	The rates for taxable income from \$100526 to \$191950 will be increased
4	from 24% to 30%, for the bracket from \$191951 to \$243725 will increase
5	from 32% to 35%. Income from \$243726 to \$609350 will increase from
6	35% to 37%, and any income above that will increase from 37% to 40%.
7	SECTION 2. Taxable income refers to a person's income that is subjected
8	to tax from the government unless exempted. Tax brackets are different
9	ranges of income that are subject to a certain rate.
10	A. For example, the first 11600 dollars someone makes is taxed at a rate of
11	10%, and any money they make over that and less than 47150 dollars
12	would be taxed at a rate of 12%.
13	SECTION 3. The Internal Revenue Service shall be responsible for
14	enforcing this legislation.
15	SECTION 4. This legislation will take effect on January 1, 2026. All laws in
16	conflict with this legislation are hereby declared null and void.
