A Bill to Increase the Federal Minimum Wage of \$7.25

A Bill to Eliminate Taxes on Food and Clothing Nationwide to Provide Relief for Low-Income Families and Promote Economic Accessibility

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

Article I:

There shall be no taxes levied on food or clothing nationwide. These items shall be exempt from sales tax or any form of taxation at the federal, state, or local levels.

Article II:

For the purposes of this bill:

- Food is defined as any item typically consumed for sustenance, including but not limited to fruits, vegetables, grains, meats, dairy, and beverages intended for human consumption.
- **Clothing** is defined as any wearable item meant for personal use, including shoes, shirts, pants, dresses, jackets, and undergarments.

Article III:

This policy shall take effect on January 1st, 2025.

Article IV:

The Department of Treasury, in cooperation with the Internal Revenue Service (IRS), will oversee the enforcement of this bill. The IRS will be responsible for ensuring that taxes are not collected on food and clothing by auditing businesses and monitoring compliance with the new regulation. Any business found in violation of this policy will be subject to penalties and fines. Additionally, any state or local jurisdiction attempting to impose taxes on food or clothing will be prohibited from doing so.

Article V:

Any state or local laws that conflict with this new policy shall hereby be declared null and void, including any statutes that impose taxes on food or clothing.
