### General Info:

All entries will be waitlisted initially, so *please make sure to enter your waitlist order correctly*. We will accept as many entries as possible in terms of space & judging, with preference given to Flint Hills schools & those schools that can provide judges to cover their extras (followed by all other schools in chronological order of registration). Fees are \$6 per entry.

Individual competitors are limited to two Saturday events total unless the third event is Impromptu. No competitor may enter more than one draw event. Competitors are responsible for making time to compete in each of their events every round - we will not make accommodations for time constraints that are not caused by the tournament. Competitors entered in extemp must draw & speak at their assigned time each round and are expected to prioritize their other events accordingly.

We will host three preliminary rounds of competition followed by finals, and the top 6 in each event will medal. Finals will be *cumulative*. Sweepstakes will be calculated based on the top 16 entries from each school, and plaques will be awarded for first, second, and third place.

We will adhere to all KSHAA regulations & follow all procedures outlined here & on Tabroom. Issues will be handled at the discretion of the tournament director.

We will not offer concessions or box lunches for students, and Eudora has fairly limited fast food options (Gambinos, Wendy's, Sonic, Subway, Quick Shop, Scooters, Dairy Queen, or Casey's, pretty much) so please plan accordingly. Hospitality will be provided for coaches.
