# A Bill to Eliminate the National Debt

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	
2		The United States shall default on its outstanding national debt, canceling
3		all obligations owed to domestic and foreign creditors.
4	SECTION 2.	
5		A default shall be defined as the failure to meet financial obligations,
6		resulting in the cancellation of all outstanding principal and interest
7		payments.
8		National debt shall be defined as all outstanding obligations of the federal
9		government, including public and intragovernmental debt, as recorded by
10		the U.S. Department of the Treasury.
11	SECTION 3.	
12		A. The U.S. Department of the Treasury, in coordination with the Federal
13		Reserve, shall oversee the cessation of all debt payments and the
14		restructuring of financial operations to function without borrowing.
15		B. The U.S. Securities and Exchange Commission (SEC) and the Federal
16		Reserve shall implement emergency measures to stabilize financial
17		markets in response to default.
18		C. All federal agencies shall adjust budgetary operations to ensure
19		expenditures do not exceed revenues moving forward.
20	SECTION 4.	
21		This legislation shall take effect at the beginning of Fiscal Year 2026. All
22		laws in conflict with this legislation are hereby declared null and void.

## A Bill to End School Gun Violence

### THE BIRTH CONTROL ACCESS ACT

**SECTION 1.** Many individuals face barriers to obtaining prescription birth control. Expanding over-the-counter access to contraceptives and ensuring insurance coverage can reduce unintended pregnancies and improve public health outcomes.

### **SECTION 2. The Birth Control Access Act aims to:**

- A. Allow over-the-counter sales of FDA-approved birth control methods without a prescription.
- B. Ensure that all insurance plans, including Medicaid and Medicare, cover over-the-counter birth control methods without requiring a prescription and without cost-sharing.

### **SECTION 3.** The Birth Control Access Act will ensure:

- A. **FDA Review and Approval:** The Food and Drug Administration (FDA) shall expedite the review and approval process for transitioning eligible prescription birth control methods to over-the-counter status, provided they meet safety and efficacy standards.
- B. **Availability:** Retailers, including pharmacies and licensed stores, may sell FDA-approved over-the-counter contraceptives without requiring identification or age verification.
- C. Education: The Department of Health and Human Services (HHS) shall collaborate with manufacturers to ensure appropriate labeling and educational materials accompany over-the-counter contraceptives.

### **SECTION 4. Insurance Coverage Requirements**

- A. **Insurance Coverage:** All health insurance plans shall cover all FDA-approved over-the-counter birth control methods without requiring a prescription.
- B. **No Cost Sharing:** Insurers shall not impose copayments, deductibles, or other cost-sharing requirements for covered over-the-counter contraceptives.

**SECTION 5.** This Act shall take effect 180 days upon passage.

**SECTION 6.** All laws in conflict with this Act are hereby declared null and void.

# TA BILL TO PROVIDE UNIVERSAL FREE LUNCH TO ALL PUBLIC SCHOOL STUDENTS

### BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

### Article I:

All public K-12 students shall receive a free, nutritious lunch each school day, regardless of their family's income or socioeconomic status.

### Article II:

"Free lunch" refers to a nutritious meal provided at no charge to students, meeting the nutrition standards set by the U.S. Department of Agriculture. "Eligible schools" refers to all public and charter schools within the United States.

### Article III:

This bill will take effect by the next school year.

### Article IV:

The U.S. Department of Education, in collaboration with the U.S. Department of Agriculture, will oversee the implementation of this bill, ensuring that all schools have the necessary funding and infrastructure to provide free lunches. Schools are encouraged to partner with local food producers to source meals.

### Article V:

The U.S. Department of Education will allocate federal funds to support the Universal Free Lunch Program, ensuring that all schools are able to offer free meals. Schools will receive funding based on student enrollment and meal cost estimates.

### Article VI:

All other laws in conflict with this new policy shall be hereby declared null and void.

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:
- 2 Article I. Any energy costs incurred by a technological enterprise in order to provide artificial
- 3 intelligence (AI) services shall be taxed at a rate of 25% each month.
- 4 Article II. Such technological enterprises shall be wholly responsible for faithfully reporting to their
- 5 energy providers how much of their energy costs result from AI services each month.
- 6 Failure to report accurately shall result in a fine equal to ten times the amount of the
- 7 underreported energy costs.
- 8 Article III. Funds raised through these taxes shall be used to support and, if possible, expand the
- 9 Department of Energy's renewable energy subsidies.
- 10 Article IV. This legislation shall be overseen by the Department of Energy, and this agency shall be
- 11 responsible for monitoring compliance.
- 12 Article V. This legislation shall take effect on January 1, 2026.
- 13 Article VI. All laws in conflict with this legislation are hereby declared null and void

# A Bill to Promote and Fund Canada Geese Population Control

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:
- 2 SECTION 1. For each of the five years following implementation of this legislation, Congress shall
- 3 allocate \$100 million to the Fish and Wildlife Service (FWS) to be divided among states and
- 4 territories in order to pay cash-prize bounties for the lawful hunting of Canada geese
- 5 (Branta canadensis).
- 6 SECTION 2. Each state and territory that participates may determine the amount of the individual
- 7 bounties, as well as the parameters and procedures for hunting the geese and claiming the
- 8 cash prizes.
- 9 SECTION 3. After five years, Congress shall reevaluate the situation to determine whether further
- 10 legislation is merited.
- 11 SECTION 4. This legislation shall be overseen by the Fish and Wildlife Service
- 12 SECTION 5. This legislation shall take effect on January 1, 2026.
- 13 SECTION 6. All laws in conflict with this legislation are hereby declared null and void
