Regent Legacy Rookie & Novice Invitational 2025 Speech and Debate Tournament Saturday-Sunday, September 13-14, 2025 Online via NSDA Campus

Dear Speech and Debate Community:

After several years of discussion, the Regent Legacy Academy Speech and Debate program is pleased to invite you and your program to join us for our inaugural Rookie & Novice Invitational which will take place this year on September 13th and 14th on the NSDA Campus platform.

For our first year, we will be offering a full-service invitational with a relaxed schedule featuring 4 rounds of Lincoln-Douglas, Public Forum, and Parliamentary Debate on Saturday as well as 3 rounds of Congress and Policy Debate. On Sunday, we will offer 4 rounds of all CHSSA and SCJFL speech events. All events will be tabbed on "total cume" with certificates for every student and medals for top students. We are defining "rookies" as students attending their first ever tournament, and "novices" as students in their first semester of competition, including attending less than 3 tournaments in the spring 2025 semester. Debaters who've never done speech before are welcome to enter speech competition, as are experienced speech competitors who've never done debate. We also strongly encourage experienced high school students to judge rounds in their event for the benefit their own academic growth.

As always, we reserve the right to merge events as entries warrant but will do so to best preserve the spirit and character of each particular event. To minimize cross-entries and facilitate a true rookie / novice experience, we are not allowing double entry for events offered on the same day. Students may still enter one debate event on Saturday and one speech event on Sunday.

We will be using the 2025-2026 national topic in Policy with debates constrained to the evidence packet, the September/October topic in Lincoln-Douglas, the September/October topic Public Forum, a lighthearted mix of fact, value, and policy resolutions in Parliamentary Debate, and Congress bills taken from the September 2025 NSDA Docket. All events will be single flighted with a prep room and topic announce over Zoom for Extemp and Parli.

We are looking forward to providing a positive first competition for all of your new students!

Web Registration

Entries will only be accepted online at tabroom.com. If your program has never set up accounts on tabroom.com, please contact us for assistance in setting your program up on that website. Students are not able to compete on the NSDA Campus platform and judges cannot access their ballots without a tabroom.com account that is linked to the school/program account.

Divisions:

Middle School Novice / Rookie and High School Novice / Rookie in all events. We are defining "rookies" as students attending their first ever tournament, and "novices" as students in their first semester of competition, including attending less than 3 tournaments in the spring 2025 semester. Debaters who've never done speech before are welcome to enter speech competition, as are experienced speech competitors who've never done debate.

Patterns:

All events will be single flighted. Students can only enter one debate event and one speech event.

Judges

Schools are expected to provide at least 50% of their judging obligation. Each judge covers two Parliamentary, Public Forum, or Policy teams or two Lincoln Douglas debaters or duo entries. Each speech judge covers six speech entries outside of duo. Schools will pay a judging penalty fee per speech slot, Congress entry, Lincoln Douglas/Duo Interp or Policy/PF/Parli team not covered by school judges.

We also strongly encourage experienced high school students to judge rounds in their event for the benefit their own academic growth, so long as they provide positive, constructive feedback to new students.

All judges are expected to have an electronic device (laptop/desktop computer, iPad/tablet, or at minimum a compatible smartphone) capable of accessing the NSDA Campus platform and we will charge nuisance fees if judge problems cause the tournament to run late. All debate judges are also expected to have a basic judging paradigm available on tabroom.com for students to review before rounds.

Electronic Device Failure Policy

We <u>strongly</u> encourage all students and judges to use a wired Internet connection and have a backup device and backup connection (like a hotspot) ready to go in the event of device failure or loss of an Internet connection. In the event of device failure or loss of connection, students and coaches should notify the tournament immediately and will have <u>15 minutes</u> to restore their connection and return digitally to their round. If the student or judge is unable to return in time, we will make reasonable accommodations to attempt to allow the affected students to finish their round – speech students may have to give their speeches to their judge in a backup competition room or will be judged on the basis of their interrupted performance. Policy, Parli, and Public Forum debaters may have to continue as "mavericks" without their partner and Lincoln-Douglas debaters may have to forfeit their round.

Generative Artificial Intelligence Policy

We are following the guidelines of the NSDA on generative artificial intelligence, as practiced at the 2025 NSDA National Tournament:

"In events in which speeches must be the original created work of a competitor (OO, INF, IX, USX, SW, EXC, IMP, EXP) students are prohibited from quoting or paraphrasing text directly from generative AI sources. Generative AI should *not be cited as a source*. The exception is that a student delivering a speech about the topic of AI may quote AI to illustrate their points about AI, in accordance with existing quoted word limits. While generative AI may be used to guide students to articles, ideas, and sources, the original source of any quoted or paraphrased evidence must be available if requested.

In debate events, generative AI should *not be cited as a source;* while generative AI may be used to guide students to articles, ideas, and sources, the original source of any quoted or paraphrased evidence must be available if requested.

In Interpretation events, students are prohibited from performing material created by generative AI sources. Generative AI should *not be used as a source of material;* while generative AI may be used to guide students to articles, ideas, and material, the original source of any material that is performed must be available if requested."

Diversity, Equity, and Inclusion Policy

We believe that the cross-cultural understanding that forensics develops in understanding how different people experience the world differently and understanding different sides of an argument is one of the most important life skills that the activity develops. Thus we are proud to support the ongoing efforts of the NSDA and other forensics organizations to promote understanding. We will be including relevant language on our tournament ballots and will address judge sensitivity during our judge training.

Accessibility Policy

In keeping with our above DEI policy, we encourage coaches to contact us directly regarding any accommodations that the tournament needs to make to create an inclusive environment for all students.

General Rules:

The tournament will consist of four rounds of debate (three for policy and congress) and three rounds of speech all tabbed on total cume, with certificates for all participants and medals for top students in each event. We will merge smaller events as needed, but make every effort to merge in ways that preserve the spirit and character of each event.

Sweepstakes:

We will offer two sets of sweepstakes awards – 1st through 3rd in speech and 1st through 3rd in debate.

Speech Rules:

We will generally follow CHSSA rules for high school events and SCJFL rules for middle school events, with exceptions considered on a case-by-case basis at the sole discretion of the tournament director. All speeches are expected to be the original work of the student and may not have been used in competition prior to Spring 2025. Extemp will be combined national and international, with rounds themed around questions of domestic, international, and economic issues. Impromptu topics will be lighthearted.

Debate Rules:

We again will generally follow CHSSA rules for high school and SCJFL for middle and elementary competition, with exceptions considered on a case-by-case basis at the sole discretion of the tournament director. Each program may have one hybrid team with another program and three person teams are allowed. "Maverick" debaters in Policy, Public Forum, and Parliamentary Debate will only be allowed under extreme circumstances. Computers are allowed in all debate events except Parliamentary Debate, in which case computers may be used in prep but not during actual rounds.

Congress Rules:

Congress will have two divisions, middle school and high school. Please designate the PO's with a 'po' for every FIVE entries; we will also welcome experienced competitors willing to serve as a PO. Congress bills will be taken from the September NSDA congressional docket and posted on tabroom.com as the tournament approaches.
