SOLIDIFY IRAN SANCTIONS ACT OF 2025

To repeal the sunset provision of the Iran Sanctions Act of 1996, and for other purposes.

1 **WHEREAS**, The Iran Sanctions Act of 1996 requires the imposition of sanctions with
2 respect to Iran’s illicit weapons programs, conventional weapons and
3 ballistic missile development, and support for terrorism, including Iran’s
4 Revolutionary Guards Corps; and

5 **WHEREAS**, The Government of Iran has acquired destabilizing conventional
6 weapons systems from the Russian Federation and other malign actors,
7 and is funneling weapons and financial support to its terrorist proxies
8 throughout the Middle East, threatening allies and partners of the United
9 States, such as Israel; therefore, be it

10 **RESOLVED**, That it is the policy of the United States to fully implement and enforce
11 the Iran Sanctions Act of 1996; and be it

12 **FURTHER RESOLVED**, That Section 13 of the Iran Sanctions Act of 1996 is
13 amended by removal of the sunset clause.

NO TAX ON TIPS ACT

To amend the Internal Revenue Code of 1986 to eliminate the application of the income tax on qualified tips through a deduction allowed to all individual taxpayers, and for other purposes.

1 **SECTION 1. EXCLUSION OF TIPS FROM GROSS INCOME.**

2 (a) Section 61 of the Internal Revenue Code of 1986 is amended by adding at the
3 end the following:

4 “(d) Exclusion of Tips.—Any cash or non-cash tips received by an employee
5 in connection with the performance of services shall not be included in
6 gross income for purposes of this chapter.”

7 (b) Any provision of the Internal Revenue Code referencing wages or compensation
8 shall exclude tips from such definition unless specifically stated otherwise.

9 **SECTION 2. EMPLOYER OBLIGATIONS**

10 (a) Employers shall not withhold federal income or payroll taxes on tips received by
11 employees.

12 (b) Employers shall not be required to report tips received by employees to the
13 Internal Revenue Service.

14 **SECTION 3. EMPLOYEE REPORTING.**

15 Employees shall not be required to report tip income for federal income or payroll tax
16 purposes.

17 **SECTION 4. EFFECTIVE DATE.**

18 This Act shall apply to tips received after December 31, 2025.

ABOLISH THE ATF ACT

To abolish the Bureau of Alcohol, Tobacco, Firearms and Explosives.

- 1 **SECTION 1.** The Bureau of Alcohol, Tobacco, Firearms and Explosives is hereby
- 2 abolished.
- 3 **SECTION 2.** This legislation shall take effect immediately upon passage.
- 4 **SECTION 3.** All laws in conflict with this legislation are hereby declared null and
void.
