# A Resolution to Rejoin and Strengthen the JCPOA to Prevent Nuclear Proliferation

1	WHEREAS,	Iran's nuclear program has significantly expanded since the United States withdrew from
2		the Joint Comprehensive Plan of Action (JCPOA) in 2018; and
3	WHEREAS,	The agreement's absence increases the risk of Iran acquiring nuclear weapons, which could
4		threaten global and regional security; and
5	WHEREAS,	The lack of a strong agreement has led to increased uranium enrichment levels, the use of $% \left\{ 1,2,\ldots ,n\right\}$
6		advanced centrifuges, and the heightened risk of nuclear weapon development, which has
7		escalated regional and global tensions; and
8	WHEREAS,	Restoring and strengthening the JCPOA with stronger provisions could help prevent nuclear contract of the prevent nuclear con
9		missile development; now, therefore, be it
10	RESOLVED,	That the Congress here assembled calls for the United States to rejoin the JCPOA with
11		provisions to extend nuclear restrictions to ensure long-term compliance, expand
12		$verification\ mechanisms\ (such\ as\ on\text{-}site\ inspections,\ constant\ monitoring\ of\ nuclear\ sites,$
13		and access to suspected undeclared facilities by the International Atomic Energy Agency), $$
14		address regional security concerns by limiting the development and testing of missiles
15		capable of delivering nuclear warheads; and, be it
16	FURTHER RI	ESOLVED, That Congress encourages collaboration with other allied nations to negotiate
17		additional agreements to curtail ballistic missile developments and support of proxy
18		groups.

## The Nuclear Energy Advancement Act of 2025

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The United States shall suspend all fossil fuel subsidies and place a 35% tariff
2		on all crude oil imports. The revenue from these measures shall be used to
3		increase funding for nuclear energy as follows:
4		A. \$50 billion for the construction of new small modular reactors and
5		conventional nuclear reactors within the United States.
6		B. \$25 billion in grants for updating nuclear power plants in the United States
7		which have been in service for twenty or more years.
8		C. \$500 million for research into sustainable nuclear waste disposal methods
9	SECTION 2.	A. Small modular reactors shall be defined as nuclear fission reactors which
10		generate between 10 and 300 megawatts of electricity.
11		B. Large conventional reactors shall be defined as nuclear fission reactors
12		which generate upwards of 300 megawatts of electricity.
13	SECTION 3.	The Department of Energy shall oversee the implementation of this
14		legislation.
15	SECTION 4.	This legislation shall take effect on October 1, 2025.
16	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

#### **The Dream Act**

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	The United States shall invest in the immigration system to alleviate unjust
2		delays in the legal immigration process and prevent illegal immigration.
3	SECTION 2.	A. 20 billion dollars shall be provided to the U.S. Citizenship and Immigration
4		Services (USCIS).
5		B. 20 billion dollars shall be provided to U.S. Customs and Border Protection
6		(CBP) to enforce immigration law and prevent illegal immigration law.
7		C. The F-1 Student visa shall permit legal residence in the United States for
8		at least two (2) years after the completion of education.
9		D. The annual cap for family-based visas and employment-based visas shall
10		both be increased by 150,000 every year until 2030.
11		E. Immigrants residing lawfully in the United States with an H1-B visa, and
12		permanent residents residing lawfully in the United States with a green
13		card, are eligible to undergo naturalization directly even if they do not
14		meet the existing requirements for duration of stay.
15	SECTION 3.	The Department of Homeland Security (DHS) and the Department of Justice $\label{eq:Department} % \begin{subarray}{ll} \end{subarray} \ben$
16		(DOJ) shall be responsible for implementing this bill. The USCIS and DHS shall
17		use their awarded 20 billion grants to hire immigration judges, border agents
18		and other personnel as necessary.
19	SECTION 4.	This legislation will take effect on July 1, 2025. All laws in conflict with this
20		legislation are hereby declared null and void.

#### A Bill to Prohibit the Launch of LEO Satellites

BE IT ENACTED BY	THE CONGRESS HERE	ASSEMBLED	THAT:

- 2 SECTION 1. The United States Federal Government shall prohibit the launch of Low
- 3 Earth Orbit (LEO) Satellites by private corporations.
- 4 SECTION 2. A LEO Satellite is defined as a piece of electronic equipment that circles in
- 5 low Earth orbit (LEO) at an altitude of 2,000 Kilometers or less.
- 6 SECTION 3. The National Aeronautics and Space Administration (NASA) will oversee
- 7 and enforce this legislation.
- 8 A. Illegally launched LEO Satellites shall be disabled and moved to
  9 end-of-life disposal orbits at the expense of the private corporation
  10 which originally launched the device.
- B. Any private corporation out of compliance will incur an additional fine of up to \$1,000,000 per illegally launched LEO Satellite.
- C. Private corporations illegally launching ten or more LEO Satellites,
   shall have their business license permanently revoked.
- 15 SECTION 4. This legislation will take effect on January 1, 2026
- 16 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to provide Tax Credits to Support the Production of Local Paper Journalism

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2	SECTION 1.	For taxable years after 2026, any taxpayer who files taxes, whether single
3		or jointly, can apply for a newspaper subscription credit up to \$250. A
4		newspaper organization must staff no more than two hundred
5		employees and can gain a taxable write off for any production or labor
6		costs up to 75% for three years and 50% for any subsequent year after
7		that.
8	SECTION 2.	"Newspaper organization" shall be defined as an organization that uses
9		print journalism to provide local content relating to news and current
10		events in a region or local community.
11	SECTION 3.	The United States Department of Treasury and Internal Revenue Service
12		of the federal government shall oversee the implementation of this
13		legislation.
14		A. The I.R.S. shall amend section 501(c) of the United States Internal
15		Revenue Code (26 U.S.C. § 501(c)) and follow these guidelines if the
16		primary purpose of the news organization is to provide print or digital
17		local news publications
18	SECTION 4.	This legislation will take effect in Fiscal Year 2026.

### A Resolution to Exchange Drugs for Jobs

WHEREAS, The price of medicine in the United States has skyrocketed, while accessibility has declined, in recent years; and

WHEREAS, The number of available jobs in India has significantly decreased, leading to high unemployment rates across the country and forcing older generations with previously established employment to carry the burden of the Indian economy; and WHEREAS, The United States is in dire need of cheaper medicine while India is in dire need of new employment opportunities; now, therefore, be it

RESOLVED, That the Congress here assembled shall direct the Secretary of State to enter into an agreement with the Indian government removing all controls on the export of medicaments and incentivizing cooperation and transparency with American Pharmaceutical companies; and, be it

FURTHER RESOLVED, Should the Indian government enter into such an agreement, that the Congress shall reallocate 50 billion dollars from the budget of the Department of Defense to be distributed as tax refunds for corporations that outsource jobs to India.
