**Official Declaration from the Bolivarian Republic of Venezuela**  
**October 12th, 2025**

To the Government of the United States of America:

Your aggressive military operations throughout Latin America, the destruction of infrastructure on sovereign territory, and the economic warfare waged against our regional allies constitutes an intolerable act of imperialist aggression. The United States has declared war on the people of Latin America through your so-called "Cartel Elimination Act."

We demand the immediate cessation of all military operations in Latin America, the withdrawal of all U.S. forces from the region, and the lifting of all financial sanctions within 72 hours.

Failure to comply with these demands will result in the following consequences:

The Bolivarian Republic of Venezuela, with the full support of the Russian Federation and our allied organizations throughout the region, hereby declares that continued American aggression will be met with a coordinated response. We have authorized defensive operations including 30-50 attacks on American territory targeting the very infrastructure you claim to protect.

Your operations have destabilized the region and violated the sovereignty of multiple nations. We will defend our hemisphere from American imperialism by any means necessary.

End your illegal operations immediately or accept responsibility for the consequences that follow.

**Statement by the Secretary of Defense**

My fellow Americans,

Following our operations against cartel networks throughout Latin America, Venezuela has issued an ultimatum. They demand immediate cessation of all anti-cartel operations. Russia backs this demand. They threaten 30 to 50 coordinated terrorist attacks on American soil if we refuse.

Our operations have succeeded. We destroyed production facilities. We interdicted trafficking routes. We froze cartel assets. We protected critical infrastructure. Venezuela now demands we stop. Intelligence confirms Tren de Aragua operates cells in 23 states capable of executing these threats.

Congress must decide between two options.

First option: Cease all operations, Withdraw forces and Lift restrictions on these cartels. Allow drug trade to resume and prevent immediate attacks. Which will avoid war and the terrorist attacks on the United States.

Second option: Passing a multi-layered legislation then we continue operations. Intensify the crackdown. Accept the risk of attacks. Declare war on the regime and eliminate both the cartels and their state sponsor permanently.

The second option requires total commitment. We will freeze all Venezuelan and Russian assets. We will escalate anti-cartel operations throughout Latin America. We will provide complete military and financial support to the Venezuelan democratic opposition. María Corina Machado will lead this effort. She won the Nobel Peace Prize yesterday for her work promoting democracy in Venezuela. She has spent years organizing opposition to Maduro's dictatorship. She currently lives in hiding after the regime blocked her presidential candidacy. She has publicly requested American support to restore democracy. We will arm her forces, train them, and back them until the regime falls and free elections occur.

We will destroy every terrorist cell on American soil. We will dismantle cartel infrastructure across the hemisphere. We will ensure no successor regime can protect these criminals. We will allocate resources to prevent cartel retaliation.

Congress will convene in a classified session to vote on war authorization. The operational details require confidentiality.

To Congress: Choose between abandoning the fight against cartels or eliminating the regime that protects them.

To the American people: Your government stands ready to protect you under either path.

To Venezuela and Russia: Follow through on your threats and face the full power of the United States military.

# The Global Peace Prize

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**SECTION 1.** The United States shall reject all demands from the Venezuelan regime and shall allocate \$10 billion to eliminate state-sponsored terrorism and restore democracy to Venezuela through comprehensive economic sanctions targeting all Venezuelan and Russian government assets, declaration of war with the Maduro regime, provision of full military and strategic support to María Corina Machado and the Venezuelan democratic opposition to conduct regime change operations, and allocation of \$100 billion to establish a Counter-Retaliatioin Task Force to prevent the return of authoritarian leadership and suppress cartel retaliation efforts.

**SECTION 2.** For the purpose of this bill, the following terms shall be defined: "Comprehensive Economic Sanctions" shall be defined as the freezing of all assets, prohibition of financial transactions, and trade embargoes targeting designated hostile nations. "Democratic Opposition" shall be defined as the coalition of Venezuelan political leaders and organizations committed to restoring constitutional democracy, led by María Corina Machado. "Regime Change Operations" shall be defined as coordinated military, intelligence, and political actions designed to remove the Maduro regime and establish democratic governance.

**SECTION 3.** The Department of State, in coordination with the Department of Defense, Department of Treasury, and Central Intelligence Agency, shall oversee the enforcement of this legislation.

**SECTION 4.** This legislation will take effect immediately upon passage.

**SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

*Introduced for Congressional Debate by Zacery Zhen, from Nova High School.*

\* Passing this bill means continuing anti-cartel operations, accepting the risk of 30-50 terrorist attacks, and declaring war to support regime change. Failing this bill means complying with Venezuela's demands and ceasing all operations to prevent attacks and avoid war.
