

## **A Bill to Mandate Rabies Vaccinations for All Supernatural Shapeshifters**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. All supernatural beings possessing the capacity for human-to-animal transformation—including but not limited to werewolves, skinwalkers, therianthropes, and other recognized shapeshifters—shall be required to receive a certified rabies vaccination every twelve (12) months.

SECTION 2. Enforcement:

A. The Department of Health and Human Supernatural Services (DHHSS) shall oversee the registration, documentation, and enforcement of rabies vaccination compliance.

B. Shapeshifters will be issued a “Transformation Health Identification Card” (THIC) upon proof of vaccination.

C. Failure to provide current vaccination documentation upon request by authorized supernatural health officers shall result in a mandatory quarantine and vaccination at the individual’s expense.

D. The DHHSS shall coordinate with local lycanthropy and supernatural affairs councils to ensure equitable and culturally sensitive implementation.

SECTION 3. This legislation shall take effect on October 31, 2026 (FY 2026). All laws or edicts in conflict with this act are hereby declared null and void.

## **A Bill to Restrict Candy Given Out to Trick or Treaters**

WHEREAS, many homemade halloween candies have been found to have harmful substances and objects within them.

WHEREAS, to protect the health and wellbeing of the youth in the United States

BE IT ENACTED HERE BY THE CONGRESS ASSEMBLED HERE THAT:

SECTION 1. All homemade candies and foods are hereby banned from being given out to trick or treaters on the night of October 31st.

SECTION 2. Candies given out to trick or treaters that are not from major candy companies, which include, but are not limited to: Mars Wrigley, Inc., Mondelēz International, Ferrero Group, The Hershey Company, Nestle SA, Haribo Co., Kellogg Co., Simply Good Foods Co., and Tootsie Roll Industries, are also hereby banned to be given out to trick or treaters on the night of October 31st

SECTION 3. Unwrapped candies, even from the approved list of major candy companies, are also banned from being given out to trick or treaters on the night of October 31st.

SECTION 4. Trick or treaters shall be defined as children ages 0-17 that come to a home the night of the 31st.

SECTION 5. "Major candy companies" shall be defined as companies approved by the US Food and Drug Administration (FDA)

SECTION 6. The US Food and Drug Administration (FDA) shall oversee the implementation of this bill.

SECTION 7. This bill is effective immediately October 30th of 2026.

SECTION 8. All laws in conflict in this are null and void

## **SAFE AND SPOOKY STREETS ACT OF 2025**

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

### **SECTION 1. Establishment of the Safe and Spooky Streets Program (SSSP).**

A. The United Department of Public Safety (USDPS) shall oversee creation and management of the SSSP in collaboration with the United States Highway Patrol (USHP) for road safety enforcement, local police departments for neighborhood patrols and emergency response and the Department of Education for school-based awareness and costume safety programs.

#### **B. The SSSP shall:**

1. Mandate municipalities organize a Halloween Safety Zone Plan annually by October 1st, outlining road closures, trick-or-treat routes, and emergency contact points.
2. Require all minors under 13 wear reflective gear or carry a light source while trick-or-treating after sunset.
3. Establish a voluntary Community Safety Watch, allowing residents to register as patrol members with their local police department to monitor neighborhoods from 5 PM to 10 PM on Halloween night.
4. Launch a national Haunted Safe House Network through which homes, fire stations, and community centers can register as designated safety points with visible signage provided by the CDPS.
5. Require local law enforcement to maintain a visible presence in high-traffic trick-or-treat areas to deter harassment, abduction, and traffic-related accidents
6. Publish an annual Halloween Safety Report summarizing implementation outcomes, injury statistics, and community feedback.

### **SECTION 2. Enforcement and Penalties.**

A. Municipal police departments shall enforce reflective gear and street safety requirements.

B. Parents or guardians who knowingly allow minors under 13 to participate in nighttime trick-or-treating without reflective gear shall receive a written warning for the first violation and a \$100 civil fine for subsequent violations.

C. Cities or counties that fail to submit a Halloween Safety Zone Plan by the October 1st deadline shall forfeit eligibility for state safety grant funding that year.

### **SECTION 3. Funding and Administration.**

A. Funding shall be provided through the United States Public Safety Enhancement Fund, reallocated from existing community safety grant reserves. Additions funding from sponsorships from local businesses and Halloween event organizers.

**SECTION 4.** This act shall take effect on October 1, 2026. All laws in conflict with this legislation are hereby declared null and void.
