A BILL TO ALLOCATE FEDERAL FUNDING TO UPGRADE THE U.S. RAIL NETWORK TO INCLUDE MAGLEV TECHNOLOGY TO INCREASE THE EFFICIENCY AND SPEED OF GOODS AND PASSENGER TRANSPORTATION NATIONWIDE

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

SECTION 1. The United States shall allocate \$20 billion over 10 years to upgrade select corridors of the national rail system to magnetic levitation (maglev) train technology to improve the transportation of goods and people.

SECTION 2. For the purpose of this bill,

- **A.** "Maglev technology" refers to high-speed rail systems that use magnetic forces for lift and propulsion, reducing friction and enabling faster speeds.
- **B.** "Select corridors" refers to high-traffic rail lines, particularly those connecting major metropolitan areas and industrial hubs, as identified by the Department of Transportation (DOT).

SECTION 3. The Department of Transportation (DOT) shall oversee the implementation and regulation of this project.

- **A.** Funds will be distributed through a competitive grant system to states and private-public partnerships with viable maglev infrastructure proposals.
- **B.** Annual progress reports shall be submitted to Congress detailing the development, expenditures, and projected impacts on freight and passenger capacity.

SECTION 4. Implementation of this policy shall begin on January 1, 2026, with initial grants awarded by July 1, 2026.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A RESOLUTION TO AMEND THE CONSTITUTION TO REPEAL THE DOUBLE JEOPARDY CLAUSE TO ALLOW RETRIALS IN THE INTEREST OF JUSTICE

RESOLVED, By two-thirds of the Congress here assembled, that the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution when ratified by the legislatures of three-fourths of the several states within seven years from the date of its submission by the Congress:

ARTICLE --

SECTION 1: The Double Jeopardy Clause of the 5th Amendment shall hereby be repealed. The Double Jeopardy Clause shall be defined as the passage stating "nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb".

SECTION 2: The Congress shall have power to enforce this article by appropriate legislation.

A Bill to Provide Milk Choice in Schools

A Bill to Jumpstart Domestic Rubber Production

A Bill to Remove the Social Security Cap
