Student Congress Legislation-October 18-19

Prelims: The Tobacco and Inhalant Restriction Act

- 1. **Section 1:** All forms of E-cigarettes, Vapes, Cigarettes, Cigarillos, Cigars, Snuff, Tobacco
- 2. Hookah, Cannabis, and other tobacco products shall henceforth be banned for use or sale
- 3. in the United States and her territories.
- 4. **Section 2:** This bill shall not affect Nicotine pouches, Oral Nicotine Pouches, Ground
- 5. Tobacco, or accessories associated with tobacco like Pipes, which may be used for herbs
- 6. or stylistic accessories.
- 7. **Section 3:** Individuals may still grow tobacco for their own use on their own property but
- 8. must register all tobacco crops with their local authorities and are forbidden from selling
- 9. said products. Any violation shall be met with a 5000 dollar fine.
- 10. **Section 4:** This legislation shall be handled by the Drug Enforcement Agency (DEA).
- 11. **Section 5:** All laws in conflict with this legislation are declared null and void.

Prelims: A Bill to Repeal the Privilege of Concealed Carry

- 1. Whereas: The number of deaths of innocent civilians in non-self defense scenarios by
- 2. citizens with a concealed carry permit are rapidly increasing, and
- 3. Whereas: With increased social safety and improved policing techniques, the ability to
- 4. concealed carry is increasingly becoming useless,
- 5. THEREFORE BE IT RESOLVED BY THE CONGRESS HERE ASSEMBLED THAT:
- 6. **Section 1:** The Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) shall be
- 7. ordered to contact all citizens who are in possession of a concealed carry license/permit
- 8. and order them to either seek an open-carry license or cease public firearm carry.
- 9. **Section 2:** Disobedience of this legislation shall be handled by the ATF and the FBI.
- 10. **Section 3:** This law shall come into effect January 1st, 2026
- 11. **Section 4:** All laws in conflict with this legislation are declared null and void.

Prelims: A Resolution to Rejoin and Strengthen the JCPOA to Prevent Nuclear Proliferation

1	WHEREAS,	Iran's nuclear program has significantly expanded since the United States
2		withdrew from the Joint Comprehensive Plan of Action (JCPOA) in 2018;
3		and
4	WHEREAS,	The agreement's absence increases the risk of Iran acquiring nuclear
5		weapons, which could threaten global and regional security; and
6	WHEREAS,	The lack of a strong agreement has led to increased uranium enrichment
7		levels, the use of advanced centrifuges, and the heightened risk of nuclear
8		weapon development, which has escalated regional and global tensions; and
9	WHEREAS,	Restoring and strengthening the JCPOA with stronger provisions could help
10		prevent nuclear missile development; now, therefore, be it
11	RESOLVED,	That the Congress here assembled calls for the United States to rejoin the
12		JCPOA with provisions to extend nuclear restrictions to ensure long-term
13		compliance, expand verification mechanisms (such as on-site inspections,
14		constant monitoring of nuclear sites, and access to suspected undeclared
15		facilities by the International Atomic Energy Agency), address regional
16		security concerns by limiting the development and testing of missiles
17		capable of delivering nuclear warheads; and, be it
18	FURTHER R	RESOLVED, That Congress encourages collaboration with other allied
19		nations to negotiate additional agreements to curtail ballistic missile
20		developments and support of proxy groups.

Finals: A Bill to Require Proof of U.S. Citizenship to Vote

- 1. THEREFORE BE IT RESOLVED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2. **Section 1:** All polling place volunteers shall be required to check for proof of U.S.
- 3. citizenship before someone may cast a vote in a presidential election. If citizenship
- 4. cannot be verified, this person shall not be able to cast a vote.
- 5. **Section 2:** Proof of citizenship shall be defined as including the following: A U.S.
- 6. passport, U.S. birth certificate, Certificate of Naturalization, Certificate of Citizenship,
- 7. or a Consular Report of Birth Abroad.
- 8. **Section 3:** This legislation shall be enforced by the Federal Bureau of Intelligence.
- 9. **Section 4:** This legislation shall come into effect January 1st, 2028.
- 10. **Section 5:** All laws in conflict with this legislation are declared null and void.

Finals: A Bill to Restore Lost Media

- 1. Whereas: Media preservation efforts are on the rise in other nations, and
- 2. Whereas: Media is a core fundamental of the culture of the United States and the
- 3. preservation of it is vital to our culture's health,
- 4. THEREFORE BE IT RESOLVED BY THE CONGRESS HERE ASSEMBLED THAT:
- 5. **Section 1:** The United States Copyright Office shall release media that has not been in
- 6. publication in the United States in its original form or a new form of near identical
- 7. resemblance for an accumulated five years into the public domain for free download.
- 8. **Section 2:** Media will be defined as published art, including, but not limited to books,
- 9. movies, and video games. The public domain will be defined as the public body of
- 10. material that is not covered under any copyright law.
- 11. **Section 3:** The United States Copyright Office (USCO) shall be responsible for the
- 12. implementation of this legislation.
- 13. **Section 4:** The USCO will see an increase in funding of \$100 million.
- 14. **Section 5:** This bill will go into effect January 1st, 2026.
- 15. **Section 6:** All laws in conflict with this legislation are hereby declared null and void.
