# **Entry & Eligibility**

Entry is open to students in grades 5-12 representing their schools. No independent entries are allowed.

Upon registration, all entries will be put on a waitlist. We will begin to clear the waitlist on November 8<sup>th</sup> and then will continue to clear it as space permits until registration locks the week of the tournament.

# **Judging Obligations**

Speech /Congress: 1 judge per 4 entries
Lincoln–Douglas: 1 judge per 2 entries
Public Forum: 1 judge per 2 teams

• **Policy:** 1 judge per 2 teams



Judges must be available for all rounds and familiar with the rules of their events. Seniors may judge JV but must be indicated appropriately in Tabroom.

**Hired Judges:** A limited number of hired judges will be available. As a note: hired judges are not guaranteed.
