### A Bill to Grant Citizenship to Dreamers

## A Bill to Ban Animal Testing

**SECTION 1**. The United States shall ban testing on non-human vertebrates for the purposes of non-essential products for humans.

**SECTION 2**. Definitions

- A. Ban: officially or legally prohibit.
- B. Testing: the systematic investigation into and study of materials and sources in order to establish facts and reach new conclusions.
- C. Non-human vertebrates: an animal, other than humans, of a large group distinguished by the possession of a backbone or spinal column, including mammals, birds, reptiles, amphibians, and fishes.
- D. Purposes: the reasons for which something is done or created or for which something exists.
- E. Non-essential products for humans: products or services that are not considered necessary for basic human survival and well-being.
- **SECTION 3.** The U.S. Department of Agriculture (USDA) shall oversee the implementation of this legislation.
- **SECTION 4.** This legislation will take effect the fiscal year of 2027. All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Halt Pay for Members of Congress During Government Shutdowns

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- SECTION 1. Members of Congress will not receive their monthly or bi-monthly paychecks while the government is in a state of shutdown due to failure to pass a budget. Members will receive backpay in full for their salaries missing during the shutdown once a federal budget is passed.
- SECTION 2. Backpay will be defined as salary paid to a member of Congress to fully compensate for the pay periods missed by the Treasury Department.

  Shutdown will be defined as a period during which the federal government has not passed a budget to pay government employees, hence a shutdown of non-essential government offices.
- **SECTION 3.** As delegated by Congress, the Treasury Department and the Secretary of the Treasury shall oversee the enforcement of this legislation.
- **SECTION 4.** This legislation will take effect October 1, 2026 (FY 2027). All laws in conflict with this legislation are hereby declared null and void.

## A Resolution to Amend the Constitution Revoking The President's Authority To Grant Pardons

1	RESOLVED,	By two-thirds of the Congress here assembled, that the	
2	following article is proposed as an amendment to the Constitution of the

4	Constitution when ratified by the legislatures of three-fourths of the		
5	several states within seven years from the date of its submission by the		
6	Congress:

8	SECTION 1:	The President of the United States will no longer hold the	
9		authority to grant pardons to a convicted criminal.
