Reminders about Use of Evidence in Congressional Debate

Review these two points carefully, and let your coach or me know if you have any questions about them.

- When citing an authoritative source, always include at least the author/publication and the year. For example, citing the *New York Times* without the year or the date is ineffective and does not meet proper citation standards. While this is not an official evidence violation, it weakens your argument and credibility as a debater.
- Make sure any sources you cite actually support your argument. Use neutral, reliable sources for statistics, and when presenting analysis, check that the author's conclusion matches yours—don't use sources that misrepresent or oversimplify opposing views just to make them easier to refute. (You can review rules and guidelines for evidence and source citations here. Pay particular attention to 7.2.4 "Straw Argument".)

State Qualification Update

After three tournaments, **19 students have earned full qualification** to the State Championship in April—that's another nine students on top of the 10 already fully qualified! Remember: even if you don't reach finals, placing in the **top six or top half** of a chamber still earns a bid. (In other words, we always give six bids per chamber. But if we have more than 12 competitors, then we give everyone in the top half a bid.)



The Federal Workers Fairness Act

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1. Members of the United States Congress will not receive their salaries during a government shutdown. Members of Congress will receive partial retroactive pay once the government shutdown ends. Members of Congress will continue to receive health insurance coverage as provided by the Federal Employee Health Benefits program.

SECTION 2. a. "Salaries" refers to the salaries as of date of members of the United States Congress.

b. "Government shutdown" refers to the outcome of a lapse in appropriations, during which the Congress of the United States fails to pass a budget and most employees of the federal government are furloughed.

c. "Partial retroactive pay" shall be defined as 50% of the pay members of Congress would've received in the time period if there had not been a government shutdown.

SECTION 3. The Congressional Budget Office in conjunction with the United States Department of Treasury shall oversee implementation and enforcement of this legislation.

SECTION 4. This legislation will take effect upon passage.

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Implement Rank Choice Voting

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Rank choice voting shall be implemented for both Senators and
2		Representatives in state and national elections in . Rank choice voting shall
3		be implemented in single member districts to choose Representatives for
4		the State and Federal House of Representatives. This legislation will not
5		affect multi-member districts.
6	SECTION 2.	A. Rank Choice Voting will be defined as a voting system where voters rank
7		their choices for office by order of preference.
8		B. This legislation will not change the number of Representatives and
9		Senators on both the state and national level.
10	SECTION 3.	The Federal Election Commission shall oversee the implementation of this
11		legislation. 1.5 Billion dollars will be allocated to the Federal Election
12		Commission to aid with the implementation of this legislation. This
13		funding will go towards hiring staff on election day, software, and any
14		infrastructure and equipment needed to implement RCV.
15	SECTION 4.	To be implemented on Januray 1st 2027
16	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void

A Resolution to Promote Workplace Pay Equity

WHEREAS, The gender wage gap persists in the United States, with women earning approximately 84 cents for every dollar earned by men;

WHEREAS, Wage disparities are even more pronounced for women of color, with Black women earning 69 cents and Latina women earning 57 cents for every dollar earned by white, non-Hispanic men;

WHEREAS, Pay inequity contributes to economic insecurity, limits retirement savings, and perpetuates systemic inequality;

WHEREAS, Transparency in compensation practices has been shown to reduce unexplained wage gaps and promote fair pay;

WHEREAS, Many employers lack systematic processes to identify and address pay disparities within their organizations; now, therefore, be it

RESOLVED, That the Congress here assembled urges all employers to conduct regular pay equity audits to identify and address unexplained wage disparities; and be it

FURTHER RESOLVED, That Congress calls upon the Equal Employment Opportunity Commission to develop and publish voluntary guidelines for conducting pay equity audits that account for legitimate factors such as experience, education, performance, and seniority; and be it

FURTHER RESOLVED, That Congress encourages states to adopt pay transparency legislation requiring employers to disclose salary ranges in job postings and prohibit retaliation against employees who discuss compensation; and be it

FURTHER RESOLVED, That Congress recognizes the need for continued research, public awareness campaigns, and policy solutions to eliminate the gender wage gap and achieve economic justice for all workers.

A Bill to Combat Shrinkflation

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 \$	SECTION 1.	A manufacturer of consumer packaged goods shall apply for a waiver from
3		the Federal Trade Commission for any changes made to reduce the size or
4		quantity offered on an item identified by a unique Universal Product Code
5		that exceed one such size or quantity reduction in any twelve-month period
6		The Federal Trade Commission may issue a waiver based on balancing the
7		impacts of the change on consumers against the business concerns of the
8		manufacturer, except that any waiver application not acted upon within 60
9		days shall be considered approved. Any products whose quantities or sizes
10		have changed more than once in a twelve-month period without a valid
11		waiver shall be seized, and the manufacturer shall be fined \$100,000 per
12		incident.
13 S	SECTION 2.	Consumer packaged goods shall be defined as food, drink, hardware, or
14		cosmetic items produced in packaging and intended for retail sale.
15 S	SECTION 3.	The Federal Trade Commission shall be responsible for enforcing this
16		legislation.
17 S	SECTION 4.	This legislation will take effect on October 1, 2026. All laws in conflict with
18		this legislation are hereby declared null and void.
