

## Round 1

# A Resolution To Ban Children's Access To Social Media

**Whereas**, estimates indicate that 95% of American teens age 13-17 utilize social media platforms and approximately 40% of 10-12 year olds use social media, and

**Whereas**, numerous studies find a direct correlation between addictive social media algorithms and negative mental health impacts including sleep disruption, anxiety, depression, eating disorders, suicidal ideation, stunted social skills, low self-esteem, and compulsive and addictive behaviors among children and adolescents.

**Whereas**, social media platforms expose children to harmful and dangerous content like predatory abuse, sexual harassment, emotional manipulation, blackmail and cyber-bullying.

THEREFORE BE IT RESOLVED BY THE CONGRESS HERE ASSEMBLED THAT:

**Section 1:** Social Media access for all U.S. children under the age of 16 be banned.

**Section 2:** All social media companies operating in the U.S. shall take reasonable steps to prevent access to their platforms for children under the age of 16, including robust and effective age-verification systems like facial recognition and other age-assurance technologies.

**Section 3:** Social media providers found in violation of this ban will face significant financial penalties of up to \$50 million and repeated offences will result in a loss of rights to operate in the U.S.

**Section 4:** Oversight of this ban will be provided by the Federal Communication Commission (FCC) and consumer protection enforcement will be provided by the Federal Trade Commission (FTC)

**Section 5:** This ban will take effect January 1, 2027 and all laws in conflict with the ban are declared null and void.

## Round 2

### A Bill to End Legacy Admissions

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

**Section 1:** Educational institutions shall be prohibited from taking legacy status into consideration during their admission process.

**Section 2:** "Legacy admissions" is defined as giving preferential admission consideration to prospective students based on a relative's prior or current attendance at the educational institution. "Educational institutions" are defined as any organization whose primary function is the education of students, whether adults or children, and which select their students based on a competitive or selective admission process.

**Section 3:** The Department of Education (DOE) will oversee the implementation of this legislation. Educational institutions found to be granting legacy admissions will be denied federal funding.

**Section 4:** This legislation will take effect on July 1, 2027. All laws in conflict with this legislation are hereby declared null and void.

## **Round 3**

### **A Resolution To Plan Coordinated Drone Safety**

**Whereas**, drones are being effectively used to disrupt and damage airbases and aircraft as evidenced in Ukraine's Operation Spiderweb, ISIS attacks in Iraq and Syria and even by Mexican drug cartels against their competitors, and

**Whereas**, U.S. airports and commercial aircraft are at increased risk of drone intrusions and attacks by international enemies and/or rogue terrorist groups, and

**Whereas**, in the status quo, only select DOJ and DHS personnel have the authority to intercept and/or disrupt communication controls on unknown drones which pose a safety risk at America's airports, and

**Whereas**, due to both funding and staffing shortages federal DOJ and DHS anti-drone teams are not stationed at U.S. airports, which are left provide their own less effective anti drone safety measures,

**THEREFORE BE IT RESOLVED BY THE CONGRESS HERE ASSEMBLED THAT:**

Appropriate funding for materials and staffing be provided to the Departments of Justice and Homeland Security to develop Coordinated drone safety plans and personnel teams instituted at all large and medium hub U.S. airports with one million or more annual passenger volume.

## Finals

### A Resolution to Condemn Russia

**Whereas**, Russia promotes ideals that are contradictory to American ideals and threaten democracy globally, and

**Whereas**, these contradicting ideals have been best exemplified by the likely election fraud in 2024 that led to Vladimir Putin maintaining his position as Russian President,

THEREFORE BE IT RESOLVED BY THE CONGRESS HERE ASSEMBLED THAT:

**Section 1:** The United States Federal Government shall formally declare that the results of the 2024 Russian election were invalid due to voter fraud, condemning the country for failing to maintain democratic integrity.

## Finals

### **A Resolution to Bolster U.S. Strategic and Economic Security**

**Whereas**, The strategic and economic security of the United States is the paramount duty of the Federal Government, and

**Whereas**, both China and Russia threaten the economic and strategic security of the United States and its citizens, and

**Whereas**, the arctic region is vital to both U.S. economic growth and opportunity and national strategic security interests because of critical shipping lanes, abundant natural resources and homeland security and defense capabilities,

**THEREFORE BE IT RESOLVED BY THE CONGRESS HERE ASSEMBLED THAT:**

Congress expresses support for the President's efforts to annex all or a portion of the territory of Greenland. To that end, this Congress authorizes the President to use the U.S. military in any capacity necessary to ensure America's economic and strategic security in the Arctic region.

Congress further directs the President, prior to, or as soon as possible (but no later than 48 hours) after exercising such authority, to make available to the Speaker of the House of Representatives and the President pro tempore of the Senate his determination that: (1) reliance on further diplomatic or peaceful means alone will not achieve the above purposes; and (2) his general plans for military deployment and continued diplomatic efforts to achieve U.S. strategic goals. Finally, Congress directs the President to update and brief Congressional leaders every 30 days, from the commencement of military action, on the particular circumstances of the military operation.
