## PLATFORM

Our tournament will be held in person on the campus of Murray State University and will use Tabroom.com for electronic ballots. All competitors and judges will need to have a registered account on Tabroom.com and judges should bring their own laptop to fulfill their obligations in preliminary and final rounds.

## CATEGORIES

We will offer all KHSSL JR & SR speech events at the Etherton Invitational. Please consult the [Kentucky High School Speech League Handbook](#) for event guidelines and scoring rules.

## ENTRIES

Teams will be allowed to have unlimited entries. The top three scores in each event per team will count towards the team sweepstakes awards. Students may **TRIPLE** in individual speech events. All students are expected to follow the schedule for the day and be on-time to rounds. However, we ask that judges be patient as students may be moving from building to building. Any concerns about whether to hold a round or not for missing students should be addressed with the tournament staff in Tab.

## JUDGES

Teams will provide one judge for every six entries into the tournament (6 entries = 1 judge, 12 entries = 2 judges, etc.). In the event you cannot provide the required number of judges, there will be a fine of \$35 per missing judge.

All judges should be familiar with KHSSL rules and ballots and are expected to be available in the judge pool during rounds where they have not been

scheduled. ALL JUDGES MUST HAVE A TABROOM ACCOUNT IN ORDER TO BE PLACED ON YOUR JUDGING ROSTER. Some JR Speech rounds may utilize SR Speech judges and vice versa. All judges are asked to be prepared for the day and to attend the 8am opening meeting.

## COST

Single entry = \$5.00

Double entry (Duo/Improv) = \$10.00

Entry drops/adds after deadline = \$10.00

Unfulfilled judge burden = \$35 per missing judge

Judge drops = \$50
