## A Resolution to Encourage the Criminalization of Vehicular Pet Abandonment

1 WHEREAS	It is estimated that hundreds of pets die from being abandoned in	
2	cars every year; and	
3 WHEREAS	These deaths can occur not just due to heat but also due to cold,	
4.	thirst, and other factors besides; and	
5 WHEREAS	In many parts of the United States and its territories, there are no	
6.	laws protecting pets from such mistreatment, and those laws that	
7.	exist elsewhere are often too vague to be meaningfully enforceable;	
8.	and	
9. WHEREAS Pet ownership is a privilege, not a right, and one which requires		
10.	significant maturity and responsibility; now, therefore be it	
11. <b>RESOLVED</b> by the Congress here assembled that all jurisdictions throughout		
12	these United States are encouraged to enact tough laws that protect	
13.	pets by criminalizing their abandonment in motor vehicles under any	
14.	and all circumstances; and be it	
15 <b>FURTHER RESOLVED</b> that Congress also urges the passage of Good Samaritan		
16.	laws that protect others from entering a vehicle without the	
17	owner's permission to rescue an abandoned pet, even if to do so	
18.	would result in damage to the vehicle.	

### A Bill to Provide for Automatic Facial Copyrighting

#### 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

- 2 **SECTION 1**. All citizens and residents of the United States and its territories henceforth, shall
- automatically possess full and unconditional copyright on their own faces and any
- 4 images or likenesses thereof, excluding normal exceptions such as Fair Use.
- 5 **SECTION 2.** Any person, corporation, or other entity wishing to use a citizen or resident's face
- 6 in a manner protected by copyright law must obtain explicit written permission
- 7 and provide just compensation or face civil and, under extreme circumstances,
- 8 criminal penalties. This shall include any future usage of faces by artificial
- 9 intelligence services.
- 10 **SECTION 3.** When a citizen or resident passes away, the copyright to their face shall pass to
- their heirs of beneficiaries as part of their estate. If none are named, relevant laws
- of interstate succession shall come to bear. The copyright shall remain enforceable
- by its rightful owner(s) for 70 years following the death of its original owner, after
- which point the face in question shall enter the public domain. This provision
- shall not apply retroactively to those who are already deceased at the time this
- 16 legislation takes effect.
- 17 **SECTION 4.** The Copyright Office of the Library of Congress shall oversee implementation
- 18 of this legislation.
- 19 **SECTION 5.** This legislation shall take effect on January 1, 2026.
- 20 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Ban Law Enforcement From Lying to Minors in Interrogations

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1	SECTION 1.	Police will no longer be allowed to deceive minors during	
2	interrogations	to provoke a confession in order to promote the reliability of	
3	youth witness	testimonies.	
4	SECTION 2.	Minor being defined as a person under the age of 18, and	
5	deceive being	defined as lying performed by an officer or interrogating	
5	personnel to provoke a confession.		
7	SECTION 3.	The implementation of this piece of legislation will be	
3	enforced by the Department of Justice (DoJ).		
Э	A. The DoJ w	ill ensure this is enforced by regulating the education of	
10	interrogat	ion methods to local law enforcement officials both in	
11	training ar	nd currently active.	
12	B. To ensure	full enforcement of this piece of legislation, interrogation	
13	sessions w	vill be recorded to ensure interrogation principles are upheld.	
14	SECTION 4.	This legislation will take effect at the beginning of the 2026	
15	fiscal year.		
16	SECTION 5.	All laws in conflict with this legislation are hereby declared	
17.	null and void.		

### A Bill to Establish the National Inmate Education Program (NIEP)

#### 1.BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

- 2. **SECTION 1**. The Inmate Education Program will be created and put into effect.
- 3. **SECTION 2. A.** The National Inmate Education Program will permit any Inmate seeking
- 4. education while serving their sentence to be eligible to apply.
- 5. **B.** Inmates will be given the opportunity to join The National Education
- 6. Program by presenting the opportunity before a judge unless the judge
- 7. denies their request respectfully.
- 8. **C.** During the program, inmates will learn basic and advanced
- 9. mathematics, history, science, personal finance and proper hospitality.
- 10. **D.** Disciplinary actions will be determined by each state's jurisdiction.
- 11. **SECTION 3.** The U.S Department of Education will oversee the implementation of this
- 12. bill as well as selection processes.
- 13. A. The U.S Department of Education will oversee the implementation of
- 14. this bill by providing penitentiary and detention centers with educational
- 15. supplies including textbooks, research tools and stand essentials including
- 16. pencils and erasers and sending hired teachers to the detention centers
- 17. and penitentiaries.
- **SECTION 4.** This legislation will take effect on January 1st, 2026.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Ban Tackling in Football and Rugby

- 1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:
- 2. **SECTION 1**. Tackling is hereby prohibited in public elementary, middle,
- 3. and secondary education sports in football, rugby, and any other
- 4. activities where tackling is standard practice within the sport. The use
- 5. of flags as a stand-in for tackling shall remain legal, and public and
- 6. private leagues at all levels are encouraged to embrace this humane
- 7. adaptation.
- 6. **SECTION 2.** Tackling is defined as the intentional use of physical contact
- 7. and force to arrest another player's movement, bring that player to
- 8. the ground, and/or compel that player to lose possession of the ball.
- 9. **SECTION 3.** Any public school found to be allowing tackling sports
- 10. without penalty shall be fined \$1,000 for each violation.
- 11 **SECTION 4**. This legislation shall be jointly overseen by the Department
- 12. of Health and Human Services and the Department of Education.
- 13. **SECTION 5**. This legislation shall take effect on August 1, 2026.
- 14. **SECTION 6.** All laws in conflict with this legislation are hereby declared
- 15. null and void.
