To Whom It May Concern:

This is to verify that Gilbert Public Schools of Maricopa County, Gilbert, Arizona is a publicly funded institute and political subdivision of the State of Arizona. As such, we are a non-profit organization under section 170 of the Internal Revenue Code and donations to the School District or schools within the District are tax deductible. The District's Federal Tax ID number is: 86-6000530.
