## **Docket A: Domestic Bill 6626**

### *The Last of the Bugs Act*

Be it enacted,

Line01: Article 1: The United States Environmental Protection Agency, in coordination with  
Line02: The United States Department of Agriculture, shall be tasked with the submission of  
Line03: comprehensive biannual reports regarding (i) the numerical status of national insect  
Line04: populations and (ii) the extent of current conservation efforts in relation to protected  
Line05: insects and the numerical effectiveness thereof. These reports shall be submitted  
Line06: to Congress on a biannual basis and made available for national public viewing.

Line07: Article 2: A. "Biannual reports" shall refer to individual reports that are to be  
Line08: conducted and presented twice every fiscal year in the form of two six month terms.  
Line09: B. "Available for national public viewing" shall refer any piece of media that,  
Line10: through its publication, is accessible to at least 75% of current US citizens.

Line11: Article 3: The House Committee on Agriculture and The Senate Committee on  
Line12: Environment and Public Works shall be given direct oversight over the provisions of  
Line13: this bill. In the case of failed compliance, a fine of no more than ten thousand dollars  
Line14: shall be set forth per calendar day up to the collective discretion of both the House  
Line15: and the Senate committees.

Line16: Article 4: The provisions of this bill shall take effect on April 24, 2027

Line17: Article 5: All laws in conflict with this legislation are hereby declared null and void.

## **Docket A: Economic Bill 0211**

### *A Bill to Provide United States Citizens With A Liveable Baseline Income*

Be it enacted,

Line 01: SECTION 1. The United States government should see to it that each  
Line 02: citizen of the nation are awarded a non-taxed monthly payout of  
Line 03: \$1,000 with an additional \$200 awarded per child or human  
Line 04: dependent. This action will be taken on by the Department of  
Line 05: Health and Human Services and Social Security Administration.

Line 06: SECTION 2. A budget of about \$3.7 trillion will be provided to the  
Line 07: departments listed above to be distributed among the American  
Line 08: people. This budget is subject to increase with the population  
Line 09: of citizens in order to continue allowing each independent U.S.  
Line 10: citizen to be provided with their proper baseline Income.

Line 11: SECTION 3. Those already on other forms of Government benefits  
Line 12: should be allowed the choice of retaining their current benefits  
Line 13: or opting into the Universal Baseline Income program in order  
Line 14: to subtract roughly \$1.2 trillion from the revenue necessary for  
Line 15: this program. All United States citizens not currently enrolled in  
Line 16: a form of welfare program will automatically be provided with  
Line 17: this Universal Basic Income.

Line 18: SECTION 4. In order to aid in providing the necessary budget for this  
Line 19: action, a VAT (Value Added Tax) of about 5% will be  
Line 20: implemented on most goods and services across the United  
Line 21: States. The profits of this VAT will be funneled from the  
Line 22: government body to the baseline income.

Line 23: SECTION 5. This bill will be put in effect as soon as January 1, 2027.  
Line 24: All laws in conflict will also be ruled null by the introduction of  
Line 25: this bill.

## **Docket A: International Bill 2001**

### *A Bill to Ensure the Democratic Transition of Haiti*

Be it enacted,

Line 01: ARTICLE I. On March 1st, 2026, \$2.5 billion dollars will be allocated towards  
Line 02: the guarantee of free and fair elections in the Republic of Haiti.

Line 03: ARTICLE II. The Department of Defense will seize control of the city of  
Line 04: Port-au-Prince and free the remaining gang controlled territories, such as the  
Line 05: Artibonite, Centre or Ouest Departments, among others. Fils-Aimé's interim  
Line 06: government shall be put in charge of domestic aid and election hosting, using  
Line 07: the resources of the United States and under its supervision, during the  
Line 08: duration of this operation.

Line 09: ARTICLE III. These actions will occur only when paramilitary action is  
Line 10: confirmed to be ineffective or insufficient. In the event of failure, intelligence  
Line 11: assets shall be retained to confirm the fairness and validity of elections, and to  
Line 12: ensure the existing widespread pro-American culture and attitude of the Haitian  
Line 13: people remain present in the nation.

Line 14: ARTICLE IV. The provisions of this bill shall take effect immediately following  
Line 15: a vote in favor of passing the bill.

Line 16: ARTICLE V. Any and all legislation in conflict with this legislature is thus  
Line 17: declared null and void.

## **Docket A: Domestic Bill 2010**

### *A Bill to Eliminate Private School Voucher Federal Funding for High-Income Families*

Be it enacted,

Line 01: SECTION I. The United States federal government shall prohibit high-income  
Line 02: households from receiving federally funded private school voucher funds.

Line 03: SECTION II. A. Federally Funded Private School Vouchers: Publicly, federally  
Line 04: funded subsidies allowing families to pay for tuition at private and religious  
Line 05: schools.

Line 06: B. High income: specified as \$256,920, 90th percentile, or above in income  
Line 07: for a household in the United States.

Line 08: SECTION III. The U.S. Department of Education shall oversee the  
Line 09: implementation and enforcement of income-based eligibility for federally funded  
Line 10: private school vouchers, henceforth.

Line 11: SECTION IV. The provisions of this bill shall take effect immediately following  
Line 12: a vote in favor of passing the bill.

Line 13: All laws in conflict with this legislation are hereby declared null and void.

## Docket A: Virginia Bill 2020

### *A Bill to Improve the Nutritional Standards of School Meals in Virginia*

Be it enacted,

Line 01: SECTION 1. All public schools in the Commonwealth of  
Line 02: Virginia shall be required to serve meals that meet stricter  
Line 03: nutritional standards, prioritizing whole foods, reduced  
Line 04: sodium, limited added sugars, and balanced portion sizes,  
Line 05: regardless of student preference for taste or quantity.

Line 06: SECTION II.

Line 07: A. Whole foods shall be defined as minimally processed  
Line 08: foods such as fruits, vegetables, whole grains, and lean proteins.  
Line 09: B. Balanced portion sizes shall be defined as portions  
Line 10: aligned with the Virginia Department of Health (VDH) nutritional  
Line 11: guidelines for children and adolescents.  
Line 12: Added sugars shall be defined as sugars not naturally occurring  
Line 13: in the food, including syrups, sweeteners, and processed additives.

Line 14: SECTION 3. The Virginia Department of Education (VDOE) and  
Line 15: the Virginia Department of Health (VDH) shall jointly oversee  
Line 16: enforcement of this legislation.

Line 17: - VDOE shall ensure school compliance through administrative  
Line 18: oversight, integration into school wellness policies, and  
Line 19: annual reporting requirements.  
Line 20: - VDH shall establish the nutritional standards, conduct  
Line 21: inspections, and provide guidance to school nutrition programs.  
Line 22: - Schools must submit quarterly nutritional compliance reports  
Line 23: - to both agencies.  
Line 24: - Schools failing to comply may face reductions in state  
Line 25: school-nutrition funding and be required to implement corrective  
Line 26: action plans.

Line 27: SECTION IV. This legislation shall take effect at when the next  
Line 28: year starts.

Line 29: SECTION V. All laws in conflict with this legislation are hereby  
Line 30: declared null and void.

## **Docket A: Virginia Bill 2040**

### *A Bill to Incrementally Increase Virginia Hourly Minimum Wage in Accordance with the CPI-U*

Be it enacted,

Line 01: SECTION II. The Commonwealth of Virginia shall increase the hourly  
Line 02: minimum wage incrementally as follows: \$13.75 per hour effective  
Line 03: January 1, 2027, and \$15.00 per hour effective January 1, 2028.  
Line 04: Starting January 1, 2029, the wage shall be adjusted in accordance  
Line 05: with the Consumer Price Index for All Urban Consumers (CPI-U).

Line 06: SECTION 2. The 'hourly minimum wage' refers to the legal baseline  
Line 07: pay for all non-exempt employees (\$12.77 as of now). CPI-U is a primary  
Line 08: monthly measure of inflation in the U.S., tracking the average price  
Line 09: change for a basket of goods and services purchased by 93% of the  
Line 10: total population.

Line 11: Section III. The following state organizations will oversee the bill jointly:  
Line 12 A. The Virginia Department of Labor and Industry will publish the  
Line 13: inflation-adjusted rate for the following year no later than October 1st of  
Line 14: each year.  
Line 15: B. The Virginia Department of Taxation will allocate funds for this wage  
Line 16: adjustment.  
Line 17: C. The Virginia Department of Accounts will oversee the distribution of  
Line 18: funds to state agencies to cover increases in payroll.  
Line 19: D. Instead of raising taxes on the normal individual or local businesses,  
Line 20: funding will come from a 0.5% fee added to the Virginia Corporate Income  
Line 21: Tax. This fee only applies to massive corporations (like Amazon, Walmart,  
Line 22: or Northrop Grumman) with >\$100 million in gross revenue.

Line 23: SECTION IV. The provisions of this bill shall take effect January 1, 2027.

Line 24: SECTION V. State that all other laws in conflict with this new policy shall  
Line 25: hereby be declared null and void.

Line 00: Be it enacted

Line 01:

Line 02: Article I: The VDOE shall implement an internship program through the Virginia

Line 03: Food for Virginia Kids (VFVK) Program in the summer of 2027-2028. The program

Line 04: will be for rising 11th graders through high school graduates.

Line 05:

Line 06: Article II: The purpose of this program is to have current and recently graduated

Line 07: students give recommendations on what foods to include in the Virginia Food for

Line 08: Virginia Kids program, which aims to increase capacity for VA counties to produce

Line 09: and provide made-from-scratch, locally-sourced meals during the school day.

Line 10:

Line 11: Article III: The students will complete an application by January 31, 2027, and the

Line 12: program will be limited to students from Title 1 schools, who may otherwise be

Line 13: unable to participate in programs that require application fees. There will be no

Line 14: application fee and the students will receive a small stipend, and will gain valuable

Line 15: experience in education policy, nutrition science, agriculture, etc. within the state of

Line 16: Virginia. Students will have the opportunity to work with state representatives in

Line 17: Richmond to discuss policy issues relevant to the internship.

Line 19: Article IV: The Virginia Department of Education (VDOE) Office of School and Community

Nutrition Programs, existing partners with the VFVK, like the United States Department of Agriculture

(USDA), will oversee and manage this program.

## **Docket A: Economic Bill 2050**

### *Ensuring And Enforcing Paid Maternity/Paternity/Spousal Leave*

Be it enacted,

Line 01: SECTION 1. Paid maternity leave, lasting a minimum of 12 weeks,  
Line 02: will be mandated across all companies. A minimum of 40% of the  
Line 03: eligible employees' salary will be paid to them for the entire duration of  
Line 04: that period. Paid paternity / spousal leave, lasting a minimum of 6  
Line 05: weeks, will also be mandated across all companies. A minimum of 60% of  
Line 06: the eligible employees' salaries will be paid to them for the entire duration  
Line 08: of that period.

Line 09: SECTION II.

Line 10: A. Employees who work part time shall be deemed eligible, on the condition  
Line 11: that they work 30 hours per week or more on a yearly basis. Leniency to this  
Line 12: section includes up to 4 weeks in which the 30 hour requirement was not  
Line 13: met per year. Employees who work part time will be paid the percentage of  
Line 14: money based on the average number of hours they worked per week,  
Line 15: calculated by the number of weeks they worked throughout that year.  
Line 16: Employees must be employed for a year or more in order to claim either  
Line 17: spouse / maternity leave. Full-time employees do not have to meet the  
Line 18: 30-hour requirement.

Line 19: B. . Eligibility for maternity leave shall be defined as the individual giving  
Line 20: birth, whose legal sex is female. Eligibility for paternity / spousal leave  
Line 21: shall be defined as an individual who is legally married to an individual  
Line 22: who qualifies and is partaking in paid maternity leave.  
Line 23: Maternity / spousal leave must start between 36 weeks and 39 weeks  
Line 24: into the pregnancy, as determined by a qualified medical professional.  
Line 25: A qualified medical professional will be a term defined as an individual  
Line 26: whose primary profession is either a doctor, physician, or obstetrician.

Line 27: C. Any company who fires, dismisses, demotes, or lays off an employee  
Line 28: within 3 months of scheduled maternity/spousal leave will be  
Line 29: investigated and fined the sum of the employee's salary that would have  
Line 30: been paid to the individual on maternity/spousal leave if found to have  
Line 31: been performing that action with the primary justification being the  
Line 32: upcoming leave.

Line 33: Section 3. The Federal Bureau of Investigation will enforce and  
Line 34: investigate as was defined in the earlier section. Fines shall be paid to the  
Line 35: affected employee. Companies will be entirely responsible for provisioning

Line 36: the funding necessary to provide this paid leave, regardless of  
Line 37: circumstances. No federal funds will be granted to companies for the  
Line 38: purpose of paying for this leave.

Line 39: Section 4. The provisions of this bill shall take effect January 19th, 2029.

Line 40: Section 5. All laws in conflict with this legislation are hereby declared null  
Line 41: and void.

### *A Bill to Assist Haiti through Financial Assistance*

Be it enacted,

Line 01: SECTION 1. The US Department of the State will authorize 750  
Line 02: million dollars to the World Food Programme in partnership  
Line 03: with the currently recognized Haitian Government for the  
Line 04: purpose of humanitarian aid. The United States will send 750  
Line 05: Million Dollars to the Gang Suppression Force for the  
Line 06: purpose of military aid.

Line 07: SECTION 2. Military aid is defined as the transfer of  
Line 08: weapons, equipment, training, services, or financial support  
Line 09: from one government to another. Humanitarian aid is defined  
Line 10: as saving lives and alleviating suffering by ensuring that  
Line 11: vulnerable and crisis-affected individuals receive assistance  
Line 12: and protection including but not limited to food assistance  
Line 13: as well as protection programs.

Line 14: SECTION 3. The 750 million dollars in humanitarian aid will  
Line 15: be managed by the World Food Programme. These funds will come  
Line 16: from the Department of State's Migration and Refugee  
Line 17: Assistance budget. The 750 million dollars in military  
Line 18: training towards the Gang Suppression Force will be managed  
Line 19: by the United Nations Support Office in Haiti. These funds  
Line 20: will come from the Department of Defense's Foreign Military  
Line 21: Financing Program.

Line 22: SECTION 4. This legislation will take effect immediately  
Line 23: upon its passing, with funds for the Gang Suppression Force  
Line 24: and the World Food Programme being available on February  
Line 25: 17th, 2026.

Line 26: SECTION 5. The Department of State will submit a report to the  
Line 27: United Nations Support Office in Haiti and the World Food  
Line 28: Programme every 90 days for information regarding the  
Line 29: distribution of funds.

Line 30: SECTION 6. All laws in conflict with this legislation are  
Line 31: hereby declared null and void.

Line 15: Article III: The Virginia Department of Labor and Industry will oversee the

Line 16: implementation of this bill

Line 17: Article IV: This bill shall take effect on January 1, 2027

Line 18: Article V: All other laws that are in conflict with this new policy shall hereby be

Line 19: declared null and void.

Line 01: ARTICLE I. No later than 180 days after the date of enactment in this legislation, the

Line 23: of Serbia's EU accession negotiations regarding Chapter 23 (Judiciary and  
Line 24: Fundamental Rights).

Line 25: ARTICLE IV. The implementation of this legislation shall be put into effect  
Line 26: immediately following enactment.

Line 27: ARTICLE V. All laws and policies in conflict with this legislation are hereby deemed  
Line 28: null and void.

### *A Bill to Improve the Treatment and Abolish the Discriminatory Practices of Ethnic Minorities in Serbia*

Be it enacted,

ARTICLE I. No later than 180 days after the date of enactment in this legislation, the Secretary of State shall prepare and submit to the Committee on Foreign Affairs of the House of Representatives and Senate a comprehensive strategy to improve the treatment of ethnic minorities in Serbia.

ARTICLE II. Discriminatory practices in Serbia is in regards to:

Passivation is preventing ethnic minorities from renewing identity documents and exercising basic rights that require identification, such as voting. Whether Serbia disregards a proportional integration of ethnic minorities in state and other public institutions.

Whether Serbia restricts or prohibits the use of minority languages in public institutions at any level or on any personal documents, including personal identification, driver's licenses, health cards, birth, marriage, or death certificates, particularly in Serbian municipalities where most of the inhabitants are minorities.

Whether Serbia uses police or any law enforcement forces to interrogate, threaten, and intimidate local ethnic minorities without due cause or process.

ARTICLE III. The Committee of Foreign Affairs (in both chambers) as well as the Secretary of State shall both administer and discharge the contents of this bill. If the Secretary of State determines that Serbia has failed to make significant progress towards the goals outlined in Article III within 180 of the initial implementation:

The United States shall suspend all non-humanitarian aid to the Republic of Serbia.

The U.S. Mission to the European Union shall formally recommend the suspension of Serbia's EU accession negotiations regarding Chapter 23 (Judiciary and Fundamental Rights).
