



Participant Waiver, Assumption of Risk, and Release of Liability Agreement

Miniversity Singapore Debate Olympiad (MSDO) 2026
In-Person Event (Singapore)

This agreement is entered into by the participant (and, if under 18 years of age, their parent or legal guardian) (collectively referred to as the “Participant”) and the organizers of the Miniversity Singapore Debate Olympiad (MSDO) 2026, including its officers, staff, volunteers, agents, and affiliated institutions (collectively referred to as the “Organizers”).

Assumption of Risk. The participant acknowledges that participation in an in-person debate tournament involves inherent risks, including but not limited to risks associated with travel to and from Singapore, movement between venues, interaction with other participants, and general participation in event activities.

The participant understands that such risks may include, but are not limited to, physical injury, illness, emotional stress, property loss, delays, or other unforeseen circumstances. The Participant voluntarily assumes all such risks, whether known or unknown, associated with participation in the tournament.

Travel & Immigration Responsibility. Participant is solely responsible for arranging and managing all travel, accommodation, visa, and entry requirements for participation in the tournament in Singapore. The Organizers shall not be responsible for any travel disruptions, visa issues, denied entry, or related costs incurred by the Participant.

Health, Safety & Insurance. The participant confirms that they are physically and mentally fit to participate in the tournament and have no conditions that would prevent safe participation.

The participant is responsible for obtaining and maintaining appropriate medical and travel insurance coverage for the duration of their participation.

In the event of illness, injury, or emergency, the Participant authorizes the Organizers to seek appropriate medical care. All associated costs shall be borne solely by the Participant.

Media & Publicity Release. The participant grants the Organizers the right to record, photograph, film, and otherwise capture their participation, including their name, voice, image, and performance.

The participant agrees that such materials may be used by the Organizers for educational, promotional, or publicity purposes, in any media format, without compensation and without limitation of time or location.

Waiver and Release of Liability. To the fullest extent permitted by law, the Participant agrees to release, waive, and discharge the Organizers from any and all claims, demands, damages, or liabilities arising out of or in connection with participation in the tournament.

This includes, but is not limited to, claims arising from personal injury, illness, property damage, loss, or other harm, whether caused by negligence or otherwise.



Indemnification. The participant agrees to indemnify and hold harmless the Organizers from any and all claims, damages, losses, or expenses (including legal fees) arising from the Participant's actions, conduct, or participation in the tournament.

Compliance with Laws and Tournament Rules. The participant agrees to comply with all applicable laws and regulations of Singapore, as well as all tournament rules, policies, and instructions issued by the Organizers.

Failure to comply may result in disqualification or removal from the tournament without refund.

Code of Conduct & Removal. The organizers reserve the right to remove any Participant from the tournament at their sole discretion for inappropriate behavior, misconduct, or actions that compromise the safety, integrity, or operation of the event.

Such removal shall not entitle the Participant to any refund.

Program Modification or Cancellation. The organizers reserve the right to modify, postpone, or cancel the tournament, in whole or in part, due to circumstances beyond their control, including but not limited to public health concerns, government regulations, venue issues, or insufficient participation.

The Organizers shall not be liable for any costs incurred by Participants as a result of such changes.

Governing Law. This agreement shall be governed by and construed in accordance with the laws of the Republic of Singapore. Any disputes arising out of this Agreement shall be subject to the exclusive jurisdiction of the courts of Singapore.

Entire Agreement. This agreement constitutes the entire agreement between the Participant and the Organizers with respect to participation in the tournament and supersedes any prior communications or understandings.

Acknowledgment and Consent. The participant confirms that they have read, understood, and agreed to all terms of this Agreement, and voluntarily accept its conditions.
