## The Period Proud Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** The Department of Education is directed to design age-appropriate teaching resources that  
3 educate students on menstruation and related topics, and to provide these resources free  
4 of charge to schools throughout the United States and its territories.

5 **SECTION 2.** Each subnational department of education is further directed to ensure that students  
6 receive direct instruction on the topic of menstruation guided by the materials referenced  
7 in Section 1. This instruction shall be required for all students from grade 5 and up,  
8 regardless of sex and gender identity, and students shall not be divided by sex or gender  
9 identity for these lessons.

10 **SECTION 3.** Any state or territory that fails to comply shall forfeit 25% of its federal education funding  
11 for each fiscal year of non-compliance.

12 **SECTION 4.** This legislation shall be overseen by the Department of Education.

13 **SECTION 5.** This legislation shall take effect at the start of the next fiscal year.

14 **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

## The Feral Hog Obliteration for Restoration of Community Equanimity (FHORCE) Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** Congress directs the Department of Defense to design a comprehensive battle plan to

3 eradicate feral hogs from the United States and its territories, with the goal of total

4 elimination of these destructive and dangerous animals from our nation within one (1) year

5 of passage.

6 **SECTION 2.** The Department of Defense may consider and utilize any and all strategies at its disposal, so

7 long as the safety and well-being of United States citizens and residents as well as our

8 troops are prioritized above all else.

9 **SECTION 3.** This legislation shall be overseen by the Department of Defense.

10 **SECTION 4.** This legislation shall take effect immediately upon passage.

11 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## A Bill to Revive the Independent Counsel Act

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED:

2 **SECTION 1.** The Independent Counsel Act, originally enacted as part of the 1978 Ethics in Government  
3 Act, is hereby reenacted, once again providing a discrete avenue for the appointment of  
4 external prosecutors to investigate high-ranking officials.

5 **SECTION 2.** Congress additionally hereby establishes the Independent Counsel Agency as an  
6 independent agency operating outside of the purview of the Department of Justice. While  
7 the President maintains the power and duty to appoint a qualified officer to lead this new  
8 agency, the Senate shall be vigilant in ensuring that whoever the President appoints has  
9 demonstrated the character and track record necessary to conduct this vital work with true  
10 neutrality.

11 **SECTION 3.** This legislation shall take effect immediately upon passage.

12 **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.
