

## **A BILL MAKE COMMUNITY COLLEGE TUITION FREE**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2. **SECTION 1.** The United States federal government will eliminate tuition costs for
3. students in good standing at two-year community colleges.
4. **SECTION 2.**
5.       A. Students in good standing refer to individuals who attend at least half-
6.       time, maintain a 2.5 GPA, and make steady progress toward completing their
7.       program.
8.       B. Community colleges that qualify must offer transfer programs or occupational
9.       training certificate programs with higher graduation rates.
10. **SECTION 3.** The Department of Education will oversee the implementation of this
11. legislation. Funds will be provided through the normal fiscal year 2016 budgeting
- process.
12. **SECTION 4.** This law shall go into effect in the fiscal year 2016.
13. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

## **A RESOLUTION TO DECREASE TIES WITH SAUDI ARABIA TO INCENTIVIZE DEMOCRATIC CHANGE**

1. **WHEREAS**, Saudi Arabia is known to restrict its citizens' freedom of speech and
- religion; and subject its citizens torture and other human rights abuses; and
2. **WHEREAS**, The United States maintains close diplomatic, economic, and military
3. ties with Saudi Arabia in spite of their inhumane actions; and
4. **WHEREAS**, our diplomatic relationship with the regime has increased Saudi global
5. hegemony and their ability to perpetuate anti-American ideals; now, therefore, be it
6. **RESOLVED**, That the Congress here assembled remove Saudi Arabia from the list of
7. International Military Education and Training assistance funding and cease American
8. arms sales entirely; and be it
9. **FURTHER RESOLVED**, That US-Saudi diplomatic relations will be suspended until
10. the Saudi government increases transparency and demonstrates significant efforts to
11. preserve human rights.

**A BILL TO CREATE AN EXCISE TAX ON SUGARED DRINKS  
TO PROMOTE HEALTHIER LIFESTYLES**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2. **SECTION 1.**
3.       A. The purchase of sugar-sweetened drinks in stores, restaurants, and other public
4.       venues shall be taxed one (1) cent per fluid ounce by the federal government.
5.       B. The revenue generated by this tax shall augment the Supplemental Nutrition
6.       Assistance Program (SNAP) and (WIC) the Special Supplemental Nutrition
7.       Program for Women, Infants and Children.
8.       C. SNAP and WIC benefits may no longer be used to purchase sugar-sweetened
9.       drinks.
10. **SECTION 2.** Sugar sweetened drinks shall be defined as beverages with added caloric
11.       sweeteners that contain at least 2 calories per fluid ounce. Milk based drinks, drinks
12.       containing over seventy (70) percent fruit juice, and alcoholic beverages shall be exempt
13.       from this tax.
14. **SECTION 3.** The provisions of this legislation shall be implemented 30 days after the
15.       passage of this legislation.
16. **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

**A BILL TO AID CENTRAL AMERICA**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
2. **SECTION 1.** The United States Agency for International Development shall allocate
3.       \$500 million between 2016-2018 to assist Central American countries.
4. **SECTION 2.** This money shall be given to the Central American Regional Security
5.       Initiative.
6. **SECTION 3.** The Central American Regional Security Initiative must utilize these
7.       funds towards confronting narcotics and arms trafficking and bolster local
8.       communities and local law enforcement agencies to maintain stability.
9. **SECTION 4.** The United States Agency for International Development shall maintain
10.       oversight over the implementation of this legislation.
11. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

### **A Bill to Ensure Fresh Water**

1. **WHEREAS**, California has been in a drought since January 2014; and
2. **WHEREAS**, Water is an essential resource for all life that is becoming scarcer; and
3. **WHEREAS**, Water desalination offers a permanent solution to water crisis of today and
4. the future; and
5. **WHEREAS**, Desalination technology already exist and is in use in several plants around
6. the world, therefore be it
7. **RESOLVED**, That the Congress here assembled fund 5 billion dollars annually for the
8. next 5 years into the construction and further research of water desalination plants
9. along the western coast line of the United States.

### **A Bill To Enhance US Cybersecurity**

1. **WHEREAS**: The increased dependency on technology to store sensitive files and the
2. storing and transferring of funds has increased over the past few decades;
3. **WHEREAS**: The US has already experienced numerous cyber attacks from international
4. governments and hacking groups;
5. **WHEREAS**: Trillions of bytes of data have been stolen already from defense contractors
6. in the US, including stolen emails, intellectual property and other strategic documents
7. **BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:**
8. **SECTION 1**: The annual funding for the United States Cyber command be increased by
9. \$250,000,000, with 20 % of funding allocated to the collaboration between the United
10. States Cyber Command and private companies to better the cyber security of the U.S.
11. **SECTION 2**: The United States Cyber Command and the Department of Homeland
12. Security should decide where to allocate these funds
13. **SECTION 3**: This law shall be taken into effect one year after its passage.
14. **SECTION 4**: All laws in conflict with this legislation shall be declared null and void.
