The Washburn Rural Forensics Squad invites you and your students to the annual WRHS Invitational Forensics Tournament to be held on Friday and Saturday, February 5-6, 2016.

On Friday, February 5, we will be offering four rounds of Lincoln-Douglas and Public Forum Debate. We will also hold two sessions of Student Congress. We will attempt to generate enough numbers to offer a Senate Chamber However, if we don't get a minimum of 16 congresspersons entered in the Senate, we will collapse it into the remaining varsity houses. I would like to have at least three house chambers with " $C$ " house being for your novices. Please keep this in mind when you are registering.

On Saturday, February 6, the tournament will consist of three preliminary rounds of competition followed by a final round to determine placing and State Championship Qualifiers. The events for competition will be: Original Oration, Informative Speaking, Domestic Extemporaneous Speaking, International Extemporaneous Speaking, Impromptu Speaking, Humorous Interpretation, Dramatic Interpretation, Duo Interpretation, Prose and Poetry Interpretation. IN ADDITION, we will offer JV Domestic Extemp, International Extemp, Humorous Interpretation, and Dramatic Interpretation. NSDA rules will apply to OO, DX, IX, HI, and DI. KSHSAA rules apply to Oral Interpretation, IMP, and INF.

Please note that JV events are open to $2^{\text {nd }}$ year sophomores, or Novices. Should entry numbers not warrant separate divisions in DX and IX, JV Extempers will be merged into one JV Extemp Division. If collapsed into one division, contestants will choose whether they draw from domestic or international topics.

The tournament will be scheduled on Thursday, February $4^{\text {th }}$, so please make your changes before this date. There will be no refunds after February $4^{\text {th }}$.

## REGISTRATION

Step1: Upon receipt of this invitation, determine if you will plan to attend and respond by email with that information. A simple "yes," or "no," is all we ask by Thursday, January 21st. Please indicate tentative plans to enter Lincoln-Douglas, Public Forum and Congressional Debate, and/or Speech/ Interpretation events [be as specific as possible as to which events you will strive to enter.

Step 2: Those schools responding "yes" will receive additional information regarding registration. In short, we will be asking for (hopefully) serious entry numbers by Wednesday, January $27^{\text {th }}$, and our plans currently include completing final registration of entries via Tabroom.com.

When registering via Tabroom.,com, you will need to enter names, and events. Final Registration will be OPEN at 5:00 PM, Thursday, January $28^{\text {th }}$; and CLOSE on Wednesday, at 5:00 pm, February 3rd. In order to allow you this much time to finalize your registration, it will be very important that you complete registration via Tabroom.com as indicated in this time frame.

## INFORMATION YOU NEED TO KNOW

1. Student participation: This year students may enter THREE events, with the following caveat(s): Do NOT enter the same student in two draw events, i.e. you may not enter the same student in both extemp divisions. But, you may enter students in Impromptu and one extemp event.
2. Extemp topics: Topics will be written from current magazines and online news sources dated from December 1, 2015 to the present. These may include; Time, Newsweek, The Economist, and The New Republic. Laptops may be used in the Extemp draw room. We do not guarantee an outlet for you to use. It is first come first serve.
3. Impromptu topics: Topics will be drawn from the following categories. Rounds 1-3, will feature "People in the News", "Political Cartoons", and "Pop Culture." In the final round, contestants will draw one of three fortune cookies. Choose one, open it, and therein you will find your topic.
4. Time limits: Judges will be informed of time limits for individual events as posted below. There may or may not be a timekeeper for all rounds. If there are no timekeepers, judges will be the final arbiters of time infractions. JV Divisions will follow the same time limits.

5. Awards: Awards will be presented to the top six finalists in each event. Sweepstakes awards will be presented to the top two schools. Points will be awarded to the " $A$ " and " $B$ " entries as follows:

> 5pts for a "1" rank
> 4pts for a "2" rank
> 3pts for a " " 3 " rank
> 2pts for a " 4 " rank
> pt for all other ranks
6. Judging: There should be plenty of judges and your students need to know that there may be panels in some rounds. However, if the weather gets weird or there is an epidemic of flu, you may need to plan on providing a couple of rounds of judging.
7. Fees: $\$ 5.00 /$ person/event. Schools will be required to pay for all entries including "extras" requested after the entry form has been submitted. This includes "extras" given on the day of the tournament.
8. Refunds: Refunds will not be given for cancellations after $5: 00 \mathrm{pm}$, Wednesday, February 4, 2015.
9. Performance Order Expectations: Any student who does not perform within the time limits of the round as posted will not be allowed to perform or will receive the last rank in the round. This is at the discretion of the tournament director.

THOSE CONTESTANTS ENTERING EXTEMP: All extempers will be expected to perform in the order as posted. They should then arrange to participate in additional event(s) either before their scheduled "draw" time, or after their scheduled speaking time.
10. The WRHS forensics coaches reserve the right to resolve any problems and/or conflicts by whatever means they deem appropriate.
11. Finals: Finals will be CUMULATIVE.

Additionally, there will be a 3-minute rapid-fire cross-examination period during finals in Extemporaneous Speaking. Speaker \#6 will cross-examine speaker \#1, speaker \#1 will crossexamine speaker \#2, etc.

Contestants will be assigned an order to perform. Be aware it may not be in the order of preliminary round placement. (If required, every effort will be made to avoid a speaker crossexamining another speaker from his/her school.)
12. Tab is closed. Ballots will be made available ASAP in a classroom very near TAB.

Since many of you anticipate some form of ongoing "Google" type document, information will be provided later as to how we will achieve this during this year's tournament.
13. LINCOLN-DOUGLAS AND PUBLIC FORUM DEBATE TOPICS:

The LD Topic that will be debated is the NSDA topic announced for January and February 2016:
Resolved: In the United States, private ownership of handguns ought to be banned.
The PFD Topic that will be debated is the NSDA topic announced for February 2016:
Resolved: The United States federal government should adopt a carbon tax.
