A Bill To Ensure Safe Production Of Genetically Modified Crops

1	BE II ENACIEL	DBY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	All companies engaging in the production of experimental Genetically Modified
3		Organisms (GMOs) will be required to engage in a human testing period of at least six
4		months to ensure it is safe for human exposure. All records of these tests must be
5		reported to the Department of Agriculture, who will analyze the records for any
6		potential harms of the GMO.
7	SECTION 2.	"Genetically Modified Organisms" (GMOs) is defined as any organism(s) the genetic
8		makeup of which has been altered in such a way that the alterations would not be found
9		in a naturally occurring form of that organism(s). Harms are defined as any damages
10		directly caused by the GMO product that impede the ability of a human being to
11		function as they normally would.
12	SECTION 3.	The Department of Agriculture will oversee the implementation and enforcement of this
13		bill.
14	SECTION 4.	This legislation must be implemented by January 1, 2018.
15	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Amend the Constitution to Require a Balanced Budget

1	RESOLVED,	By two-thirds	of the Congress here assembled, that the following article is
2		proposed as a	n amendment to the Constitution of the United States, which shall
3		be valid to all i	intents and purposes as part of the Constitution when ratified by
4		the legislature	s of three-fourths of the several states within seven years from
5		the date of its	submission by the Congress:
6			ARTICLE
7		SECTION 1:	The annual federal budget may not run a deficit.
8		SECTION 2:	The annual federal budget must have a spending limit of less
9			than 17.5 percent of the United States Gross Domestic Product
10			(GDP) for the prior fiscal year.
11		SECTION 3:	In order for Congress to raise the debt ceiling at any point, it
12			shall require a three fifths vote of both the house and senate.
13		SECTION 4:	The Congress shall have power to enforce this article by
14			appropriate legislation.

A Bill to Increase Investment in Offshore Wind Farms

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT: 1 2 **SECTION 1**. The United States government shall increase its investment in offshore wind farms 3 through the assistance of private energy companies. 4 **SECTION 2**. A private energy company shall be defined as a non-governmental business that 5 supplies energy. An offshore wind farm shall be defined as a group of wind turbines 6 generating electricity from wind located at least 30 meters deep in a body of water. 7 SECTION 3. The United States Department of Energy will oversee the implementation of this 8 legislation. 9 SECTION 4. This bill shall take effect exactly one year after the passage of this legislation. 10 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Regulate Rent Prices

1	WHEREAS,	Many owners raise the rent prices by 5% or more which causes hundreds of dollars in
2		difference between each monthly payment; and
3	WHEREAS,	Without rent control, many people have to move frequently to other housing due to
4		shortage of rent money; now, therefore, be it
5	RESOLVED,	That the Congress here assembled make the following recommendation for a solution to
6		prevent the chance of overpriced rents by capping monthly lease inflation to 3% to be
7		mandated by the U.S. Department of Housing and Urban Development.

A Bill to Create Public Housing for the Poor in Wealthy Areas

1	BE IT ENACTED	BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	As a condition of obtaining construction funds for public housing, schools, and
3		transportation, as well as grants for operation of public housing and schools
4		from the U.S. Federal Government within a city's boundaries, 5% of all public
5		housing capacity in a city must be located in designated "Residential Areas of
6		Concentrated Wealth."
7	SECTION 2.	"Residential Areas of Concentrated Wealth" are defined as residentially zoned
8		communities where the average household income is greater than \$200,000 per
9		year.
LO		A. This restriction will only apply to cities with a population greater than
l1		250,000 people.
L2	SECTION 3.	The Department of Housing and Urban Development will oversee this bill.
L3	SECTION 4.	This bill will go into effect immediately upon passage.
L4	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

The Justice in Pharmaceutical Pricing Act

1	BE II ENACIEL	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Secretary of Health and Human Services is empowered to negotiate drug prices
3		with pharmaceutical companies.
4		A. This legislation overrides subsection (6)(B) of section 222 of the Medicare
5		Prescription Drug, Improvement, and Modernization Act (MMA), which
6		prohibits the secretary of state from negotiating drug prices.
7		B. Brand name and generic drug makers must offer Medicaid and Medicare at
8		a lower price, if their drug prices rise by more than double the national
9		inflation rate.
LO		C. In the event that such a price increase is not avoidable by the company, the
l1		company may file a request with the Department of Health and Human
L2		Services to waive this requirement. Unavoidable price increases include:
L3		a. The manufacturing costs of the drug has increased significantly.
L4		b. The company cannot make a profit on the drug at the current price
L5		c. The company is close to bankruptcy, and must increase the price of
16		the drug to pay for company debts.
L7	SECTION 2.	As outlined above, the Department of Health and Human Services is charged
L8		with the implementation of this legislation.
19	SECTION 3.	This legislation will come into effect on January 8th, 2018.
20	SECTION 4.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Replace Presidential Debates with Oxford Debates

1	SECTION 1.

L4	SECTION 3.	Congress shall oversee the implementation of this bill.
L 5	SECTION 4.	This piece of legislation shall go into full effect on March 4th, 2017.
L 6	SECTION 5.	All laws in conflict are declared null and void.

A Resolution to Declare War on the Syrian Government

1	WHEREAS,	In Syria there is a president, Bashar Al-Assad, who is oppressing his
2		citizens and specifically using chemical weapons on his people; and
3	WHEREAS,	In Syria there is now a violent and disastrous civil war which has split the
4		nation; and
5	WHEREAS,	This Civil War was sparked by the use of chemical weapons by the Syrian
6		President, among other tyrannical actions; and
7	WHEREAS,	As a result of this crisis, nearly 14 million people are displaced and are
8		seeking refugee status here in the United States and other countries; and
9	WHEREAS,	This humanitarian crisis continues to get worse and the problems that
10		the world faces in Syria are all traced back to the Syrian Government;
11		now, therefore, be it
12	RESOLVED,	That the Congress here assembled recommend a declaration of war
13		against the Syrian Government.

A Bill to Ban the Use of Hydraulic Fracturing

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The Practice of Hydraulic Fracturing shall be banned in the United States.
- 3 **SECTION 2.** Hydraulic Fracturing shall be defined as the forcing open of fissures in
- 4 subterranean rocks by introducing liquid at high pressure, especially to extract
- 5 oil or gas.
- 6 **SECTION 3.** The Department of Energy and the Environmental Protection Agency shall jointly
- 7 oversee the enforcement of this legislation.
- 8 **SECTION 4.** This bill will go into effect two years after passage.
- 9 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Restore Voting Rights to Felons

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:		
2	SECTION 1.	A. The right of citizens of the United States of America to vote shall not	
3		be denied or abridged by the United States or by any State on the	
4		account of felon status.	
5		B. All felons who have been disenfranchised on the account of a felony	
6		conviction(s) will be re-enfranchised upon the passing of this bill.	
7	SECTION 2.	A . Felon is defined as someone who has committed one or more felonies.	
8		B. Felony is a crime punishable by death or imprisonment in excess of	
9		one year.	
10		C. The right to vote is defined as enfranchisement for any and all U.S.	
11		citizens who are eighteen years old or older, and who meet their state's	
12		residency requirements.	
13	SECTION 3.	All felons who are incarcerated at the time of an election, referendum, or	
14		an initiative will be provided a mail-in ballot prior to the vote.	
15	SECTION 4.	The Department of Justice will oversee the implementation of this bill.	
16	SECTION 5.	This bill will take effect on January 1st, 2018.	
17	SECTION 6.	All laws in conflict with this legislation are hereby declared null and void.

1	WHEREAS,	The United States has a firm commitment to global human rights; and

4	WHEREAS,	The Democratic Republic of Congo is fraught with human rights abuses, a
5		situation which could be improved through diplomatic means; and
6	WHEREAS,	Addressing this situation as partners will allow both parties to address
7		this human rights crisis in earnest; now, therefore, be it
8	RESOLVED,	That the Congress here assembled declare the Democratic Republic of
9		Congo as a United States' partner in peace; and, be it
10	FURTHER RES	SOLVED, That the United States consider similar action when warranted
11		with other countries.

A Bill to Remove Common Core to Help Increase Effective Learning

- 4 county, or local government entities.
- 5 **SECTION 2**. Common Core will be defined as the current system of education implemented in 2009. The government entities will be defined as state education boards, school district boards, etc.
- 8 **SECTION 3**. The Department of Education will oversee the enforcement and implementation of this bill.
- 10 **SECTION 3.** This bill will go into effect in the 2017 2018 school year.
- 11 **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Require All United States Residents to be Fully Vaccinated

1	BE IT ENACTE	ED BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	All United States residents must be fully vaccinated for all diseases that they are
3		not already vaccinated for or immune to.
4	SECTION 2.	United States residents shall be defined as individuals who have resided within
5		the United States' borders for six or more months.
6		A vaccine shall be defined as a substance used to provide immunity against one
7		or more diseases.
8	SECTION 3.	The department of Health and Human Services will oversee the implementation
9		of this bill.
10		A. A national vaccine registry will be created in order to keep track of
11		vaccination records.
12		B. Only medical professionals certified by a state or federal agency will have
13		access to the information within the registry unless subpoenaed by a federa
14		or state agency or court.
15	SECTION 4.	This bill will go into effect on July 31 st , 2019
16	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

- 6 **SECTION 3.** The U.S. Department of Education will oversee and implement this bill.
- 7 **SECTION 4.** This Bill shall be fully implemented by August 1, 2017.
- 8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Increase Students' Safety within School Zones

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Within one mile of every elementary or secondary school zone, during official
3		school hours, continuous police presence will be required in order to increase
4		students' safety and deter speeding, violent crimes, and drug abuse.
5	SECTION 2.	Definitions:
6		A. Police presence will be defined as an on-duty officer, plainly visible on foot, in
7		a vehicle, or another form of official transportation. Officers may, also, be
8		stationed within the school.
9		B. Elementary and secondary school zones will be defined as public schools,
10		which are sanctioned and funded by the state and local government.
11	SECTION 3.	The Department of Justice and the Department of Education will oversee the
12		implementation of this bill jointly and evenly divide appropriate funding for any
13		additional officers.
14	SECTION 4.	This bill shall be implemented as of August 1, 2018.
15	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

1	WHEREAS,	The Democratic People's Republic of Korea creates a continuing problem for the
2		United States and its allies; and
3	WHEREAS,	The Democratic People's Republic of Korea is violating human rights and has
4		repeatedly taken actions against the interests of the United Nations and the
5		United States; and
6	WHEREAS,	The Democratic People's Republic of Korea is building nuclear weapons,

8	WHEREAS,	All peaceable attempts to try to stop The Democratic People's Republic of Korea

- 4 **SECTION 2**. Guantanamo bay is a detention camp used by the United States military and located within Guantanamo Bay, Cuba.
- 6 **SECTION 3.** The department of Justice will oversee the implementation of this legislation
- 7 **SECTION 4.** This bill will go into effect one year after passing.
- 8 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

2	SECTION 1.	The government shall subsidize the raising and processing of all animal proteins
3		that are free from hormones, antibiotics, and any other contaminating
4		substances.
5	SECTION 2.	Subsidize is defined as an aid or promote (as a private enterprise) with public
6		money.
7	SECTION 3.	The USDA will oversee implementation of this bill and distribution of the
8		subsidies.
9		A. Implementation of a 1% tax on all sales of animal proteins from farmers using
10		hormones, antibiotics, and any other contaminating substances will pay for
11		the subsidies and enforcement of this bill.
12	SECTION 4.	This bill will be enacted by January 1, 2018
13	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Authorize the United States' Participation in the Trans-Pacific Partnership

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2	SECTION 1.	These United States of America shall adopt the terms and conditions of the
3		Trans- Pacific Partnership, as negotiated by the US Trade Representative.
4	SECTION 2.	The Trans- Pacific Partnership shall be defined as the multinational trade
5		agreement finalized in 2016 by: Australia, Canada, Japan, Malaysia, Mexico,
6		Peru, Vietnam, Chile, Brunei, Singapore, New Zealand, and these United States.
7	SECTION 3.	The US Trade Representative shall be the principle overseer of this legislation.
8		A. The executive shall order all relevant agencies to comply with the terms of
9		the agreement, in a manner consistent with the letter and spirit of the
10		agreement.
11		B. The Senate Finance Committee, House Ways and Means Committee, and
12		Joint Economic Committee shall be responsible for oversight of the
13		agreement's implementation and effects.
14	SECTION 4.	This agreement shall be ratified and take effect one year after it has been signed
15		by the President of the United States and has been adopted by the other
16		signatory nations.
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Privatize the Postal Service

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. The United States Postal Service shall no longer receive funding from the federal
