

### A Bill to Reinstate Voting Rights of All Felons

1	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:		
2	SECTION 1.	The United States shall reinstate the voting rights of all felons, both in	
3		prison and out of prison.	
4	SECTION 2.	A felon is defined as any United States citizen that has either pleaded	
5		guilty to or been convicted of a felony.	
6	SECTION 3.	The United States Department of Corrections shall oversee the	
7		implementation of this legislation, including:	
8		A. Establishment of a committee to oversee reinstatement of the voting	
9		rights of any United States citizen that has pleaded guilty to or been	
10		convicted of a felony PRIOR to the passage of this legislation, and,	
1		<b>B.</b> Establishment of a committee to oversee the voting rights of any	
.2		United States citizen that pleads guilty to or is convicted of a felony	
13		AFTER the passage of this legislation.	
L <b>4</b>	SECTION 4.	The Department of Justice will regularly audit on an annual basis the	
L <b>5</b>		Department of Corrections to ensure this policy is properly enforced.	
16	SECTION 5.	This legislation will go into effect January 1, 2019.	
L <b>7</b>	SECTION 6.	All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Oblige Insurance Companies to Supply Birth Control Pills.

- 1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. Insurance companies shall not have the right to deny women birth
- 3 control, for any reason.
- 4 **SECTION 2**. Upon the passage of this bill, insurance companies will only be obligated
- to supply birth control bills, which will not include IUD'S and other
- 6 implants
- 7 **SECTION 3.** The Department of health and human services shall be responsible for
- the changes in policy.
- 9 **SECTION 4.** This shall take effect on July 1, 2018
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

# A Bill to Limit the Amount of Army Surplus Received by Local Police

1	BE IT ENACTE	D BY THE CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Local and state law enforcement agencies may receive standard surplus
3		equipment, weapons, and ammunition from the United States military,
4		but shall not receive weapons specific to military combat unless and until
5		1) said law enforcement agency personnel have received and been
6		certified in specialized training specific to said equipment, and 2) are in a
7		geographic area proven to have a significant need for military style
8		weaponry in their jurisdiction.
9	SECTION 2.	Local and State Law Enforcement Agencies are defined as any City,
10		Municipality, Township, Metropolitan, County, Urban County
11		Government, or State law enforcement agency.
12	SECTION 3.	The Department of Public Safety shall be responsible for these changes in
13		policy.
14	SECTION 4.	This shall take effect July 1, 2018

6. WHEREAS,	Inaction by the U.S. allows China to continue its aggressive
7.	action in the South China Sea; and
8. WHEREAS,	To allow China to continue to grow its military is to open
9.	ourselves up to an inevitable strike from the Chinese, resulting
10.	in mass suffering and loss of life of the American people; now
11.	therefore, be it
12. <b>RESOLVED</b> ,	By this Congress that: the United States should preemptively
13.	initiate war with China.

#### A BILL TO LIFT THE TRADE EMBARGO ON CUBA

#### BE IT ENACTED BY THIS CONGRESS THAT:

- 1. **SECTION 1.** The United States will no longer limit American companies from
- 2. conducting business in the Republic of Cuba.
- 3. **SECTION 2.** According to the United States State Department, the trade embargo with
- 4. the Republic of Cuba mandates that "Except as may be deemed necessary by the President in
- 5. the interest of the United States, no assistance shall be furnished under this chapter to any
- 6. government of Cuba," including monetary loans and all business transactions.
- 7. **SECTION 3.** The U.S. State Department will oversee the implementation of this bill.
- 8. **SECTION 4.** This bill will take effect on January 1, 2019.
- 9. **SECTION 5.** All other laws that are in conflict with this new policy shall hereby be
- 10. declared null and void.
