#### A Bill To Reform Mental Health

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Section 1. In order to combat the growing mental health issue in the United States, \$700 Billion will be allocated to reform mental health.

**Section 1a.** \$200 billion will be allocated to the upgrading and building of modern Mental Health Facilities and for the staffing of these facilities

**Section 1b.** \$150 billion will be allocated to the evaluation of all federal and state prisoners of their mental health and the transportation of prisoners deemed mentally ill from prisons to Mental Health Facilities.

Section 1c. \$50 billion will be allocated to the oversight and review of facilities and treatment by the Department of Health

**Section 1d.** \$300 billion will be allocated to the diagnosis and additional surveillance of mental health in jobs deemed "high stress" and in schools. In-building programs will also be implemented to address the issue.

**Section 2.** Mentally III citizens over the age of 50 of the United States will be moved to nursing homes equipped to handle their needs on a case-to-case basis. Citizens under 50 will be moved general Mental Health facilities.

**Section 3.** Federal, State, and Municipal Prisoners in both public and private prisons will be reviewed and tested for mental health, and mentally ill prisoners will be brought to asylums and hospitals.

Section 3b. In order to prevent overcrowding of facilities, prisoners will be evaluated and sent to a facility based on its capacity, proximity to prisons and availability.

**Section 4.** All Medical Professionals working and/or specializing in the field of Mental Health will be required to obtain an additional license to practice in Mental Health validated by the Federal Government.

Section 4a. The licenses for these positions will be renewed every 5 years after passing.

**Section 4b.** Each license renewal will be based on assessment by the Department of Health

Section 5. This law will be enforced by the Department of Health and Human Services.

Section 5b. Funding for this bill will be come from excise and capital income taxes.

Section 6. This law will take effect within year of passage.

Section 7. All laws in conflict with this legislation are hereby declared null and void.

## A Bill To Re-equip Civilian Police

#### BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Section 1. Local Police Departments with the ability to possess military grade equipment will relinquish such equipments to Federal and State Governments

Section 2. Local Police Departments with the ability to possess military grade equipment are defined as civil forces within a community, township, or city, that have said equipment.

Section 2a. Military Grade Equipment shall be defined as weapons and armament that the U.S Military has defined as adequate for their combative requirements.(i.e Humvees, Heavy Assault Rifles etc) and Class 3 weapons (as defined by the NFA)

Section 2b. Riot gear (including that of armor, batons, tear gas and rubber bullets) will be exempt from this bill

Section 3. Local Police Departments will be expected to relinquish said equipment in favor of training in ethics and civil resourcefulness.

Section 4. This law will be enforced by the Department of Justice.

Section 5. This law will take effect within year of passage.

Section 6. All laws in conflict with this legislation are hereby declared null and void.
