### **2018 PHSSL District 9 Forensics Competition**

Dear District 9 Member,

To avoid any confusion about the judge requirements for the District tournament, let me clarify what you need to have.

#### You will need:

- 1 judge for every 1-5 speech and/or Senate participants
- 1 judge for every 1-2 LD participants
- 1 judge for every 1-2 Policy Debate Teams
- 1 judge for every 1-2 Public Forum Teams
- 1 judge for every 1-2 Parliamentary Debate Teams

It should be assumed that any portion thereof requires an additional judge.

We <u>may</u> have speech & PFD judges for hire, <u>but no LD or Policy judges will be available</u>. The cost for hiring a judge, if available, is \$70.00

The ideal situation, of course, is to cover your team with the appropriate number of judges for the categories entered. We would also appreciate any additional judges you can bring.

All judge quotas will be frozen as of 3:00pm on Wed., Feb. 14th Please do not drop any judges after this time, even if you drop competitors. After 3:00pm on Wed., Feb. 14<sup>th</sup>, any drops, adds, or changes (other than names) will incur a \$5.00 fee.

SENATE - All schools entering senate should submit their bill via e-mail by Wed. Jan. 31st at NOON.

Bills will be distributed to all participating schools by Friday Feb. 2nd at Noon.
