Konkurrenceregler

Konkurrencen er ikke købsbetinget. Køb eller betaling vil ikke forbedre dine vinderchancer. Denne konkurrence er tiltænkt deltagere i Danmark, og konkurrencens regler er underlagt dansk lov. Venligst undlad af deltage i konkurrencen, hvis du ikke er berettiget.

1. OM KONKURRENCEN: Konkurrencen ”Kaffekapløbet” er arrangeret af TerraCycle Danmark i samarbejde med TASSIMO. Målet med ”Kaffekapløbet” er at øge bevidstheden omkring genanvendelse, og at man kan redde skrald fra at ende på lossepladsen og forbrændingsanlægget. TerraCycle Danmark ønsker at sætte endnu mere fokus på vores indsamlingsprogram, samt at give folk muligheden for at donere penge til velgørende formål.

2. HVEM KAN DELTAGE: konkurrencen er kun åben for deltagere i TASSIMO-genanvendelsesprogrammet. Ansatte, ledere og bestyrelsesmedlemmer i TerraCycle Inc., og TASSIMO, samt ansatte hos selskaber, datterselskaber, filialer etc. som TerraCycle og TASSIMO kan associeres med, må ikke deltage i konkurrencen. Slægtninge og nære familiemedlemmer såsom: ægtefæller, forældre, børn, søskende) og enkeltpersoner i samme husstand, uafhængigt af hvorvidt de er i familie eller ej, må heller ikke deltage i konkurrencen. Ved at deltage i konkurrencen godkender deltageren disse officielle regler, som går efter dansk lov.

1.a Specifikke betingelser

Alle registrerede deltagere i TASSIMO-genanvendelsesprogrammet er automatisk med i ”Kaffekapløbet”, hvis de indsender en forsendelse med TASSIMO-kapsler og/eller foliepakker i konkurrenceperioden fra den 22. marts til den 27. juni 2016. Alle indsendte og modtagne forsendelser uanset vægt deltager i konkurrencen. Dog kræves der en forsendelsesvægt på minimum 2 kg, hvis forsendelsen skal krediteres med velgøringspoint.

En vinder bliver fundet blandt de lokale indsamlingspladser i Danmark, som deltager. Vinderen er den deltager der konkurrenceperioden har indsamlet og indsendt flest TASSIMO-kapsler og foliepakker. 10 vindere vil blive udvalgt blandt de offentlige indsamlingssteder og private indsamlingssteder der



deltager. Vinderne er de deltagere, der har indsamlet flest Tassimo kapsler og folie pakker i konkurrenceperioden. Dette betyder, at der samlet vil blive udvalgt 20 vindere.

3. KONKURRENCEPERIODE: ”Kaffekapløbet” starter den 22. marts 2016, kl. 12.00 og slutter 27.juni 2016 kl. 24.00. TerraCycle skal have modtaget deltagernes forsendelse(r) inden den 27.juni 2016 kl. 23.59 for at kunne deltage i konkurrencen. Den 1. juli 2016 afsløres TerraCycle-vinderne.

4. PRÆMIER: Førstepremien er 3 000 DKK for de lokale indsamlingssteder hhv. 1 000 DKK for private indsamlingssteder, andenpræmien er 1650 DKK for lokale indsamlingssteder hhv. 750 DKK til private indsamlingssteder, tredje præmie er en 1000 DKK for de lokale indsamlingssteder hhv. 500 kroner for private indsamlingssteder. 4. til 10.-pladsen vinder 200 DKK hver, som et lokalt indsamlingssted og 100 DKK som et privat indsamlingssted. Vinderne vælger selv hvilken 100% non-profit organisation pengene skal gå til. Non-profit organisationen som vinderen vælger, skal være registreret i Danmark.

De 20 vindere bliver annonceret på TerraCycles hjemmeside www.terracycle.dk.

Så vidt vinderne ikke kan godtage overnævnte præmier, kan præmien gå tabt.
