

## **Terms & Conditions**

### **The L.O.L. Surprise!™ Collection Contest - Ireland**

#### The L.O.L. Surprise!™ Recycling Programme

#### **General**

1. The L.O.L Surprise!™ Collection Contest is open to individuals in Ireland who are signed up to The L.O.L Surprise!™ Recycling Programme and are aged eighteen (18) or over, excluding Promoter's and L.O.L Surprise!™ Limited's employees, their families, their agents or anyone else connected to the contest.
2. The promotion period will start at 9:00 Monday 18th October and will end at 17:00 Friday 17th December.
3. The Promoter reserves the right to remove any participants not complying with these Terms and Conditions, the law or whose behaviour is considered by the Promoter as dishonest or fraudulent. The Promoter reserves the right to suspend or amend the contest where it becomes necessary to do so for reasons outside of the Promoter's control.

5. The Promoter will give one month's notice on this website of any intention to cancel or amend this offer.

7. Please note that the Promoter is not responsible for any packages that are lost or delayed in the post or by the Material Recovery Facility. Proof of posting is not proof of receipt. Insofar as is permitted by law the Promoter will not be responsible for, or liable to compensate the participants for, or accept any liability for any loss, damage, personal injury, or death occurring as a result of participating in this contest, except where this is caused by the Promoter's negligence.

#### **Prizes**

8. There are two types of prizes available. Firstly, the 2 weeks sign up promotion offers 200 bonus TerraCycle points per account holder who signs up to the contest, available until Sunday 31st October at 23:59 BST. Secondly, the L.O.L Surprise!™ O.M.G House of Surprises prizes (worth RRP €270 each), which will be awarded at the end of the contest to the top three (3) participants who have sent the most L.O.L. Surprise!™ products, packaging and accessories.
9. No alternative prizes in whole or in part will be given to the winners to replace the TerraCycle points and the L.O.L Surprise!™ O.M.G House of Surprises.

## How to enter

10. The contest will be open for all shipments received by the Material Recovery Facility and scanned between 9:00 Monday 18th October, and 17:00 Friday 17th December (contest period). Any shipments received and scanned after this will not be counted in the contest.
11. It is a requirement to be registered on The L.O.L. Surprise!™ Recycling Programme before participating in the contest. To join the programme, go to the programme page ([www.terracycle.com/en-IE/brigades/lolsurprise-ie](http://www.terracycle.com/en-IE/brigades/lolsurprise-ie)) and click on the 'Join programme for free' button. After this, to check you have successfully joined the programme, view '[My Recycling Programmes](#)' on your TerraCycle account and you should see 'The L.O.L. Surprise!™ Recycling Programme' listed.
12. To enter the Contest, members of the programme must fill in the [contest sign-up form](#) to ensure they agree to have their information (nickname) displayed on the leaderboard. Only once this step, alongside being a member of the programme, is complete can the participants join the contest.
13. The Promoter accepts no responsibility for entries not completed due to a technical fault or malfunction, computer hardware or software failure, satellite, network or server failure of any kind.
14. Participants must collect L.O.L. Surprise!™ products, packaging and accessories and send them to the Promoter using the free post address label which can be found by logging onto their TerraCycle account at [www.terracycle.com/en-IE/account/collection-programs](http://www.terracycle.com/en-IE/account/collection-programs).
15. Shipments of any weight will be counted in the contest. However, only shipments of accepted waste weighing a minimum of 1kg (as per The L.O.L. Surprise!™ Recycling Programme details) will qualify for regular TerraCycle points.
16. Shipments of L.O.L. Surprise!™ products, packaging and accessories received during the contest period will be accepted and counted. The types of accepted packaging are outlined in The L.O.L. Surprise!™ Recycling Programme [FAQ section](#). Non-compliant materials received won't be accepted or counted.

## How to win

17. To win the sign-up bonus points, the participants must have successfully joined The L.O.L. Surprise!™ Recycling Programme and have completed the contest sign-up form by midnight on 31st October. The bonus points will be allocated to their TerraCycle account within 10 working days of the sign-up bonus point promotion finishing.
18. Winners of the three (3) L.O.L. Surprise!™ O.M.G House of Surprises will be determined by absolute collection numbers within the Contest Period. The three participants with the greatest number of L.O.L. Surprise!™ products, packaging and accessories compliant with the accepted waste guidelines received before the end of the Contest Period will win one of three prizes.
19. Only one L.O.L. Surprise!™ O.M.G House of Surprises will be awarded per winner.
