

## Den Store Utfordringen

## Regler og vilkår

KONKURRANSEN ER IKKE KJØPSBETINGET. KJØP ELLER BETALING VIL IKKE FORBEDRE DINE VINNERSJANSER. DENNE KONKURRANSEN ER TILTENKT DELTAKERE I NORGE ALENE, OG KONKURRANSENS REGLER ER UNDERLAGT NORSK LOV.

- **1. OM KONKURRANSEN:** "Den store utfordringen" arrangeres av TerraCycle Norge, i samarbeid med TASSIMO. Målet med "Den store utfordringen" er å øke bevisstheten rundt resirkulering og oppsirkulering, og ideen om at man kan redusere mengden av søppel som blir sendt til forbrenning eller som havner på deponier. TerraCycle Norge vil fokusere mer på lokale innsamlingssted gjennom vårt innsamlingsprogram, i tillegg til å gi deltakere mulighet å donere penger til veldedige formål.
- **2. HVEM KAN DELTA:** Konkurransen er åpen for nåværende deltakere i TASSIMO-Brigaden som er private innsamlere, samt nye deltakere i TASSIMO -Brigaden. Ansatte, ledere, og styremedlemmer i TerraCycle Inc., TASSIMO, deres respektive tilknyttede selskaper eller divisjoner, morselskaper, datterselskaper, tilknyttede selskaper og deres slektninger og nære familiemedlemmer (ektefeller, foreldre, barn, søsken), samt enkeltpersoner som bor i samme husstand, uavhengig av om de er i slekt eller ikke, kan ikke delta i konkurransen. Ved å delta godtar deltakeren disse offisielle reglene, som går under norsk lov.

## 2.a Spesifikke vilkår

De 20 første som registrerer seg som et lokalt innsamlingssted i TASSIMO-Brigaden under konkurranseperioden mellom 26. januar og 5. april 2016 blir tildelt 500 kroner hver, som går til en selvvalgt ikke-statlig organisasjon. Hvis det nyregistrerte lokale innsamlingsstedet sender inn en forsendelse under konkurranseperioden, som veier 2 kilo eller mer, deltar deltakeren i en loddtrekking. Etter 5. april 2016 kommer TerraCycle til å trekke tre tilfeldige vinnere blant deltakerne som har sendte inn en forsendelse med TASSIMO-kapsler og/eller folieemballasje i konkurranseperioden . De tre tilfeldige vinnerne kommer å få hver sin goodie bag fra TASSIMO. Hvis medlemmer av Brigaden sender inn flere forsendelser under konkurranseperioden har de større sjanser til å vinne en goodie bag fra TASSIMO i loddtrekningen. En forsendelse gir et lodd i loddtrekningen, to forsendelser gir to lodd, også videre.



- **3. KONKURRANSEPERIODE:** "Den store utfordringen" starter 26. januar 2016 kl.12.00 og avsluttes 5.april 2016 kl.24.00. TerraCycle kommer til å trekke tre vinnere etter 5. april 2016, som deretter kommer til å bli kontaktet av TerraCycle.
- **4. PREMIER:** Hvis deltakere av "Den store utfordringen" er blant de 20 første som registrerer seg som et lokalt innsamlingssted i TASSIMO-Brigaden under konkurranseperioden fra 26. januar til 5. april 2016 vinner de 500 kroner hver, som går til en selvvalgt veldedighetsorganisasjon. Veldedighetsorganisasjonen som vinneren velger må være registrert i Norge. Hvis disse kravene er oppfylt deltar samtlige deltakere i konkurransen om å vinne en goodie bag fra TASSIMO til en verdi av 270 kroner. Baggen inneholder følgende produkter; Gevalia Original Mellanrost, Evergood Classic, Gevalia Latte Macchiato Less Sweet, Gevalia Cappuccino og Freia Sjokolade. Tre goodie bager blir utloddet til tre vinnere. Vinnerne velges ut ved hjelp av <a href="https://www.random.org">www.random.org</a> som genererer et tilfeldig utvalg.

Dersom vinneren ikke kan motta prisen, kan prisen gå tapt. Det er ikke mulig å gi prisen videre, og premiepengene kan kun doneres til en veldedighetsorganisasjon, som er registrert i Norge.
