Tävlingsregler och villkor

TÄVLINGEN ÄR INTE KÖPBETINGAD. KÖP ELLER BETALNING KOMMER INTE ATT FÖRBÄTTRA DINA VINSTCHANSER. TÄVLINGEN ÄR ENDAST FÖR DELTAGARE FOLKBOKFÖRDA I SVERIGE OCH REGLERNA FÖR TÄVLINGEN GÅR UNDER SVENSK LAG.

- **1. OM TÄVLINGEN:** Tävlingen "Kaffeloppet" arrangeras av TerraCycle Sverige, i samarbete med TASSIMO. Målet med "Kaffeloppet" är att öka medvetenheten kring återvinning och upcycling, och idén om att man kan minska mängden sopor som förbränns och hamnar på deponi. TerraCycle Sverige vill sätta ännu mer fokus på vårt insamlingsprogram, samt ge deltagare möjlighet att donera pengar till välgörande ändamål.
- 2. VEM KAN DELTA: Tävlingen är enbart öppen för deltagare i TASSIMO-återvinningsprogrammet. Anställda, chefer och styrelsemedlemmar hos TerraCycle Inc., TASSIMO, samt anställda hos företag, dotterbolag, filialer etc. som TerraCycle och TASSIMO kan associeras med, får inte delta i tävlingen. Inte heller får deras respektive släktingar och nära familjemedlemmar (makar, föräldrar, barn, syskon) och individer boende i samma hushåll, oavsett om de är släkt, delta i tävlingen. Genom att delta godkänner deltagaren dessa officiella regler, som går under svensk lag.

1.a Särskilda villkor

Alla registrerade deltagare i TASSIMO-återvinningsprogrammet deltar automatiskt i "Kaffeloppet" om de skickar in en försändelse med TASSIMO-kapslar och foliepaket, under tävlingsperioden från den 22:a mars till den 27:e juni 2016. Alla inskickade paket oavsett vikt deltar i tävlingen, dock krävs det att deltagarens paket väger 2 kilo eller mer för att denna skall få sina ordinarie välgörenhetspoäng. 10 vinnare kommer att utses bland de allmänna insamlingsplatser respektive privata insamlingsplatser som deltar. Vinnarna är de deltagare som har samlat in flest antal TASSIMO-kapslar och foliepaket under tävlingsperioden. Detta betyder att det totalt kommer att utses 20 vinnare.

2. TÄVLINGSPERIOD: "Kaffeloppet" startar den 22:a mars 2016 kl. 12.00 och slutar den 27:e juni 2016 kl. 24.00. TerraCycle måste ha mottagit deltagarens försändelse innan den



27:e juni 2016 kl. 23.59 för att deltagaren skall delta i tävlingen. Den 1:a juli 2016 avslöjas TerraCycle-vinnarna.

4. PRIS: Första pris är 3 000 kronor för allmänna insamlingsplatser resp. 1 000 kronor för privata insamlingsplatser, andra pris är 1 650 kronor för allmänna insamlingsplatser resp. 750 kronor för privata insamlingsplatser, tredje pris är 1 000 kronor för allmänna insamlingsplatser resp. 500 kronor för privata insamlingsplatser. Plats 4 till 10 vinner 200 kronor vardera som allmän insamlingsplats och 100 kronor som privat insamlingsplats. Prispengarna går oavkortat till en icke-vinstdrivande organisation som resp. vinnare själv väljer de vill donera prispengarna till. Den icke-vinstdrivande organisation som resp. vinnare väljer måste vara registrerad i Sverige.

De 20 vinnarna kommer att presenteras på TerraCycle's hemsida www.terracycle.se.

Om vinnaren inte kan ta emot det ovannämnda priset, kan priset gå förlorat. Det är inte möjligt att vidarebefordra priset, och prispengarna kan enbart doneras till en ickevinstdrivande organisation, som är registrerad i Sverige. Andra utgifter i samband med tävlingen, exempelvis eventuella kostnader i samband med avlämning av TASSIMO-avfall hos Posten, är vinnarens eget ansvar. Deltagare kan enbart vinna ett pris vid ett tillfälle.
