Kampanjregler och villkor

KAMPANJEN ÄR INTE KÖPBETINGAD. KÖP ELLER BETALNING KOMMER INTE ATT FÖRBÄTTRA DINA VINSTCHANSER. KAMPANJEN ÄR ENDAST FÖR DELTAGARE FOLKBOKFÖRDA I SVERIGE OCH REGLERNA FÖR KAMPANJEN GÅR UNDER SVENSK LAG.

1. OM KAMPANJEN: Kampanjen ”Bli en kapselhjälte i ditt område” arrangeras av TerraCycle Sverige, i samarbete med TASSIMO. Målet med ”Bli en kapselhjälte i ditt område” är att öka medvetenheten kring återvinning och upcycling, och idén om att man kan minska mängden sopor som förbränns och hamnar på deponi. TerraCycle Sverige vill sätta ännu mer fokus på våra allmänna insamlingsplatser inom vårt insamlingsprogram, samt ge deltagare möjlighet att donera pengar till välgörande ändamål.

2. VEM KAN DELTA: Kampanjen är öppen för nuvarande deltagare i TASSIMO-återvinningsprogrammet, som agerar som privata insamlare samt allmänheten som vill bli nya deltagare i TASSIMO-återvinningsprogrammet. Anställda, chefer och styrelsemedlemmar hos TerraCycle Inc., TASSIMO, samt anställda hos företag, dotterbolag, filialer etc. som TerraCycle och TASSIMO kan associeras med, får inte delta i kampanjen. Inte heller får deras respektive släktingar och nära familjemedlemmar (makar, föräldrar, barn, syskon) och individer boende i samma hushåll, oavsett om de är släkt, delta i kampanjen. Genom att delta godkänner deltagaren dessa officiella regler, som går under svensk lag.

2.a Särskilda villkor

Registrerade deltagare i TASSIMO-återvinningsprogrammet deltar i kampanjen om de startar upp och agerar som administratör för en allmän insamlingsplats för TASSIMO-kapslar och foliepaket på en offentlig plats, exempelvis i en mataffär eller annan butik, under 2016. Att vara administratör för insamlingsplatsen innebär att deltagaren ser till att TASSIMO-avfallet skickas in till TerraCycle när insamlingslådan är full, genom att skriva ut fraktsedlar från deltagarens TerraCycle-konto.



3. KAMPANJPERIOD: "Bli en kapselhjälte i ditt område" startar den 4:e maj 2016 kl. 12.00 pågår under resten av 2016.

4. PRIS: Deltagare som startar upp och agerar som administratör för en allmän insamlingsplats av TASSIMO-kapslar och foliepaket på en offentlig plats får 5000 bonuspoäng, vilket motsvarar 50 SEK. Bonuspoängen registreras på deltagarens TerraCycle-konto när ansökningsformuläret för kampanjen i fråga är ifyllt och godkännande från kontaktpersonen på insamlingsplatsen har bekräftats.

Om vinnaren inte kan ta emot det ovannämnda priset, kan priset gå förlorat. Det är inte möjligt att vidarebefordra priset, och prispengarna kan enbart doneras till en icke-vinstdrivande organisation, som är registrerad i Sverige. Andra utgifter i samband med tävlingen, exempelvis eventuella kostnader i samband med avlämning av TASSIMO-avfall hos Posten, är vinnarens eget ansvar. Deltagare kan vinna ett pris per tillfälle.
