## **Detailed Rules**

- 2. CONTEST PERIOD: Contest will run from June 30<sup>th</sup>, 2019 at 9:00 am Pacific Standard Time ("PST") to September 29, 2019 at 11:59 pm PST (the "Contest Period").
- 3. TO ENTER: Schools meeting the conditions set forth in paragraph number 1 above are automatically enrolled in the Contest. The goal of the Contest is for the Schools in the Eligible Regions within the Participating Program to earn the most Pledges ("Pledges"). Pledges are earned by receiving pledges (each, a "Pledge," and collectively, "Pledges"). Each Pledge to save Pledges water will earn one (1) Pledge. can cast www.terracycle.com/colgateshopritegarden2019 ("Contest Webpage"). Limit one Pledge per person (as identified by the "authorized subscriber" of the email account used for the Pledge) per day. Email addresses entered are subject to end-user validation. Email addresses will only need to be validated once during the Contest Period in order for all subsequent Pledges to be counted.
