## Free-Response

The ECHS Academy has identified key areas that must be addressed in order to sustain the ECHS program.

- Continuous Professional Development (ECHS/IHE/Industry Partners) – Teachers will participate in a 2 week PD session specifically targeting ECHS focus areas as indicated in the ECHS Blueprint. IHE partner will invite ECHS faculty to career pathway PD or curriculum PD sessions as needed to build on instructional practice and support IHE Dual Credit program requirements.
- Teacher qualifications in career pathways-Teachers will be recruited and encouraged to express an interest in their prior career pathway as they offer instruction in dual credit courses. Identify and recruit qualified teachers that are close to completing a master's degree to serve as dual credit faculty for ECHS.
- Mentor/Mentee Program specifically for ECHS faculty (ECHS/IHE/Industry Partners)
- Weekly PLC meetings specifically targeting ECHS needs and improvements
- Weekly Faculty Meetings with lead ECHS teacher presentations, updates and reflections. IHE will be updated on ECHS needs based on updates shared by the team each week. IHE and ECHS administration will meet periodically (monthly) to address areas of need.
- Recruit from within current qualified faculty. IHE and ECHS will work to identify faculty within the IHE or ECHS faculty that meet qualifications.
- Provide professional career pathway opportunities to enhance instructional practice. ECHS faculty will be encouraged to seek out additional PD or career related experts to enhance Dual Credit instruction in the classroom. (Medical field expert, accountant, engineer, etc.)
- Provide incentives and stipends to teachers that are serving as ECHS faculty instructors.
- Identify ECHS faculty as lead teachers to train faculty at the middle school level and build capacity in preparation for students enrolling in ECHS.

**Describe the processes that the dual credit provider and the ECHS campuses monitor student progress, and determine when interventions are needed. How is this ECHS going to share data and monitor student progress and ensure student success?**

The ECHS and IHE will have full collaboration in planning, implementation, and continuous improvement of programs, including the provision for faculty, staff, and administration; curriculum development; training; and student services. Both will collaborate in the following:

- The design and execution of challenging and innovative instructional programs (including Early College, Dual Credit, and College Prep Math, College Prep English and Workforce courses).
- Comply with all applicable guidelines, standards and requirements in the offering of the programs, including but not limited to regulations promulgated by the Texas Higher Education Coordinating Board (THECB), the Southern Association of Colleges and Schools (SACS), and the Texas Education Agency.
- Sharing of student data by the ECHS and IHE will be ongoing to better serve students and provide interventions that will enhance learning, support progress and student advancement. Both the IHE and ECHS will collaborate in offering, communicating, promoting and tracking student participation as they attend intervention classes to ensure student success and advancement. Student data will be analyzed, and desegregated. The ECHS along with IHE will use Response to Intervention tiers (RTI) to group and provide interventions to students.

Both IHE and ECHS will collaborate to discuss and finalize the scheduling of classes and support during monthly communication. Informing all students of dual credit enrollment and requirements. The IHE and ECHS will advise students in the areas of:

1. Career pathways
2. Financial Literacy
3. Campus Life
4. Campus Resources
5. Transferrable transfer credits
6. Grading Policies and GPA
7. Instructional Material
8. Instructional Calendar

- Academic Advisor, IHE P-16 Director, ECHS Leadership team and dual credit faculty will meet to address areas of needed improvement periodically. The ECHS will encourage students to share their data/grades with ECHS advisors to review student progress and discuss next steps to ensure student success.
- ECHS students will be recognized for their progress and accomplishments in end of the year ECHS showcase event.
- Parents of ECHS students will be invited to monthly meetings informing them of student accomplishments and next steps as they complete their ECHS program. Informing parents of progress and the status of ECHS courses will ensure that communication with home and school is seamless and frequent.
