# **Narratives**

### **Opening Statement**

Describe how the decision to apply for a planning year was made. Include the types of individuals that were involved in the decision process.

West High School is a small, 3A school located 15 miles north of Waco, in central Texas. The school is a traditional high school that has offered some dual credit classes in History and English. Don Snook, the principal at West High School, was the principal of Waxahachie Global High School, an ECHS started in 2007. Mr. Snook, who was hired in 2015, brings the knowledge and experience of operating an Early College High School and had been asked by the superintendent and school board to enhance the dual credit offerings at the school. Other dual credit classes in math, science and electives, were added the last three years. Currently, there are over 15 dual credit courses offered at West High School. In August 2017, a committee of teachers, administrators, parents and business leaders was formed to explore areas where the district can challenge students in the areas of academic, fine arts, and athletics. Mr. Snook presented information to the committee members about what an Early College High School model could offer the students and what was expected of the district based on his previous experiences. In November 2017, the committee offered its recommendations to the school board about changes it would like to see be incorporated into the district, including pursuing an Early College High School designation at the high school. In December 2017, the school board accepted the recommendations of the committee, including submitting an application for West High School to become an ECHS. In all, there were 60 committee members that voted unanimously for the school to explore the ECHS designation and all 7 school board members agreeing with the recommendations of the committee. The district is aware of the obligations that it has in order for the ECHS designation to occur and has committed resources to ensure its success.

For the 2017-2018 school year, the AP courses offered to the students were AP Literature, AP Art 2, AP Art 3, AP Composition. Supporting those classes, the high school offered advanced courses in Biology, Chemistry, and Physics in Science; English I and English II in English Language Arts; Algebra I, Geometry and Algebra II in Mathematics; and World Geography and World History in Socials Studies. Classes offered for Dual Credit included: Psychology, Sociology, Speech, and Art Appreciation for Electives; State Government and Federal Government, and US History in Social Studies, Biology for Majors in Science, and Algebra, Statistics, and Calculus I in Mathematics.

The current IHE partner with West ISD is McLennan Community College. The students are charged a tuition of \$70 per college hour per class, and are responsible for access fees and books. McLennan Community College pays the stipend to the teacher for the college classes the teacher teaches. McLennan Community College also assists our high school counselors in counseling the high school students and advises the students on the courses they should take based on the student's major. At West High School, we have a new science lab, fully stocked with equipment and chemicals, and MCC has lent the school equipment for the students to use in their DC Biology lab.
