Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirement: Curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification.

The Vanguard Mozart Secondary ECHS and South Texas College (STC)shall provide a rigorous course of study that enables participating students to receive a high school diploma and complete the Texas Higher Education Coordinating Board's (THECB) core curriculum as defined by the Texas Administrative Code (TAC 4.28 or an associate's degree or at least 60 credit hours towards a baccalaureate degree during grades 9-12. The ECHS will provide students with academic, social, and emotional support in their course of study. STC will regularly update the ECHS counselor and principal regarding STC curricular changes. Vanguard Mozart Secondary ECHS is responsible for ensuring that state course requirements for high school graduation are fulfilled. Students who declare a major leading to Career and Technical Education (CTE) certificate or Associate Degree, may also enroll in academic dual credit courses, limited to English 1301, Mathematics/Natural Science Electives , and Humanities Electives, Social and Behavioral Electives and other Associate of Applied Science, while not exceeding the limitation on dual credit courses per semester.

STC and Vanguard shall offer comprehensive college advising services for dual credit students consisting of a First-Time Dual Credit Student Module, group enrollment advising using Degree Works, face-to-face advising and an STC Advising Training Program for high School District Counselors. New dual credit students are required to complete a First-Time Dual Credit Student Module for eligibility into the Dual Credit Program. The module must completed prior to the students first attempted semester. All grade reports for all students will be produced and disseminated no later than 72 hours (3 business days) following the end of the academic term according to the published schedule. Grades are due in the office of admissions by the published date and time. Term and cumulative GPA's will be reflected on grade reports. All transcript corrections due to major change or repeated course are updated prior to the next grade reporting period. STC's registrar will provide appropriate security and confidentiality measures for the reporting and posting of grades and the maintenance of transcripts. STC will advise students as to the transferability and applicability to baccalaureate degree plans of all college credit offered and earned. Access to STC will be made available following the College's Academic Calendar, including summer. Students and instructors will receive an STC campus identification card and will have access to instructional and services available at the college. The College resources and resources will be available to support academic success. the district and College will evaluate the facilities on an ongoing basis.

Vanguard Academy will provide transportation for all Vanguard Mozart ECHS field trips and activities. In addition, ECHS students enrolled in dual enrollment classes at STC will be transported by Vanguard Academy. Vanguard Academy has purchased several vans and hired several full-time drivers to transport students to and from STC.

FERPA Allows protected student data to be exchanged between the College and School District for students that re dually enrolled without the consent of with the parents or the student under SS99.34. If the student is under 18, the parents still retain the right under FERPA to inspect and review any educational records maintained by the school district, including records that the College disclosed. The College and the School District are expected to meet FERPA requirements to maintain the privacy of student data. STC will provide data reports to Vanguard Mozart ECHS via standard reports as per identified timelines. STC will provide data reports outside of the scheduled report distribution schedule provided the data is requested at minimum three days prior to the requested delivery date. The school district and the College will develop a plan for the evaluation of the Vanguard Mozart ECHS program to be completed every year based on the collection and review of the following data: enrollment/attendance and retention rates, GPA of high school credit only courses and college courses, leaver codes/attrition rates by grad level, satisfactory progress in college courses in fulfillment of degree plan, adequate progress towards the college-readiness of student in the program, articulation of high school students in four year colleges and universities/levels of entry, and student participation in activities at college.

Describe any challenges in ensuring your academy has educators with qualification to teach dual credit. What steps did your academy take to address the need?

Vanguard Academy has implemented several changes within the last three years that will help continue to recruit staff members that have the qualifications to teach dual credit courses. Additional stipends have been created for those teachers serving in the capacity of dual enrollment professors in our district. In addition, the administrative team is very cognizant of the role they play in retaining highly qualified teachers and staff. It has been found that salary and benefits, intrinsic rewards, administrative support, and working conditions all effect teacher retention and recruitment. Vanguard Academy administrators evaluate the needs of each campus on a yearly basis and our superintendent works closely with the HR department to ensure positions are posted on our website in early Spring so that positions for the following year can be filled in a timely manner and qualified applicants can be recruited. Our superintendent has worked tirelessly to recruit and on-board new staff to increase the number of our dual enrollment professors. He identified the needs of the district and a plan was enacted so that our Vanguard STC professors can teach at multiple Vanguard campuses. These professors are provided with an annual stipend and are paid gas and mileage to travel between campuses. This allows us to maximize our staff.

How does your academy use the access, achievement, and attainment data for program improvement?

We review access data to ensure that our ECHS target populations (at-risk, Hispanic, ECD, ELLs, and SWDs) are representative of the district target populations in order to align to the Provisional Early College Access Outcomes-Based Measures and make adjustments to our recruiting activities. We review our Achievement Measures and provide targeted instructional supports (Tutoring, TSI/ACT Prep, and online resources) in the area of reading, writing, and math TSI, Algebra I and English II. The data attained from these intentional supports are used to assist in meeting the Provisional Early College Achievement Outcome-Based Targets and provide intensive supports for students who are struggling in data indicators. Our first ECHS cohort will graduate in 2023 and in order to align to the attainment data and ensure they are on track to meet the provisional early college data indicators, we ensure that the students are receiving frequent degree audits with our IHE partner and school counselor, provide preparation to succeed in their college courses, and train students and parents on IHE and high school graduation requirements.

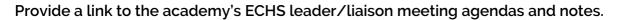
