The Early College High School shall have a current, signed Memorandum of Understanding (MOU) for each school year that defines the partnership between the school district(s) and the institution(s) of higher education (IHE).

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirement: Curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification.

La Villa Early College High School is small 9th – 12th grade rural school with enrollment of approximately 188 students. It provides students the opportunity to earn both a high school diploma and up to two years of transferable college credits (60) and/or and an associate's degree which are transferable and applicable towards a baccalaureate degree. The partnering IHE, South Texas College, gives credit for courses taken in their dual credit program for which Dual Credit Course Agreements have been approved with the primary emphasis on achieving Core Curriculum requirements for all Associate of Arts and Associate of Science degrees. The La Villa ECHS and South Texas College provides a rigorous course of study which enables a student to receive a high school diploma and to complete the Texas Higher Education Coordinating Board's (THECB) core curriculum as defined by the Texas Administrative Code (TAC 4.28). La Villa ECHS is responsible for ensuring that state course requirements for high school graduation is fulfilled. The La Villa ECHS and South Texas College has established a course equivalency crosswalk and is updated as required. The college catalog identifies the number of credits that may be earned for each college course offered at La Villa ECHS. As the school continues to progress and serve students, new topics will be addressed to include, but not limited to community partnerships, student support systems and expanding the college culture.

La Villa Early College High School (LVECHS) and South Texas College offers comprehensive college advising services for all dual credit students. The advisement consists of a First-Time Dual Credit Student Module, group advising and orientation using DegreeWorks, designated college support services staff for advising dual credit students, Fast Track Orientation, semester degree audits, and face-to-face advising. LVECHS Counselor and South Texas College provides the following services and resources: 1) Facilities such as classrooms, computer labs, auditoriums or settings which allow for South Texas College to provide one-to-one advising, online advising or group type advising; 2) Equipment such as computer technology to facilitate advising or meetings; and 3) Parent meetings for dual credit enrollment requirements. LVECHS and South Texas College provides advising opportunities to La Villa ECHS students as to the transferability and applicability to baccalaureate degree plans of all college credit offered and earned.

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirements: Transportation costs and fees including provisions for discontinuing operation while ensuring students previously enrolled will have opportunity to complete their course of study.

La Villa Early College High School (LVECHS) provides transportation (school bus) to students enrolled at South Texas College as required, deemed necessary, and appropriate under State law and School District rules and procedures. LVECHS also provides transportation for all field lessons to South Texas College. In addition, LVECHS students enrolled in dual credit classes at South Texas College will be transported to/from the high school campus to the college. South Texas College waives student tuition for dual credit "S" section college courses, including the student advisement and library usage

fees. LVECHS assumes responsibility for the timely payment of the costs incurred to recover South Texas College expenses for faculty/professors traveling to the LVECHS campus or for college course sections whereby a course is provided solely for LVECHS students. In case of discontinuation of early college program, LVECHS will provide services to students enrolled in dual college course at South Texas College through their high school graduation completion.

Disaggregated data such as number of credit hours taken and earned, GPAs, State assessment results, SAT/ACT/PSAT scores, qualifications of LVECHS staff, location (s) where courses are taught as well as six weeks exam and benchmark results will be monitored to inform instruction and advise students. The LVECHS implements an annual professional development plan based on needs assessment of student data. FERPA allows protected student data to be exchanged between South Texas College and LVECHS for students that are dually enrolled without the consent of either the parents or the student under § 99.34. South Texas College and LVECHS meets FERPA requirements to maintain the privacy of student data. South Texas College will provide data reports to the LVECHS via standard reports as per identified timelines. These reports provide required data in a timely manner to South Texas College. LVECHS provides a primary and secondary contact, at the La Villa Independent School District and at LVECHS, to receive data via a secure process from South Texas College. These contacts are responsible for distributing data securely within their assigned area and within FERPA guidelines. Any student level data received from South Texas College is not shared outside the LVECHS without prior authorization from South College.

La Villa Early College High School has one mastered degree teacher certified by South Texas College

to teach a dual credit course at the high school campus. The LVECHS challenge is the recruitment/acquisition of master degree level teachers for a small rural high school of eighteen teachers. To address this need, LVECHS will implement the GearUp Program (2020 - 2021 academic year) allowing current teachers to pursue masters level courses within their content area. The program will allocate partial funding for tuition costs incurred by teachers.
