The Early College High School shall have a current, signed Memorandum of Understanding (MOU) for each school year that defines the partnership between the school district(s) and the institution(s) of higher education (IHE).

These standards must be upheld regardless of the student composition of the class. (1) Collaborate with SECONDARY ENTITY and ECHS officials to fulfill all Texas Education Agency requirements, including to: a. Ensure that the academic plan which leads to the associate's degree is also a pathway to the bachelor's degree; b. Permit/ensure ECHS participation in all P-16 meetings; c. Ensure approved dual credit courses are available to all Early College students on a continual basis as required to meet graduation requirements for both high school and the college.

Study Hall	Study Hall is provided to all 9th graders. Each student has a 90 minute study hall built into their schedule. Upper classmen who need extra time or assistance with their course work are also given a study hall period. The Tues/Thursday Advisory is a study hall for all students. Peer tutorials are also provided at this time.
Advisory	Advisory is our system of support and first line of defense for all areas where a student may need assistance. Advisory families meet Monday through Thursday and ocasionally on Fridays and develop a strong bond with the teacher advocate, as well

Activity	as the group of students. Description
Tutorial Programs	Tutorials offered after school, as well as some specialized weekend programs, such as preparations for AP exams.
OneGoal and Guidance	Articulated and supported college readiness curriculum being taught by ECHS staff. All Challenge students must take Guidance their junior and Senior year. This course focuses on PSAT, SAT, College research, Career research, personal statement, finalizing resume, and applying to colleges and scholarships.
Emerge	Emerge empowers and prepares high -performing youth from underserved communities to attend and graduate form the nation's top colleges and universities.
GT Independent Study	All seniors research a topic relevant to their future as part of a rigorous, year long project. Each study has a mentor or accountability coach in the industry related to the project.
(Academic Students Support and Intervention System Teaming)	ASSIST Teams (Academic Students Support and Intervention System Teaming) is a program developed here at Challenge to support students that are struggling with grades, attendance or behavior. The team, comprised of a student, at least one core teacher, the advisory teacher, one administrator and the students parents,.
Dean Counseling System	Students are assigned a high school dean that they have for all 4 years. Students go through a series of meetings with their dean each year. From 9th grade they meet about their Personal Graduation Plan (PGP) and requirements of high school and the Associates Degree, learning how to schedule college classes in the 10th grade, transcript review and college course scheduling in 11th grade, and 2nd semester juniors and seniors use our high school master schedule and HCC course catalog

Social Worker/Family Therapist	LMFT through Communities in Schools provide social emotional support as well as social services.
Dean Rotation	Students at Challenge have the same dean, who works with their schedules and any other individual student.
Advisory	Advisory is our system of support and first line of defense for all areas where a student may need assistance. Advisory families meet Monday through Thursday and ocasionally on Fridays and develop a strong bond with the teacher advocate, as well as the group of students.

We review access data to continuously increase the target populations. We recruit from all campuses in HISD, but moving forward, we are beginning to use our access data to do special outreach to the target populations. We have used attainment data to identify what students leave and why, and make sure that we have supports built into the school day. Achievement data is used to inform our instructional practices and determine our programs, such as tutorials, double-block courses, etc.

Benchmark 1: Target Population	We will focus on growing our recruitment pratices that reach the target populations. We currently recruit at every middle school in Houston ISD. We will go a step further and begin recruitment early and use tactics to recruit the target
Benchmark 4: Attainment	Persistence of 9th grade students (and transfers in grades 10 or 11) through ECHS program into fall of 12th grade. We will continue to review our transfer data, what students are leaving from grade level to grade level, and how many of our students we are losing by graduation. Looking at this data and providing supports were needed will ensure we are meeting the distinguished level on the benchmark.
Benchmark 2: Partnership Agreement	It will be necessary to improve data sharing agreement with our higher-ed partner. This will enable us to intervene when students are not doing well in their classes, especially grasuating seniors. As or today, their is no process required of instructors to inform us that a graduating senior is failing a course, which delays high school graduation.
