The Early College High School shall have a current, signed Memorandum of Understanding (MOU) for each school year that defines the partnership between the school district(s) and the institution(s) of higher education (IHE).

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirement: Curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification.

As outlined in the articulation agreement between Northeast Lakeview College (NLC) and the Judson Independent School District (JISD), students engage in rigorous course curricula that ensure that all

requirements are met for both high school graduation and graduation with an Associate' of Arts degree in Liberal Arts. We have agreements with nearly all of the universities in our area that guarantees transfer of courses. Students engage in this prescribed curriculum beginning in Grade 9 and continue each year through Grade 12, resulting in 36 high school credits and 60 college credit hours. The articulation agreement provides for the annual collaborative review and modification of the program's curriculum based on student performance data to ensure curriculum alignment, effective combined professional development between the high school teachers and college professors and appropriate course agreements defining student learning outcomes. Representatives from the high school and the college participate in ongoing discussions and reviews of the course curricula and course agreements throughout the school year to evaluate the effectiveness of the program and prescribed courses.

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirements: Policies for: 1) advising students on the transferability of all college credit offered and earned, 2) ensuring the IHE transcripts college credit earned through dual credit in the same semester that credit is earned, 3) advising students as to the transferability and applicability to baccalaureate degree plans for all college credit offered and earned (college credits earned during high school should allow students to progress from an associate degree to a bachelor's degree and beyond in their chosen field), 4) students accessing the IHE facilities, services and resources

The IHE College Coordinator of High School Programs introduces students to the Alamo Colleges District Transfer Advising Guides (TAGS) to assist students in understanding how college credits earned at NLC can transfer to four-year institutions leading to a Bachelor of Arts degree. The MOU promotes collaborative review of the courses in the prescribed degree plan to mitigate the potential for excessive college hours when transferring to a four-year institution after high school graduation. Upon the conclusion of each semester, the NLC and Judson Early College Academy (JECA) administrative teams meet to conduct a grade review to ensure that students are credited with the correct college hours on the NLC transcripts and the correct credit for high school classes on the JECA transcripts. In addition, the high school counselors and teachers introduce and explain to students how they can utilize available resources to communicate with intended transfer institutions for the purpose of calculating the estimated transferability and applicability of the college hours earned. Through the MOU, NLC and JISD have agreed that all students enrolled at JECA have access to the same IHE facilities, services, and resources as traditional NLC students. These facilities, services, and resources include the use of NLC classrooms, cafeteria, bookstore, library, tutoring services, Wellness Center, Disability Support Services, and technology.

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirements: Transportation costs and fees including provisions for discontinuing operation while ensuring students previously enrolled will have opportunity to complete their course of study.

Per the articulation agreement, JISD will provide for all transportation that is required to and from NLC. No transportation charges are incurred for this specific reason since JECA is located on the NLC campus; however, JISD provides transportation across seven local municipalities to ensure that students who are selected for JECA and live anywhere within the JISD boundaries are able to attend regardless of their transportation situation, at no cost to the student. The articulation agreement also states that JISD will provide transportation for students for any ECHS field trips, pursuant to applicable JISD rules and procedures. In the event of discontinuation of the program, the MOU has the plan for dissolution for approval by the Leadership Council, which must include provisions allowing for all students enrolled in Grades 11 and 12 to complete the program through graduation. Students in Grades 9 and 10 will enroll in the high school assigned based on the student's respective residence.

NLC and JECA cooperate in sharing all data related to the efficient and effective operation of the school. As explained in the articulation agreement, both NLC and JECA share data that is not otherwise available to the other party for the purposes of course enrollment, state reporting, financial matters, Title IX matters, student conduct, and/or other official business related to the ECHS program. Such data includes, but is not limited to: Texas Success Initiative Assessment (TSIA) data, Academic Probation status, Academic Dismissal status, and semester and cumulative Grade Point Average (GPA). Both NLC and JECA have explicitly agreed to adhere to all confidentiality requirements associated with the Family Educational Rights and Privacy Act (FERPA) during the transmission of data. JECA is not required to share teacher data, such as qualifications, since all Dual Credit courses are taught at NLC by adjunct or full-time faculty.

All Dual Credit courses are taught by NLC adjunct or full-time faculty, all of whom have been vetted for required credentials and hired by the College. The teachers at JECA only teach classes for high school credit; thus, JECA has not experienced any challenges in ensuring that the students are taught by educators with qualifications to teach Dual Credit.

Activity	Description

At JECA, access, achievement, and attainment data are used to refine our campus processes. Each school year, we use our attainment data to review (and revise, if needed) our degree plan, in collaboration with NLC.
