The Early College High School shall have a current, signed Memorandum of Understanding (MOU) for each school year that defines the partnership between the school district(s) and the institution(s) of higher education (IHE).

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirement: Curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification.

The MOU between Clear Creek ISD and San Jacinto College ensures curriculum alignment through a course equivalency crosswalk of the available courses and credits that may be earned in the Dual Diploma Program. San Jacinto College ensures that all college courses taught for Dual Credit are substantially equivalent to the same courses offered to the general student population for general college credit. The same standards for curriculum, instruction, materials, method, and rigor are upheld regardless of the student composition of the class. San Jacinto College does not offer remedial or developmental courses for Dual Credit. Clear Horizons students participate in college classes that have a combination of regular college students and high school Dual Credit students. The courses offered for Dual Credit include core curriculum, electives, languages, and career classes that satisfy the specific degree plan requirements leading to the completion of 60 hours of college credit and one of five Associates Degrees in either Business, Applied Sciences, Physical Science, Mathematics, or General Studies.

Counselors maintain a degree plan and program completion plan for every student in the Early College High School. The college counselors provide one-on-one academic advising to establish a plan of enrollment for efficient use of courses. Students participate in annual meetings, as well as mandatory advising meetings at the 20-25 credit hour completion mark and at the 42-45 credit hour completion

mark. Students establish their personal goals for transferring to a university and develop a plan of action with their Academic Advisor and High School Counselor for earning a Bachelors Degree. The MOU ensures that all college courses, including Dual Credit, will be recorded on the college transcript immediately upon completion. In addition, the agreement ensures that all Dual Credit students will be provided with the same support services that are afforded to the college students at San Jacinto. This includes timely and efficient access to academic advising, learning materials, library resources, academic assistance, student engagement activities, and tutoring from the Student Success Center.

The MOU states that Clear Creek ISD shall assume all costs in providing daily round-trip transportation to and from San Jacinto College for all students who are enrolled in Dual Credit and/or the Early College High School.

Student education records shared between Clear Creek ISD and San Jacinto College shall be maintained in accordance with both the Family Educational Rights and Privacy Act and the school district/college policies and procedures for managing student education records and other confidential information. Both parties grant permission to the other to use such data only for the following purpose and for no other purpose: to track current CCISD students who earned credit in a college course offered for Dual Credit, or have graduated, or have completed a sequence of courses leading to certification, licensure, or an Associate Degree from San Jacinto College while maintaining dual enrollment at Clear Creek ISD.

Individualized plans for struggling students	Grade-level team teachers work together to identify and intervene for students that are struggling. A personalized plan is developed to help student achieve.
Tutoring	Academic tutoring promoted and provided to all students. High school teachers and National Honor Society students tutor for high school courses. San Jacinto College provided tutoring through the "Success Center."
Advisory Lessons	Students participate in advisory curriculum that supports the whole child and provides activities for college readiness.

ACCESS DATA: The results of the weighted lottery inform us as to the percentages of the incoming students who are from low-income households, are first-generation college-goers, and/or identified as At Risk/ELL/Special Needs, That information is used to develop our ECHS Bridge Camp conducted each summer to transition students to the Early College Program. ACHIEVEMENT DATA: These results are utilized to provide early interventions for students who do not demonstrate college readiness on the TSIA. The Achievement Data confirms that Clear Horizons students have consistently performed well on the STAAR End of Course Exams required by TEA. ATTAINMENT DATA: Clear Horizons has an established history of delivering strong student outcomes. We are currently on track to surpass the percentages required in the attainment measures. Six out of the seven targets must be met. Only one category concerns us at this time: Persistence. We are still seeing the effect of the COVID-19 pandemic.
