Fredericksburg Early College High School will meet with the leadership teams from the high school and middle school to review the blueprint and target populations. The FECHS will provide informational documents (website, social media, flyers, etc.) to the students and parents of incoming 9th graders. FECHS will present information to parents face-to-face during the course selection parent night for current 8th grade students, which will also include Q&A. High School counselors will present the FECHS components to parents and students during their one-on-one family meetings prior to registration. We will offer a Summer Bridge program to students who enroll in the ECHS.

The Early College High School shall have a current, signed Memorandum of Understanding (MOU) for each school year that defines the partnership between the school district(s) and the institution(s) of higher education (IHE).

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirement: Curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification.

We currently offer dual credit courses through a partnership with Angelo State University. Our course offerings include English, History, Government, Economics, Math, Speech, and Arts. We currently have several teachers vetted through ASU to teach some of these courses. We are currently collaborating with Central Texas College to provide the additional coursework to complete an Associates Degree. The CTC MOU will be added shortly.

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirements: Policies for: 1) advising students on the transferability of all college credit offered and earned, 2) ensuring the IHE transcripts college credit earned through dual credit in the same semester that credit is earned, 3) advising students as to the transferability and applicability to baccalaureate degree plans for all college credit offered and earned (college credits earned during high school should allow students to progress from an associate degree to a bachelor's degree and beyond in their chosen field), 4) students accessing the IHE facilities, services and resources

The guiding principal of the MOU is that CTC and FISD will provide an innovative educational experience which allows students the opportunity to attain a High School Diploma and up to 60 hours of college credit and upon high school graduation provide a seamless transition for students to pursue further post-secondary education and the attainment of a Bachelor's Degree. The question of credit transferability to a four-year university is one of our main goals for the joint agreement. It is imperative that we attain credit transferability to four-year universities. Our MOU provides for the transferability of college credit offered and earned. FISD and CTC staff work collaboratively to track student progress for high school and Associates graduation. FISD ensures that all courses are in the students' Individual Graduation plan by collecting and reviewing all disaggregated data to ensure the IHE transcripts college credit earned through dual credit in the same semester it is earned. The transferability to a BA degree will be the work of FISD and CTC to create a pipeline for ECHS scholars to move from the IHE graduate to a bachelor's program. All ECHS scholars have full access to all IHE facilities, services and resources.

All costs for ECHS students is incurred by Fisd. Therefore, there is no financial liability for students and their families. Tuition and fees will be provided by Fisd. Fisd will be responsible for the purchase/rental of instructional materials, including scantrons, bluebooks and textbooks for courses that are part of the agreed upon course sequence.

The MOU will state that sharing of any Personally Identifiable Student Data with CTC is subject to strict compliance with Family Education Rights and Privacy Act (FERPA). Student data will be shared only with a contractor, including CTC. The daily operational data is shared within the guiding principle of collaboration, both the ISD and IHE team track all components of specific graduation requirements. Academic review meetings will determine if a scholar is on track for college readiness or if they will be removed from the AA pathway to ensure high school graduation.

Fredericksburg is a rural area but is know as a vacation/resort town due to popularity of Texas wineries and distilleries as well as its German heritage. With this being said the cost of living in Fredericksburg is extremely high and the school district does find itself with a shortage of teachers. The Hill Country University Center, located in Fredericksburg, has partnerships with Central Texas College and Texas Tech University. These partnerships, especially Texas Tech, work with the district to provide programs

that allow undergraduates to speed up the process and course work in the TechTeach program to complete their degrees with a teaching certification. They also provide master's programs for teachers to further their education locally. We are currently working with teachers who already have a masters degree to gain eligibility from partnering colleges to be able to deliver face-to-face dual credit.
