The district does much of its recruitment by hosting meetings for students and parents explaining programs that will be offered to students. Emails are sent to students that deal with different offerings and opportunities. Social Media is used to a huge extent to inform students of what is available and how it can affect them. Flyers are sent out as well as being posted on Social Media and the school's website. Students are able to meet with the high school counselor and the principal of the school. As the district as a GEAR UP cohort, the GEAR UP facilitator is very actively recruiting the particular grade level involved in GEAR UP. All students have laptops for their use so they are able to stay up to date as to what is going on at the high school as well as being informed of different opportunities.

The district and South Texas College have an understanding of the needs of the students at the Early College High School through the MOU that is signed by both entities. The IHE is very familiar with IHE Blueprint: Curriculum requirements and courses of study that the district plans to offer. The IHE and the district have had a long standing agreement and relationship and both have continued with an MOU and both of the entities are aware of the different offerings of associate degrees, post secondary certificates that are provided by the IHE. The IHE Blueprint requirement is reviewed by both the IHE and the district many times throughout the year to ensure that students are receiving the types of classes and courses that are need in order to fulfill the courses that are being taken.

Teachers are hired by the IHE. Therefore, they are responsible for ensuring that all teachers are certified to teach the particular course. At the campus, the principal and counselor review all transcripts and they also meet individually with each student to make sure they are taking the correct courses and that all courses will transfer to the college of choice. Students have tremendous at their disposal at the IHE. They receive remediation from teachers as well as access to the library, lab and other resources that are available to any student attending the IHE.

Transportation costs are provided for all students attending dual credit as well as any industry based mentorship, internship or work sites. The campus also provides meals. Students do not have to pay any transportation costs. Also, the district pays all tuition as well as books and other fees associated with taking courses.

The district has been providing as many resources as possible to get students back to where they were before the Pandemic.
