Our campus made the decision to apply for distinction as an Early College High School through collaboration with our partnership with Lamar State College-Orange and our Campus Improvement Plan. We have students who are enrolled in dual credit courses now, but we have a large number of students who do not participate due to the cost of the courses. Our campus has a large number of students who are considered at-risk due to low socio-economic status. as well as other factors. We have met continuously since the spring of 2022 to develop a plan to ensure that all of our students were able to gain access to college hours while in high school no matter the roadblocks. We want to provide a way for our students, many of which are first year college attendees, to gain access to a higher education.

Deweyville is committed to educating the whole student, socially, emotionally as well as academically. Deweyville provides character education through a daily advisory class as well as participates in School Pulse. School Pulse helps to boost the emotional well being, individual awareness, and social competency of every student, by sending a wellness check text three times per week in which the student can respond. This allows administration to monitor the overall anxiety and wellness levels of the campus. College Readiness classes are also offered to ensure that our college bound students are well prepared and have a set plan for applying for their school of choice as well as prepared for scholarship applications and essays through academic support in college readiness classes.

Deweyville ECHS will partner with Lamar State College Orange for college preparation through CCMR nights and college visits as well as help with scholarship opportunities, FASFA assistance and meeting with program coordinators. Family involvement is a top priority and parents are welcomed partners in every aspect of their student's educational opportunities. Since our students come from low-socioeconomic backgrounds and most will be first generation college students, it is important for us to ensure that parents are well versed in the steps necessary to help their child with applying for scholarships and preparing for college visits. We offer multiple opportunities for parents to meet with administration and counselors for graduation planning, dual credit planning as well as programs and other enrichment opportunities throughout the year. We are a small school in a rural community that supports the local businesses through community service projects throughout the school year.

Deweyville is committed to attracting highly qualified teachers to fill positions that become available, which is rare. Our teaching staff has been employed with Deweyville ISD for many years. The newly acquired teachers are all certified teachers for their role and have masters degrees. We will continue to use the practices that have been set forth to ensure that we continue to employ highly qualified staff. We plan to offer both technical and academic courses. The primary options will be an associate of arts. This will have an option for the AA in Teaching (AAT), with an additional future option of natural sciences for students who plan to enter the medical field. We also plan to offer an option in business, criminal justice and construction managment.

Recruitment and Enrollment
