The Business/Industry articulation agreement addresses the blueprint requirements of clear roles and responsibilities for work site supervisors, mentors, teachers, support personnel, and other partners. From the beginning of our planning year, we made sure all of our partners were informed of their roles and responsibilities. We met with them initially to fully explain everything and see if they had any questions or concerns and also took into consideration any suggestions they may have contributed. The whole process started with our leadership team meeting and brainstorming on possible business and industry partners in our community that might be willing to work with us and our students. After the list was made, we made contact with each possible partner. A working lunch meeting was set up with the potential partners and they were provided with information on the grant and their roles and responsibilities. The excitement from them was amazing since they are all local community members and some have students enrolled in Brooks County ISD. Our district staff has stayed informed from the beginning of the grant process through various meetings, emails, and conferences. We are very fortunate to have the support we have in the community and within the district.

The Business/Industry articulation agreement addresses the blueprint requirements of support for students' activities, such as clubs, Career and Technical Student Organizations, competitions, and special invitations. Support for our students' activities comes from a variety of sources and opportunities which give our students growth in education and in personal wellbeing. In education, they are able to show their learned skills and in personal wellbeing, it gives them the confidence to compete and also socialization opportunities. Within our district CTE organizations, Future Farmers of America (FFA), Family, Career and Community Leaders of America (FCCLA), and Business Professionals

of America, both FFA and FCCLA have students that participate in our local Livestock Show competitions. FFA competes not only at the local level, but also at state area Livestock Shows such as the San Antonio Livestock Show and the Houston Livestock Show. In addition to the local Livestock Show competition, our FFA students also compete in area welding competitions at the Nueces County Livestock Show and at the Craft Training Center welding competition. Summer opportunities are also provided to our students who are interested in learning a trade, such as carpentry, through Los Mestenos Career Academy. Every summer a building trade is taught and the students that participate are paid through the program offered by the career academy. Last summer they built Aron deck chair sets, Captain Chair Sets and octagon picnic tables, Our students take pride in their competition projects and are dedicated to their learning.

The Business/Industry articulation addresses the blueprint requirements of student access to business and industry partners and work-based learning facilities, services, and resources. The students in our Ignite Technical Institute get various opportunities throughout the year to access all these areas. Currently the areas visited are located out of town. Our students are transported to several locations in the Corpus Christi, Texas area such as the Craft Training Center, specializing in training in welding, industrial technician, etc. for high school students, Turner Industries, specializing in industry specialty services, Career Expo which is held at the American Bank Center, specializing in job opportunities available through a wide range of companies, and MMR Constructors, Inc. specializing in electrical and instrumentation. Providing students access to these area facilities, provides them with the exposure they need to see what is available to them outside of our local area and community.

The Business/Industry articulation agreement addresses the blueprint requirements of the transportation fees and costs by making it clear that we, the district, Brooks County ISD will cover all necessary transportation fees and costs at the local level of funding at no cost to any of the students. Our district is well equipped with buses, crew-cab pick-up trucks, and suburban's to transport our students to and from their destinations with relation to competitions, facility visits, job shadowing, internships, etc.

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirement: Curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification.

Falfurrias High School (Ignite Technical Institute) P-TECH and Del Mar College have an active partnership and have had a partnership for many years. The Memorandum of Understanding for the partnership between Falfurrias High School P-TECH and Del Mar College addresses all statutory requirements such as Curriculum Alignment & Course of Study, Instructional Materials, Instructional Calendar, and Compliance. Curriculum Alignment & Course of Study includes the Dual-Credit Crosswalk which covers all core curriculum courses, academic courses and course listings that can be electives for AAS degree. Del Mar College focuses on student success and works with Falfurrias High School personnel to assure course selections that guarantee degree completion and/or certificate transferable to a Texas public four-year institution. Instructional Materials are covered by Falfurrias High School, with no cost to any of the students. The Del Mar College Instructors provide a list of textbooks to the P-TECH counselor, which in turn makes the purchase for all the students. The Instructional Calendar covers both the academic calendar of Del Mar College and the yearly schedule for Falfurrias High School. The partnership utilizes their agreement to accommodate student holidays, bad-weather days and state testing. The Compliance part of the partnership ensures that both partners agree to comply with all federal, state, and local laws applicable to both entities. The partnership agrees to certify their sites are ADA compliant and applicable provisions of FERPA are implemented.

The IHE Dual Enrollment Specialist will be the dedicated advisor to all enrolled students. They will be responsible for providing academic and career advising. The Dual Enrollment Specialist will be responsible for arranging advising, degree planning, and registration with every student. The IHE will provide mentors to the high school students, when available. They will also provide information to the high school and the students about Student Services events and activities sponsored by the IHE that could be beneficial to the students' education

The IHE articulation agreement addresses the following IHE Blueprint Requirements: Transportation costs and fees including provisions for discontinuing operation while ensuring students previously enrolled will have opportunity to complete their course of study is not really an issue for our district. Two things come to mind in our response to this description, we use our own teachers from within district and transportation is offered at no cost to the students. Several of our teachers at the high school meet the criteria of the IHE to teach our students. With that fabulous opportunity, our students do not have to travel to the IHE for classes. Our transportation costs and fees are only used in the summer, when we offer our incoming freshmen an opportunity to participate in Summer Bridge. The students are encouraged to sign up for six credit hours and they are transported to the nearest IHE campus about 30 miles away so they can have the college campus experience.

They will collect, share and review program and student data to assess the progress of the high school student. Our P-TECH campus will collect, share and review program and student data to assess the progress of the student enrolled at the IHE that will also include degree audits and course completion.

Ignite Technical Institute recruits and selects teachers that have field experience and demonstrate a commitment to the campus and its students. Competitive salaries for teachers in our region are offered along with a stipend from the district and our partner Del Mar College. Mentors within the school district and from Del Mar College, ensure the success of our highly qualified teachers by providing support in areas needed for providing our students the skills and emotional support to be the best at their level of success. Brooks County ISD participates in several career fair events held at area universities and at the Education Service Center, Region 1. The district has a recruitment effort that focuses on fully credentialed personnel that can meet the needs of our district, in turn, the needs of our students. Our district continuously strives to expand the career pathways offered to our students.
