When making the decision to apply for a planning year our campus took many different factors into consideration. The main driving factor for our campus was taking the time to gather enough community voice and choice in the decision making process. A team of Administrators, Directors, Community partners and parents were brought together to give feedback on the options available to us now that T-STEM was no longer an option. It was the decision of this team that a P-TECH planning year was the right move for our school because of the options P-TECH offers and how inclusive the program is for our students. In order to implement the program with fidelity the stakeholders stated that we need community support for this initiative and in order to gain their support we will have to inform and educate them about the P-TECH model and the benefits it will provide our students and community.

The P-TECH academy will provide wrap-around strategies and services involving multiple stakeholders (parents, teachers, counselors, community members, etc.) to strengthen both the academic, technical, and individual support for students for students to be successful in rigorous academic and work-based learning experiences. Describe how the campus plans to provide students with layered academic support by personalizing their learning environment. Examples include developing individualized student plans, academic support for intervention/remediation/acceleration, tutoring for identified students in need, application/financial aid/college/career counseling, advisory and/or college readiness support time built into program of study, providing bridge programs, and establishing an industry mentorship program.

When implementing wrap-around services we will categorize our offerings by academic, technical and individual support. In the academic category we will have our teachers, and New Tech Network College Access Network(NTNCAN) team to support students. Teachers will provide support by implementing interventions for students who need to make improvements, remediation when students are showing large gaps and acceleration for those who are moving through the curriculum at a faster pace. Additionally, we will provide small group tutoring for those students who have been identified by HB4545. These students have demonstrated a greater need and making sure they are receiving small group interventions will help keep them on track. Our NTNCAN is an established team on campus that works with students on all college and career planning. They hold different events and meetings to provide students and parents with information on FAFSA, college applications, and all other post-secondary needs. When it comes to technical aspects we will count on our parents and community members. These stakeholders will be an integral part of our wrap-around services by providing students with experiences related to their work-based learning experience. Parents will be able to provide perspective about their jobs and share them with students and community members will be able to come in as guest speakers and share with students different opportunities available to them in the community. Our individual support will come from teachers, counselors and district monitoring staff. In doing so interventions will be individualized and specific to their pathway.

In order to provide well executed wrap-around strategies and services for our students we will have all stakeholders play a role. Our community liaisons will work to conduct campus needs assessment so we are able to make sure they are getting the resources they needs or referrals to the proper people on campus. They will also be the bridge between the school and the chamber of commerce to build relationships with community partners. Parents will play a role in helping students skill build by leading conversations during our CCMR block to share with them a skill from the parents line of work. Our community will serve as the audience for the work we are doing. We currently have an established

relationship with Dallas College who is our IHE, they will help us crease a crosswalk that aligns to the community needs and provide students with relevant learning experiences that help them attain certifications. Additionally, our industry partner will serve as a vehicle to bring all of our programs of study together through one business partner. Our industry partner Xerox provides a curriculum for student s and professional development for teachers this will strengthen the programs of study we have by having teachers who are trained with fidelity.

In order to ensure the success of our students on the TSI we will be implementing a TSI prep course into our offerings. This course will be taught to all 8th grade students to prepare them for the TSI they take in the spring semester. In order to continuously monitor and improve upon this TSI prep course, we will use the data from each testing group to redesign the interventions the students will receive in the TSI prep 2 course that will be for 9th grade students who did not meet the college readiness standard of the TSI. Taking this approach will allow us to see how successful our initial prep courses are and how the prep 2 course reteaches those missed concepts.

Outside of our school we will bring in community members and stakeholders from our IHE and our Industry partner. Currently, we are an open enrollment school, we will continue this practice and students will be able to register and apply through our online system. The current population we serve includes limited English proficient scholars, scholarship disabilities, and students that have not passed state assessments. We will continue to seek out the scholars as well as enroll them in our program in order to help us and them receive the most rigorous education possible. When it comes to stakeholders the community liaisons, directors and superintendent will conduct outreach events in order to showcase the school. Our IHE partner will speak to students and be present at college and career fairs as well as helping us to offer courses that will attract students. When it comes to making sure students are properly enrolled, our registrar will take care of that process, and our industry partners will provide us with needed materials to help showcase outcomes of the programs for perspective, families.
