Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirement: Curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification.

El Paso Community College has entered into a Memorandum of Understanding whereby El Paso Community College will work with Clint ISD, Horizon High School, to develop a four-year course of study plan (grades 9-12) that meets the requirements of an Associates Degree in Applied Science in Cybersecurity. Students will also be given the opportunity to earn a Level 1 certification. Both entities have created a crosswalk to provide a seamless transition for students from grade level to grade level, allow students to transition from high school classes to a gradual integration to college level classes during grades 9-12 and represent high levels of rigor, acceleration, and support.

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirements: Policies for: 1) advising students on the transferability of all college credit offered and earned, 2) ensuring the IHE transcripts college credit earned through dual credit in the same semester that credit is earned, 3) advising students as to the transferability and applicability to baccalaureate degree plans for all college credit offered and earned (college credits earned during high school should allow students to progress from an associate degree to a bachelor's degree and beyond in their chosen field), 4) students accessing the IHE facilities, services and resources

El Paso Community College has entered a Memorandum of Understanding whereby El Paso Community College will ensure: College credit for each P-TECH student appears on the EPCC transcript as students complete each college course. Transcription of college credit is the responsibility of EPCC and transcription of high school credit is the responsibility of Horizon High School. Horizon High School determines how the college grades will be recorded in the high school transcript for GPA and ranking purposes. Horizon High School, through the P-TECH staff, will ensure that parents are aware and knowledgeable of this and other procedures regarding transcription of grades. The P-TECH Counselor, Academic Counselor and/or College and Career Facilitator shall assist students to take courses that will count toward the degree at the 4-year university of choice or a degree or certificate from EPCC. All P-TECH students will have access to student services and facilities as regular college students, including but not limited to the use of academic and support facilities including the library, computer labs, study rooms, student services, bookstore, and food services. It is recognized that PTECH students may gain access on the EPCC campus to the unrestricted internet access afforded other EPCC students.

Describe how the IHE articulation agreement addresses the following IHE Blueprint Requirements: Transportation costs and fees including provisions for discontinuing operation while ensuring students previously enrolled will have opportunity to complete their course of study.

El Paso Community College has entered into a Memorandum of Understanding whereby Clint Independent School District will provide for such student transportation as may be required to and from the EPCC as required under State law, and for any P-TECH field trips, each pursuant to applicable Clint ISD rules and procedures. Either EPCC or Clint ISD shall have the right to terminate this agreement with or without cause at any time during the initial term upon written notice to the other party. In the event of termination during the initial term of this agreement, the effective date of termination shall be as of June 30, following the notice. It is the intent of the Parties that no termination shall be made during the middle of the school year which will disrupt the academic progress for the students of P-TECH, unless the Parties mutually agree. In the event of termination, the P-TECH will continue operation through the 11th grade cohort's scheduled graduation from the P-TECH. Services to enrolled 9th and 10th grade students may be continued though graduation of those cohorts by agreement.

El Paso Community College has entered into a Memorandum of Understanding whereby stating, in accordance with Applicable Law, Horizon High School will maintain student records pertaining to PTECH and provide EPCC copies of the grades, progress, and other informational data on student assessment, promotion, retention, award of diplomas, and other student data necessary and advisable for EPCC to perform its obligations under this MOU. Each party will be responsible for maintaining student records and records pertaining to the Program in conformity with the Texas Record Retention laws and FERPA. Each Party designates the other Party as its agent with a legitimate educational interest in students' education records for purposes of FERPA, and each Party agrees in its capacity as such agent to comply with FERPA. Each party shall institute policies and procedures reasonably designed to ensure that its employees and agents comply with these and all other federal and state laws, including, without limitation, FERPA, governing the rights of P-TECH students with respect to educational records, and shall protect student education records against accidental or deliberate redisclosure to unauthorized persons. College credit for each P-TECH student appears on the EPCC transcript as students complete each college course. Transcription of college credit is the responsibility of EPCC and transcription of high school credit is the responsibility of Horizon High School.
