Describe how the Business/Industry articulation agreement addresses the following Business/Industry Blueprint Requirements: Clear roles and responsibilities for work site supervisors, mentors, teachers, support personnel, and other partners.

The Business/Industry articulation agreement addresses the Business/Industry Blueprint Requirement of clear roles and responsibilities for worksite supervisors, mentors, teachers, support personnel, and other partners as follows: Birdville ISD has developed a memorandum of understanding (MOU) that clearly defines the roles and responsibilities of our partnership with Medical City North Hills Hospital. Birdville ISD P-Tech instructors, together with hospital administrators, have developed a detailed plan for grade-level appropriate work-based learning experiences, including facility visits, quest speakers, presentations, career information, job shadowing, internships, externships, and apprenticeships. The MOU provides a detailed description of clear roles and responsibilities for worksite supervisors, mentors, teachers, support personnel, and other partners. The hospital agrees to provide career mentoring for BISD P-Tech students. The MOU includes an agreement that the hospital will give students enrolled in the BISD P-Tech program priority in interviewing for jobs for which the student is qualified upon the student's completion of the program. BISD has a clearly defined Course path for students enrolled in the P-Tech program with Medical City North Hills Hospital. which is clearly articulated in the MOU. The P-Tech course path and program will be continuously monitored to ensure student success while progressing through the P-TEch program. The MOU clearly defines the industry certifications that the students will earn, as well as the standards and curriculum which will be followed while earning the specified certifications

The Business/Industry articulation agreement addresses the Business/Industry Blueprint Requirement of supporting students' activities, such as clubs, Career and Technical Student Organizations, competitions, and special invitations as follows: The Business/Industry articulation agreement supports student activities in the aligned CTSO, which is Health Occupation Student Association (HOSA), by supporting student competitors and mentoring students and teams. The MOU between Birdville ISD and the hospital ensures that BISD P-Tech students will gain practical, authentic, real-world experience while working in the hospital, resulting in student success in CTSO competitions and activities at the regional, state, and international levels.

Describe how the Business/Industry articulation agreement addresses the following Business/Industry Blueprint Requirements: Student access to business and industry partners and work-based learning facilities, services, and resources.

The Business/Industry articulation agreement addresses the Business/Industry Blueprint Requirement of providing student access to business and industry partners and work-based learning facilities, services, and resources as follows: The Business/Industry articulation agreement with Medical City North Hills allows students to observe and assist in various aspects of patient care. Observations will take place throughout the hospital, giving students opportunities to experience multiple departments within Medical City North Hills Hospital as the P-Tech students participate in clinical rotations. Students assisting with patient care will assist nurses and patient care technicians with routine rounds. In addition, the MOU between BISD and the hospital provides that the hospital will allow P-Tech students to shadow multiple healthcare professionals, including phlebotomists, EKG technicians, patient care technicians, lab technicians, pharmacists, emergency medical technicians, nutritionists, nurses, labor and delivery, physical therapist, surgery, speech pathologists and various other positions.

# Describe how the Business/Industry articulation agreement addresses the following Business/Industry Blueprint Requirements: Transportation fees and costs.

The Business/Industry articulation agreement addresses the Business/Industry Blueprint Requirement of transportation fees and costs as follows: Birdville ISD agrees to pay the transportation cost and fees associated with transporting P-Tech students to and from Medical City North Hills Hospital. It is expressly agreed that all such transportation, as well as the acts and omissions of all transportation personnel, are the sole and exclusive responsibility of BISD. To the extent permitted by Texas law, and without waving any defenses, including governmental immunity, BISD agrees to be solely responsible for its own acts of negligence and solely responsible for all liability and obligation, incurred by or asserted against the hospital, its trustees, officers, employees, and assistants that arise out of or in connection with the transportation of the BISD P-Tech students. The MOU provides that BISD shall maintain the insurance coverage agreed to by BISD and the hospital.

The IHE articulation agreement addresses the IHE Blueprint Requirement of curriculum alignment and courses of study, which enables a student to combine high school courses and college-level courses to earn either an associate degree, postsecondary certificate provided by an IHE, or industry certification as follows: Birdville ISD and Tarrant County College are expanding dual credit offerings to include courses required for students to earn an Associate of Arts with Central Sterile Processing Level 1 Certificate. The articulation agreement between BISD and TCC contains a provision specifically regarding the prescribed alignment of curriculum as associated with courses necessary to obtain an Associate of Arts with Central Sterile Processing Level 1 Certificate. The articulation agreement contains a provision which outlines student learning materials including college-approved textbooks and supplemental instructional materials as outlined in the BISD P-Tech course crosswalk. All textbooks and supplemental materials shall be provided by BISD. The articulation agreement between BISD and TCC includes the BISD course crosswalk which outlines the P-Tech course of study which will enable a student to combine high school courses and college-level courses to earn either an associate degree postsecondary certificate provided by an IHE, or industry certification. The MOU specifically states that BISD will be responsible to provide P-Tech students with the necessary practice test and curriculum to ensure P-Tesch student success on industry certification exams. The MOU states that BISD is responsible for providing BISD P-Tech students with the appropriate industry certification tests.

between BISD and TCC includes a policy to ensure BISD P-Tech students receive advising from admissions counselors and their instructors regarding the transferability of all college credit offered in the BISD P-Tech crosswalk, as well as advising on the transferability of all college credit earned. The articulation agreement ensures that TCC will transcript college credit which is earned through P-Tech dual credit courses in the same semester that credit is earned. The articulation agreement mandates that P-Tech students will receive advising as to the transferability and applicability to baccalaureate degree plans for all college credits offered and earned. The articulation agreement between BISD and TCC provides that BISD P-Tech students shall have full access to all of the facilities, services, and resources offered by TCC, including college advising, tutoring, computer labs, library and various other student services.

All BISD P-Tech teachers hold a Bachelor of Science in Nursing and have industry experience working as registered nurses in the required fields. To address the need to hire and retain dual-credit accredited teachers, BISD actively seeks out teachers who meet the TCC requirements. For example, recently BISD recruited and hired a teacher who serves as an adjunct professor at TCC and will be teaching in the P-Tech academy and is already familiar with TCC's policies and procedures.
