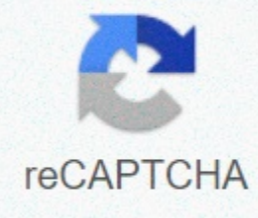

## Britain visa application form

This tool will help you find out about UK visa application fees based on country, visa category and type of visa. This tool contains only information on fees for UK visa applications made outside the UK. Get started now All content is available under the V2.0 Open Government Licence, except when otherwise declared you may need a visa to come to the UK to study, work, visit or join the family. There are different visas depending on: where you come from why you want to come to the UK how long you want to stay for your personal circumstances and skills Before applying, you should check if you need a visa and what type you need. Depending on your nationality, you may not need a visa to visit or transit through the UK. Your application must be approved before traveling. You do not need to apply for a visa if you are an Irish citizen. If you want to visit the UK Solicit for a standard visitor visa to visit the UK for up to 6 months. For example: for a holiday or to see family and friends for a business trip or meeting to take a short course of study You must apply for a wedding visitor visa if you want to visit the UK to get married or register a civil partnership. If you have a visitor visa, you cannot accept a job in the UK. If you are travelling around the UK You may need a visa if you are travelling around the UK on your way to another country, for example if you have a stopover between flights. Apply for a visa to travel around the UK. If you want to study in the UK Its length, type and place of study affect which visa you apply for. A Standard Visitor visa allows you to take a short course of study that does not last more than 6 months. A short-term study visa allows you to come to the UK to study an English course older than 6 months and up to 11 months. A student visa is usually for a longer course. You must be sponsored by a college or university graduate and have a confirmed place. You may be able to do some work on this visa. The child student visa is for children from 4 to 17 years who want to study in an independent school. If you are 16 years or older, you can do some work on this visa. If you want to work or invest in the UK you can work in the UK in the short or long term with a work visa. There are many types of work visa. The visa you need depends: your skills and qualifications if you have a job offer and sponsorship if you want to bring your family with you what you will do - for example, sports, charity or religious work You can also money in the UK on an investor visa. You can set up a business with a Start-up visa or an Innovative visa. If you want to join the family in the UK If you are a spouse, partner or family member of someone who has British citizenship or settlement in the UK, you can apply for a family visa to join them. They may need to show that they can support you financially. You may be able to apply indefinitely indefinitely (ILR) after a certain period of time living in the UK. If your family member is from the EU, Switzerland, Norway, Iceland or Liechtenstein You can apply for a free family permission if you have a close family member who was living in the UK by 31 December 2020. Family leave allows you to live, work and study in the UK for up to 6 months. You can apply to the EU Settlement Scheme after the end of your family leave. Family reunion visas for refugees If you were separated from your partner or child when you were forced to leave your country, you can request that they join you in the UK. To apply, you must have received asylum or 5 years of humanitarian protection, and not have British citizenship. Other ways to get permission to live in UK Community citizens You can apply for an ancestry visa to work in the UK if you have a British grandfather and meet other eligibility criteria. You may have the right to housing to live in the UK. If you are a Community citizen and cannot prove your right to be in the UK, read about the Windrush scheme. If you have had indefinite leave to stay (ILR) and have left the UK for more than 2 years, you will need to apply for a returning resident visa to return. Other visas There may be another visa that is right for you based on your circumstances. Make sure you need a visa and what other visas you are eligible for. If you need a visa, you must apply online before travelling to the UK. Check which documents you need to apply. Proving your identity and providing supporting documents As part of your online application, you need to make an appointment at a visa application center. You will have your fingerprints and photographs (known as 'biometric information') taken in your query. Give time to attend your appointment, as the visa application center may be in another country. The visa application center can keep your passport and documents while processing your application. Apply for a standard visitor visa Once you have started your application, you can save your form and pree complete it later. Sign up now Continue your request You can log back into your app if you saved it. Check your email and follow the link to return to your app. Sign up with family members Each family member must make their own request and pay the fee. You can apply on behalf of your partner and child if they cannot apply to themselves. They must attend their own consultation at a visa application center. How long it takes to get a decision Once you have signed up online, proved your identity and provided your documents, you will usually have a decision on your visa within 3 weeks. Find out how to get your visa decision faster - it depends on what country you're in. Is. receive an email or letter containing the decision in your application. This will explain what you need to do next. If you need to change or cancel your request If you need to change something in your request after submitting, please contact UK Visas and Immigration (UKVI). You can ask to cancel your registration. You will only have your fee refunded if the request has not yet been processed. To enter the UK, your passport must be valid for the entire duration of your planned stay. If you are planning to travel on after leaving the UK, please note that many other countries require at least six months of validity remaining on your passport to enter. If you are destined for continental Europe, please refer to our Schengen FactSheet for more details. Visas for specific categories of visitors must be obtained prior to travel. Visit the UK Visas and Immigration (UKVI) website to determine if you need a visa to enter the UK. We cannot intervene on your behalf when you apply for a visa in the UK, nor can we defend your admission to the UK if you are denied entry. Students and prospective students should visit the UKVI website to determine if they need a visa. Unpaid and paid workers, trainees, volunteers, charity workers and temporary workers can find information about obtaining a visa on the UKVI website. Visitors travelling to the UK to get married, even if they do not plan to reside there, must obtain a visa in advance. See the UKVI website for visa information. Surcharges apply to certain categories of visas, usually those involving work, study or residence for more than six months.
