Official Rules for DRaysBay 2022 Bay Republic Sweepstakes

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

- 1. Eligibility: The DRaysBay 2022 Bay Republic Sweepstakes (the "Sweepstakes") is open to residents of the United States (excluding territories and possessions), who are at least eighteen (18) years of age (or in the case of legal residents of jurisdictions where the age of majority is greater than 18 years of age, such age of majority under the laws of the jurisdiction in which they reside at the time of entry) who have internet access and a valid Twitter account. - 6. **How to Enter**: To enter, you must (1) follow @DRaysBay on twitter and @TheBayRepublic on twitter, and (2) during the Entry Period post a tweet about what you are most excited about this season (completion of all actions constitute an "Entry") with the hashtag "#TBRxDRBsweepstakes". You will receive one (1) Entry per submission. There is a limit of one (1) Entry per person during the Entry Period. Entries in excess of the allowable limit will not be acknowledged. Entries must fulfill all Sweepstakes requirements, as specified, to be eligible to win a prize. Entries that are not complete or do not adhere to the rules or specifications may be disqualified at the sole discretion of Administrator. You may not enter more times than indicated by using multiple e-mail addresses, Twitter accounts, identities or devices in an attempt to circumvent the rules. Administrator reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. The "authorized account holder" is the natural person who is the registered account holder for the applicable Twitter account. ADMINISTRATOR HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, AND THE MAXIMUM AGGREGATE LIABILITY UNDER THIS SECTION 13(D), IF ANY, WHETHER IN CONTRACT OR TORT, OF ADMINISTRATOR SHALL NOT EXCEED THE COST OF ENTERING AND PARTICIPATING IN THE SWEEPSTAKES.

14. Publicity/Rights Granted by You:
