1. INFORMATION ABOUT US

2. YOUR STATUS

By registering for the program, you warrant that: (a) You are legally capable of entering into binding contracts; or (b) You are at least 18 years old; or (c) A parent or guardian has entered into the Contract on behalf of the participant.

3. REGISTRATION PROCESS

Prices are liable to change at any time, but changes will not affect registrations for which you have already paid. It is always possible that, despite best efforts, some of the Programs listed on the Registration Form may be incorrectly priced. Where a Program's correct price is less than the stated price on the Registration Form you will be charged the lower amount. If a Program's correct price is higher than the price stated on the Registration Form, We reserve the right to reject your registration and notify you of such rejection. We are under no obligation to provide the Program to you at the incorrect (lower) price, if the pricing error is obvious and unmistakable and could have reasonably been recognised by you as a mis-pricing. Payment for Program can be made by cash, cheque, credit/debit card or online bank transfer. No memberships will be frozen for any reason including long breaks undertaken by the student or during examinations. You are responsible for arranging and paying for suitable insurance to cover any injury or illness to the participant as, unfortunately, we cannot provide a refund under these circumstances. For avoidance of doubt, no refund is permitted for participant's failure to attend the Program. In all cases refund of money received from you will be made by cheque within a period of 14 days.

7. LIABILITY

We are not responsible for indirect losses which happen as a side effect of the main loss or damage even if such losses result from a deliberate breach of these terms that would entitle you to terminate the Contract. You shall be liable for the cost of any damage to our property or facilities caused by you or by persons under your control. Maximus Prime Sports LLP will not be liable for any injuries sustained during the Program or the training.

8. NOTICES

Other than notices of cancellation sent under clause 6, all notices given by you to us must be given to Maximus Prime Sports LLP at maximusprimesports@gmail.com. Notices will be deemed received and properly served 48 hours after an e-mail is sent, or 3 days after the date of posting of any letter.

9. TRANSFER OF RIGHTS AND OBLIGATIONS You may not transfer, assign, charge or otherwise dispose of a Contract, or any of your rights or obligations arising under it, without the prior written consent from us. Our Operator may transfer, assign, charge, sub-contract or otherwise dispose of a Contract, or any of our rights or obligations arising under it, at any time during the term of the Contract.

10. EVENTS OUTSIDE OUR CONTROL

We will not be liable or responsible for any failure to perform, or delay in performance of, any obligations under a Contract that is caused by events outside our reasonable control ("Force Majeure Event"). A Force Majeure Event includes any act, event, non-happening, omission or accident beyond our reasonable control and includes in particular (without limitation) the following: (a) Strikes, lock-outs or other industrial action. (c) Fire, explosion, storm, flood, earthquake, subsidence, rain/unavailability of the ground or facilities, epidemic or other natural disaster. (d) Impossibility of the use of railways, shipping, aircraft, motor transport or other means of public or private transport. (e) Impossibility of the use of public or private telecommunications networks. (f) The acts, decrees, legislation, regulations or restrictions of any government. Performance under any Contract is deemed to be suspended for the period that the Force Majeure Event continues. We will make reasonable endeavours to bring the Force Majeure Event to a close or to find a solution by which the obligations under the Contract may be performed despite the Force Majeure Event.
